1. Summary

- 1.1 A licensing authority may refuse to grant taxi licences in order to limit the number of taxis licensed in their area. In order to do so, the licensing authority must be satisfied that there is no significant demand for the services of taxis in their area which is unmet.
- The Council currently has a policy of limiting the number of taxis within Renfrewshire and keeps the demand for taxis under review. The purpose of this report is to advise the Board of recent observations by the Civic Government Enforcement Officer in relation to demand for taxis.

2. Recommendations

2.1 It is recommended that the Board note the contents of this report and continue to keep the numbers limit under review.

3. Background

3.1 Section 10(3) of the Civic Government (Scotland) Act 1982 ("the Act") empowers the Council as licensing authority to refuse to grant new taxi licences in order to limit the number of taxis in its area providing it is satisfied that there is no significant demand for taxi services in its area which is unmet.

- On 26 May 2016, the Board considered a detailed report, carried out externally by Vector Transport Consultancy, in relation to demand for taxi services in Renfrewshire. The Board agreed at that time to increase the limit in relation to the number of taxis in Renfrewshire to 235. The Board also agreed that the number of taxis in Renfrewshire be reviewed in January 2017.
- As at January 2017, officers were aware that the new licences allocated by the Board were not yet operating. A number of the new licences had not been granted until late 2016 and were issued subject to a condition that a suitable taxi be acquired by 1 December 2016. The Council also received intimation in or around December 2016 that drivers were being sought to drive newly licensed vehicles, who would require to apply for taxi driver's licences. Officers thereafter arranged to carry out observations in April 2017.
- In April and August 2017, the Civic Government Enforcement Officer carried out rank observations at Gilmour Street, Paisley, and at Glasgow Airport to assess whether there was any significant unmet demand. Surveys were undertaken at Gilmour Street and Glasgow Airport for thirty minute periods as detailed in the Civic Government Enforcement Officer's report, which is attached as Appendix 1 to this report. This report sets out the Civic Government Enforcement Officer's detailed findings.
- Officers will continue to carry out observations at the taxi ranks and bring further reports to the Board.

Report on Unmet Demand for Taxis

Summary

Surveys have been undertaken at the main taxi stances, in Paisley and at Glasgow Airport. These surveys were conducted on Thursday 27 April, Friday 28 April, Thursday 17 August and Friday 18 August 2017. This report documents the findings of the surveys.

<u>Methodology</u>

Surveys were undertaken at Gilmour Street and Glasgow Airport for 30 minute periods, commencing at the times shown below. The surveys included observations during the day and into the early hours.

Findings

Gilmour Street, Paisley

Surveys were conducted at the taxi rank on

Thursday 27 April at 1400

Thursday 17 August at 1430 hours

Friday 28 April at 2230 hours and 0030 hours

Friday 18 August at 2230 hours and 0030 hours

The surveys lasted 30 minutes.

During the survey conducted on Thursday 27 April, 9 taxis picked up passengers and no waiting times were incurred.

During the survey carried out on Thursday 17 August, 7 taxis picked up passengers and no waiting times were incurred.

During the survey conducted on Friday 28 April at 2230 hours, **19** taxis picked up passengers and no waiting times were incurred. Later on that date, during the survey conducted at 0030 hours, **27** taxis picked up passengers with no waiting times, **6** people then waited 10 minutes before being picked up, then a further **10** taxis picked up passengers with no waiting time incurred. At 0100 hours, the conclusion of the observations, **3** passengers were waiting at the rank.

During the survey conducted on Friday 18 August at 2230 hours, **17** taxis picked up passengers and no waiting times were incurred. Later on that date, during the survey conducted at 0030 hours, **10** taxis picked up passengers with no waiting time and no passengers remained at the rank at 0100, the conclusion of the observations.

Glasgow Airport

Surveys were conducted at the taxi rank on

Thursday 27 April at 1100

Thursday 17 August at 1500

Friday 28 April at 2130 and 2330

Friday 18 August at 2130 and 2330

The surveys lasted 30 minutes.

During the survey conducted on Thursday 27 April at 1100 hours, **44** taxis picked up passengers and no waiting times were incurred.

During the survey conducted on Thursday 17 August at 1500 hours, **32** taxis picked up passengers and no waiting times were incurred.

During the surveys conducted on Friday 28 April at 2130 hours, **32** taxis picked up passengers and, at 2330 hours, **26** taxis picked up passengers. No waiting times were incurred during either period.

During the survey conducted on Friday 18 August at 2130 hours, **21** taxis picked up passengers, with approximate 5 minutes waiting time. During the survey conducted at 2330 hours, **17** taxis picked up passengers with approximate 5 minutes waiting time.

Johnstone, Renfrew

It should be noted that the taxi ranks at Houston Square, Johnstone, and High Street Renfrew are not utilized by the trade.

Other Information

One complaint has been received regarding taxi availability. This was received in April 2017, prior to the observations carried out on 27th and 28th April. The person referred to having to wait 45 minutes at the Gilmour Street taxi rank on a Saturday night after 1am.

There have been no further complaints.

Conclusion

The surveys indicate that general demand is currently being met at the taxi ranks in Renfrewshire.

1.	Summary	
1.1	There are currently five sites in Renfrewshire which constitute Control of Major Hazards (COMAH) establishments.	
1.2	The Health and Safety Executive has requested that Renfrewshire Council reviews its procedures under the Civic Government (Scotland) Act 1982 to prevent the licensing of certain activities that could pose a risk to members of the public should they take place within the vicinity of a COMAH establishment.	
1.3	The recommendations in this report would ensure that appropriate Council departments are consulted when an application is received for a market operators' licence or public entertainment licence which is seeking to take place within the vicinity of a COMAH establishment. This will allow the appropriate departments to liaise with relevant external bodies and make relevant objections or representations to the Regulatory Functions Board. The policy also creates a rebuttable presumption that certain applications will not be granted.	
2.	Recommendations	
2.1	To approve the Regulatory Function Board COMAH Policy as set out in Appendix 1; and	
2.2	To instruct officers to make any necessary changes to the civid government licensing application procedures and practices as required to implement the COMAH Policy.	

3. Background

- The Control of Major Accident Hazards Regulations 2015 (the "Regulations") provides that a site will constitute a COMAH establishment if it houses dangerous substances above the thresholds provided in the Regulations. In the Renfrewshire area there are currently five COMAH establishments. These are listed in Appendix 2.
- The Regulations are enforced by the COMAH Competent Authority which is a partnership of different bodies including the Health & Safety Executive, the Office for Nuclear Regulation and the Scottish Environment Protection Agency. When applicable, Planning Authorities are notified by the Health & Safety Executive or the Office for Nuclear Regulation of consultation distances for COMAH establishments. This allows the relevant bodies of the COMAH Competent Authority to be consulted when planning applications are received within the consultation distances. Within the consultation distance there is an inner zone, a middle zone and an outer zone. An example of a consultation distance is provided in Appendix 3. There is no equivalent consultation requirement under the Civic Government (Scotland) Act 1982.
- 3.3 Certain activities licensed under the civic government licensing regime may attract a large crowd public gathering in one location. Should this location be within the vicinity of a COMAH establishment then there is a potential risk to the members of the public should a major accident occur. Accordingly, the Health and Safety Executive has requested that Renfrewshire Council reviews its procedures to ensure that appropriate bodies are consulted when an application has been made for Market Operators' Licences and Public Entertainment Licences which take place in the vicinity of a COMAH establishment. These types of licences have the potential for attracting large crowds and would not necessarily require planning permission.
- 3.4 The proposed COMAH Policy provides that the Council's Health and Safety Section and Civil Contingency Service must be consulted should an application for Market Operators Licences and Public Entertainment Licences for activities on premises within the middle zone of consultation distances for a COMAH Establishment. The officers of these departments have the experience and knowledge to liaise with appropriate external bodies and then make representations or objections as would be necessary. The policy also creates a rebuttable presumption which means that any application within an inner zone of a consultation distance will be refused which means that the applications will go to Board for consideration. This rebuttable presumption will not apply to applications where the COMAH Competent Authority have already been consulted on the intended activities as part of the consultation for planning permission and the COMAH Competent Authority did not make any adverse comments. This will prevent duplication of the planning process.

- 3.5 The draft policy has been approved by the Health and Safety Executive. Comments were also sought from Diageo, the operator of the upper tier COMAH site in Renfrewshire, but no comments have been received.
- 3.6 Should the Board approve the proposed policy then officers will review the application practices and procedures in order to best implement the aims of the policy.

Civic Government (Scotland) Act 1982

Regulatory Functions Board COMAH Policy

Where an application is made to Renfrewshire Council for the grant or renewal of a Public Entertainment Licence or a Market Operators' Licence which is wholly or mainly to be carried on in a premises within a Middle Zone or Inner Zone of a COMAH Establishment then a copy of the application will be sent to Renfrewshire Council Civil Contingency Services and to Renfrewshire Council Health and Safety Section.

Where an application is made to Renfrewshire Council for the grant or renewal of a Public Entertainment Licence or a Market Operators' Licence which is wholly or mainly to be carried on in a premises within an Inner Zone of a COMAH Establishment it will be presumed that the application will be refused for reason of protecting public safety in accordance with Paragraph 3(d) of Schedule 1 of the Civic Government (Scotland) Act 1982. This rebuttable presumption will not apply to applications which include evidence that the relevant Competent Authority were consulted in relation to the activities intended to be licensed as part of the consultation process under Regulation 25 of the Town and Country Planning (Development Management Procedure) (Scotland) Regulations 2013 and the relevant Competent Authority made no adverse comments.

In this policy:

"COMAH Establishment" has the same meaning given to "establishment" in the Control of Major Accident Hazards Regulations 2015;

"Competent Authority" has the same meaning given to "competent authority" in the Control of Major Accident Hazards Regulations 2015;

"Inner Zone" means the inner zone of the consultation distance around a COMAH Establishment notified to Renfrewshire Council by the relevant Competent Authority for the purposes of development management;

"Market Operators' Licence" has the same meaning given to "market operators' licence" in the Civic Government (Scotland) Act 1982.

"Middle Zone" means the middle zone of the consultation distance around a COMAH Establishment notified to Renfrewshire Council by the relevant Competent Authority for the purposes of development management.

"Public Entertainment Licence" has the same meaning given to "public entertainment licence" in the Civic Government (Scotland) Act 1982.




