# 1 MINUTE OF PREVIOUS MEETING

There was submitted the Minute of the previous meeting of the Renfrewshire Licensing Forum held on 23 May 2023.

S McLean requested that her apologies be added to the previous minute. The Clerk confirmed that the Minute would be amended accordingly.

# 2 MATTERS ARISING

Under reference to Item 1 of the Minute of the previous meeting of the Renfrewshire Licensing Forum held on 23 May 2023 relative to the Election of Convener. The Convener advised that he would return to his substantive post on 1 October 2023 and as of that date he would no longer Chair the Renfrewshire Licensing Forum.

Under reference to Item 8 of the Minute of the previous meeting of the Renfrewshire Licensing Forum held on 23 May 2023 relative to the Local Licensing Forums Training/Awareness Session which had been provided by the Scottish Government in June 2023. The Convener advised that this matter would be carried forward to be discussed at a future meeting of the Renfrewshire Licensing Forum at which Mr Mills would provide feedback on his attendance at the Glasgow training event to Forum members.

#### DECIDED:

(a) That it be noted that the Convener would cease to be Chair of the Renfrewshire Licensing Forum effective from 1 October 2023; and

(b) That the Scottish Government Licensing Training Event item be carried forward to be discussed at a future meeting of the Renfrewshire Licensing Forum at which Mr Mills would provide feedback on his attendance at the Glasgow training event to Forum Members.

# **POLICE SCOTLAND UPDATE**

Police Scotland provided a verbal update on local licensing issues which had arisen during the 12 months prior to the meeting date.

Police Scotland attended 297 incidents, 177 within Paisley and 120 across Renfrewshire. 480 proactive visits to Licensed Premises were carried out. There were no premises categorised as "problematic" and 2 Town Centre premises were being "monitored". Police Scotland had agreed to Renfrewshire Licensing Board's Policy on Festive Hours 2023/24 and advised they would object to any premises being granted further hours in excess of these additional festive hours. Police Scotland advised that most of the incidents within Paisley were related to a particular premises and that these had reduced following a change of management. Various safety campaigns were ongoing, these included the "Talk To" campaign, a UV Bottle campaign, CCTV and a Halloween/Christmas campaign.

Best Bar None would be revisited next year due to limited interest by licence holders in 2023.

Sergeant Robertson was heard in answer to questions from members on the update.

# 4 LICENSING STANDARDS OFFICER UPDATE

The Fair Trading Officer provided a verbal update relative to licensing activity undertaken since the previous meeting of the Renfrewshire Licensing Forum on 23 May 2023. Two premises had been visited in connection with breaches of their operating plans and three premises were no longer licensed. Numbers of premises licences held were 89 trading as on sales, 188 both on and off sales and 153 off sales, which totalled 430 licensed premises throughout Renfrewshire.

Premises Licence Annual Fees were due to be paid by 1 October 2023, reminders were sent in August and there would be a structured approach to recovering any late fees.

The Fair Trading Officer outlined the implementation of a duty rota for the five Licensing Standards/Trading Standards Officers who would respond to enforcement emails and was then heard in answer to questions from members on the update.

# 5 ALCOHOL RELATED DEATHS IN RENFREWSHIRE 2022

# Parliament must come together to renew and reinvigorate MUP

The Scottish Government has launched a consultation on their proposal to maintain and uprate minimum unit pricing (MUP) to 65p per unit, following the publication of their report on its effectiveness.

Since it was introduced in Scotland in 2018, MUP has been linked to an estimated 3% reduction in alcohol consumption, a 4.1% reduction in hospital admissions and a 13.4% reduction in deaths directly caused by alcohol.

increase in the MUP level is now needed to maintain its positive impacts, and failing to link MUP to rising inflation will cost more lives in the future.

Laura Mahon, deputy chief executive of Alcohol Focus Scotland, welcomed the Scottish Government's announcement: "With the recent rise in alcohol deaths, and the impact of the pandemic we need the Scottish Parliament to come together once again to renew and reinvigorate MUP. It is not enough for MUP to be retained. Unless there is support to increase the price, the positive effects we've seen will be reversed, condemning hundreds more people to unnecessary suffering and loss."

# Majority support 'nanny state' policies to improve Britain's health outcomes

According to think tank the Social Market Foundation (SMF), Brits largely support public health interventions like bans on advertising, regulating food prices, and affordability limits on gambling.

SMF has published two of three papers exploring tobacco, alcohol, obesity, and gambling policy. The **first paper** compares different types of policy approach, and concludes that more 'interventionist' and apparently politically challenging measures, such as strict regulations on availability and taxes, tend to be more effective.

The **second paper** explores the political opportunities and constraints around action on tobacco, alcohol, obesity, and gambling. SMF analysed several public opinions polls

advertising bans – like limiting the exposure of children to alcohol advertising on social media. People are also more likely to agree that alcohol and tobacco duties are 'too low' or 'just about right' compared to other taxes, making them among the most popular of any taxes.

SMF suggests that resistance from industry, party colleagues, and the media are bigger obstacles to implementing public health interventions than voter opposition.

# Debate: Investing in Alcohol Services to Reduce Alcohol Related Harm in Scotland

On Thursday 7 September, Carol Mochan MSP led a debate in the Scottish Parliament highlighting the public health emergency we are facing in Scotland. She pointed to the high number of alcohol-related deaths in 2022, which saw 1276 people in Scotland losing their lives because of alcohol.

MSPs from parties across the political spectrum agreed that we need more action and less talk to address our problem with alcohol, particularly for those living in our poorest

MSP Gillian Mackay focused on the need to combat alcohol marketing and supported calls for the implementation of an alcohol harm prevention levy to raise funds from the sale of alcohol to fund prevention and treatment.

In response to the points raised, Elena Whitham MSP, Minister for Drugs and Alcohol Policy, outlined the government's initiatives to address mental health and substance use, workforce plans, and collaboration with local leaders and recovery groups to reduce alcohol harm. Ms Whitham also announced that the findings and next steps of the consultation on restricting alcohol marketing will be published in the coming months.

Researchers from the Sheffield Alcohol Research Group (SARG), University of Sheffield, have published a new report commissioned by the Scottish Government on the impact of alcohol pricing policies, alcohol consumption and harm in Scotland.

An adaptation of the Sheffield Tobacco and Alcohol Policy Model

Overall, the report highlights that a

combination of high inflation and the long-term effects of the pandemic on drinking behaviour are likely to lead to increases in alcohol-related harm. To combat this, the researchers believe an increase in the MUP level is now needed to maintain the positive impacts, and that failing to link MUP to rising inflation will cost more lives in the future.



With the pandemic leading to a 14 year high in alcohol deaths, it is not enough for MUP to be retained. Unless there is support to increase the price, the positive effects we've seen will be reversed, condemning hundreds more people to unnecessary suffering and loss. This is particularly true for people living in our most deprived communities, where we've seen the greatest benefits from MUP.

We welcome the Scottish Government's proposal to increase the price to 65p. Alcohol Focus Scotland and SHAAP, along with more than 30 other organisations including medical bodies and children's charities, have **called** for the minimum unit price to be increased to at least 65p to make good on inflation and save lives into the future. This is in addition to increased and sustained investment in alcohol services and recovery support and the implementation of other preventative policies to tackle this public health emergency.

It is vital that we demonstrate a wide and diverse range of support for increasing the price of MUP.

# AFS Response: Healthcare in Remote and Rural Areas

The Scottish Government has committed to establishing a National Centre for Remote and Rural Health and Social Care to improve primary and community services. Due to the level and trajectory of alcohol-related problems in these areas and the specific treatment and support needs people face, we recommend the National Centre include alcohol use in its focus. We call for an updated economic assessment of alcohol harms, as well as an assessment to gather information on the needs of local communities and the range of services currently available, to help identify issues and support the planning and funding of services.

Additionally, we propose further action from the Scottish Government, in the form of an emergency response to alcohol harm. We recommend increasing the price of alcohol, reducing its availability, and controlling how it is marketed. This must be accompanied by accessible and evidence-based treatment and recovery support for those already experiencing alcohol problems. An Alcohol Harm Prevention Levy on off-trade alcohol retailers could be used to fund local action on preventing alcohol harms and improving treatment and recovery support.

# AFS Response: A Human Rights Bill for Scotland

The Scottish Government recently consulted on a proposed Human Rights Bill, which will incorporate a range of rights into Scots law for the first time. Specifically, the Bill will bring four United Nations international human rights treaties into the law in Scotland, within the limits of the Scottish Parliament's devolved powers.

In our response to the consultation, we highlighted that human rights can help us to address the harmful impacts of alcohol. For this to happen, it is vital that the Human Rights Bill ensures that the Scottish Government, local authorities, and the public sector adopt a human rights framework for alcohol-related laws, policies, and support services. People will also need to be supported to understand that they have human rights in Scotland which must be respected, protected, and fulfilled.

# New Consultation: Updating labelling guidance for no and low-alcohol alternatives

The UK Government is seeking views on potential changes to the government's guidance on no and low-alcohol (NoLo) descriptors, specifically on:

- recommended conditions of using the descriptors 'alcohol free', 'de-alcoholised', 'non-alcoholic' and 'low alcohol' and whether such conditions should be set in regulations
- displaying numerical information of the alcoholic strength on the label
- displaying the UK chief medical officers' low risk drinking guidelines on the label and alternative ways of communicating this information to consumers
- displaying an age restriction on NoLo products and alternative options for preventing children and young people from accessing and consuming NoLo drinks

# Effects of media campaign videos on stigma and attitudes towards treatment seeking for alcohol use disorder: a randomized controlled study

New research published in BMC Public Health suggests that video materials focusing on recovery and reducing the perception of differentness have an immediate effect on decreasing public stigma associated with Alcohol Use Disorder (AUD).

AUD is one of the most stigmatised disorders in the western world. As stigma is a major barrier to seeking treatment for AUD, researchers in Denmark have explored the effects of video campaigns on public and self-stigma. Participants completed surveys before and after watching one of three different videos. The researchers conclude that videos can have an immediate effect on the level of public stigma, while other types of interventions are needed to increase motivation to change people's own alcohol use and reduce selfstigma.

# The Women's Soccer World Cup Final 2023: gender equity and alcohol promotion

Researchers say broadcasters providing news coverage of sporting events should avoid "problematic" shots of fans drinking alcohol, in a commentary article published in the Journal of the Royal Society of Medicine.

It is hoped that high-profile sports events like the Women's Soccer World Cup will help inspire young women's participation in sports, which often drops dramatically after they leave school. Sports participation in general is linked to positive outcomes like increased fitness, stress reduction, and a heightened sense of belonging. The researchers discuss how alcohol marketing, and particularly TV images of female fans drinking, normalise and glamourise alcohol consumption. They call for an alcohol-oriented equivalent of the Framework Convention on Tobacco Control (FCTC).

# Rainbows in June: Selling alcohol to LGBTQ+ people

Sexual and gender minorities (SGMs) are targeted by a complex web of alcohol marketing across various channels, according to new research published in Drugs: Education, Prevention and Policy. Writing for the Institute of Alcohol Studies, Dr David Whiteley, Glasgow Caledonian University, summarises the scoping review.

LGBTQ+ people are more likely to drink alcohol, drink it to excess, and are more at risk of becoming dependent on alcohol than heterosexual and/or cisgender people. Although the alcohol industry tries to position itself as an ally through appropriation of SGM iconography and event sponsorship, they market extensively to LGBTQ+ people, through traditional advertising, digital marketing, and venue-based marketing. The authors call for further work to describe and quantify the impact of these strategies on alcohol use within SGM communities.


# IAS: An exploration of lay discussions about alcohol and pregnancy on Mumsnet
