Declarations of Interest

There were no declarations of interest intimated prior to the commencement of the meeting.

1 Minute

There was submitted the Minute of the meeting of the Executive Sub-committee held on 9 December 2022.

DECIDED: That the Minute be approved.

2 Revenue Budget Monitoring

There was submitted a joint revenue budget monitoring report by the Treasurer and the Chief Executive of Scotland Excel for the period 1 April to 9 December 2022.

The report intimated that at the end of period 9, Scotland Excel was projecting a breakeven position by year-end in its core activities and a planned £0.043 million increase in committed project reserves by year-end. It was noted that both core and projects budgets would be monitored closely over the remainder of the financial year, targeted at a break-even position for core operations by March 2023. Further detail was provided in section 3 of the report.

The appendices to the report provided an analysis of the actual spend to date along with projected net expenditure for 2022/23 and included a summary of movement in both the revenue reserve and the project reserves.

DECIDED: That the report be noted.

Councillor McLeod joined the meeting during consideration of the following item of business.

3(a) Contract for Approval: Supply and Delivery of Janitorial Products

There was submitted a report by the Chief Executive of Scotland Excel relative to the award of a renewal framework for the supply and delivery of janitorial products for a period of four years from 1 March 2023 until 28 February 2027. It was noted that subject to approval and completion of a standstill period, it was anticipated that the framework agreement would commence on 1 March 2023.

The framework would provide members with a mechanism to procure a range of janitorial products including, but not limited to, paper-towels, cleaning chemicals, hand-soap, refuse sacks and cleaning equipment.

The report summarised the outcome of the procurement process for this national framework which had been divided into four lots, as detailed in table 1 of the report.

The report advised that the framework had been advertised with a potential value of £14 million per annum and Appendix 1 to the report detailed the participation and spend summary of those participating in the framework.

Tender responses had been received from 20 suppliers and Appendix 2 to the report provided a summary of the offers received. Based on the criteria and scoring methodology set out in the tender document, a full evaluation of the compliant offers had been carried out and Appendix 3 to the report confirmed the scoring achieved by each bidder.

Based on the evaluation undertaken, and in line with the advertised criteria and weightings set out in the report, it was recommended that a multi-supplier framework arrangement be awarded to 12 suppliers across the four lots, as outlined in Appendix 3 to the report.

Appendix 4 to the report detailed the approach taken by suppliers in relation to fair work practices and their position on the payment of the Real Living Wage.

The report intimated that, in accordance with Scotland Excel's established contract and supplier management programme, the framework had been classified as class D in terms of risk and spend, as detailed in Appendix 5 to the report.

<u>DECIDED</u>: That the award of the multi-supplier framework for supply and delivery of janitorial products, as detailed in Appendix 3 to the report, be approved.

3(b) Contract for Approval: Building Construction Consultancy

Under reference to item 3(a) of the Minute of the meeting of this Sub-committee held on 21 October 2022, there was submitted a report by the Chief Executive of Scotland Excel relative to the award of the first national framework for building construction consultancy services for a period of two years from the commencement date with an option to extend for up to a further 24-month period. It was noted that subject to approval and completion of a standstill period, the framework was intended to commence around 1 December 2022.

The report intimated that following approval of this national framework at the meeting of the Executive Sub-committee held on 21 October 2022, updates were required to reflect the evaluation outcome and specific changes were required to lots 5 and 11 to correct formatting errors and these were identified in appendices 2 and 3, highlighted yellow. The Executive Sub-committee was further advised that Appendix 2 required to be amended to correct a typographical error relative to the entry for Savills (UK) Ltd such that reference to lot 14, all regions, should be removed from the "lots/regions awarded" information, as this part of their bid was not successful. The report had been brought back to the Sub-committee for fresh approval and superseded previous reports. Subject to this approval, the standstill period would be commenced with the framework commencing in February 2023.

As previously advised, the framework would provide members with a mechanism to procure services relating to buildings and their surrounding grounds. The report advised that, following delivery of Scotland Excel's New Build Residential Construction (NBRC) framework in 2019, there had been growing demand to deliver a consultancy framework to support the NBRC framework. Scotland Excel operated frameworks for other building construction works such as demolition, asbestos removal and energy efficiency contractors which this framework would also support.

The report summarised the outcome of the procurement process for this national framework which had been divided into 14 lots, as detailed in table 1 of the report. All lots were sub-divided by eight regions, as detailed in table 2 of the report, and it was noted that suppliers could opt to offer for one, some or all regions.

The report advised that the framework had been advertised with an estimated spend of £100 million over the maximum four-year period and Appendix 1 to the report detailed the participation and spend summary of those participating in the framework.

Tender responses had been received from 137 suppliers and Appendix 2 to the report provided a summary of the offers received. Suppliers who were deemed non-compliant were advised that their offer or part of their offer would not be considered further. One supplier was non-compliant for all lots as they rejected the advertised terms and conditions, and one supplier was partly non-compliant as they failed to submit a required element of their commercial submission.

Based on the criteria and scoring methodology set out in the tender document, a full evaluation of the compliant offers had been carried out and Appendix 3 to the report confirmed the scoring achieved by each bidder.

Based on the evaluation undertaken, and in line with the advertised criteria and weightings set out in the report, it was recommended that a multi-supplier framework arrangement be awarded to 93 suppliers across the 14 lots, as outlined in Appendix 3 to the report.

Appendix 4 to the report detailed the approach taken by suppliers in relation to fair work practices and their position on the payment of the Real Living Wage.

The report intimated that, in accordance with Scotland Excel's established contract and supplier management programme, the framework had been classified as class B in terms of risk and spend, as detailed in Appendix 5 to the report.

DECIDED:

- (a) That the updated report for the award of the multi-supplier framework for building construction consultancy services, including amendments as detailed in appendices 2 and 3 to the report, be approved; and
- (b) That Appendix 2, once amended, be reissued to members of Scotland Excel Executive Sub-committee.

4 Request for Associate Membership: Moray College UHI

There was submitted a report by the Chief Executive of Scotland Excel advising that Moray College UHI, part of the University of the Highlands and Islands, had submitted an application to become an associate member of Scotland Excel.

The report provided details of the organisation and the legislative position in relation to the application.

<u>**DECIDED**</u>: That the application by Moray College UHI to become an associate member of Scotland Excel, with no annual membership fee, be approved, subject to completion and signing of the agreement documentation.

5 Overview of the Scotland Excel Academy

There was submitted a report by the Chief Executive of Scotland Excel presenting an overview of the Scotland Excel Academy and which identified development opportunities for the future.

The report intimated that the Academy provided an award-winning multi-disciplinary development portfolio as detailed in figure 1 of the report; delivered learning which was typically 40-50% below market pricing; and spanned accredited learning, leading to a qualification, and unaccredited learning. Further detail was provided in the report.

The report advised that local authorities had requested lower cost and shorter duration development programmes and the Academy had explored a range of development programme options that would be achieved in a much quicker timeframe, remain of high academic standard, and be more cost effective for members. The new strategy would support lifelong development to ensure the right people could be hired and retained, addressing the current challenges in the labour market and aimed to offer learners a choice in the way that they become lifelong learners in the field of procurement.

The report noted that the new Academy Strategy would be based on responses to the questionnaire issued to Councils in December 2022 and would be presented to a future meeting of the Executive Sub-committee for consideration.

DECIDED:

- (a) That Scotland Excel's work-based-learning Academy be noted as a core people and organisational development solution across the Scottish public-sector, providing high quality, cost-effective useful learning;
- (b) That Scotland Excel provide members of the Executive Sub-committee with a login to access the Academy; and
- (c) That it be agreed that members be ambassadors for the Academy, promoting the depth and breadth of its portfolio and innovative cost-effective approach to work-based learning.

Operating Plan Update 2022-23

1. Summary

- 1.1 In June 2018, Scotland Excel's Joint Committee approved a new five-year corporate strategy supported by annual operating plans.
- 1.2 In December 2021, the Joint Committee approved a new operating plan which covers the period from 01 April 2021 to 31 March 2023.
- 1.3 Reports are issued quarterly to track progress made towards the delivery of the commitments contained within the operating plan. This paper presents the most recent report which covers operating plan activity to 31 December 2022.

2. Progress since September

- 2.1 As of the end of December 2022, thirty-one operating plan commitments were progressing in line with plans and are indicated as green within the report.
- 2.2 Two commitments are progressing slower than anticipated, and as such they are indicated as amber within the report.
- 2.3 One commitment is indicated as white within the report. This relates to the roll out a competitor analysis model scheduled for delivery towards the end of the financial year. This activity has now been incorporated into Scotland Excel's value project, and work will commence in Q4.

3. Recommendations

3.1 The members of the Joint Committee are invited to note Scotland Excel's progress in delivering the commitments contained within the Operating Plan 2022-23.

4. Background

- 4.1 Progress reports are produced quarterly to track Scotland Excel's activity against operating plan commitments. Reports are produced at the end of each quarter and submitted to Executive Sub-Committee meetings. The most recent quarterly report is also submitted to Joint Committee meetings with recent updates noted.
- 4.2 The reports summarise the progress made against operating plan commitments and uses a 'traffic light' symbol to provide a guide to the status of each activity. This guide has been revised to include symbols to indicate projects or activities which have not yet started, and projects or activities which have been completed:

1. Introduction and Background

This recommendation is for the award of the fourth-generation renewal framework for the Supply and Distribution of Fresh Meats, Cooked Meats and Fresh Fish. The current framework will expire on 31 March 2023. This proposed framework will be for a period of four years from 1 April 2023 until 31 March 2027 which, subject to approval and completion of a standstill period, is anticipated to be 1 April 2023.

This framework will provide councils with a mechanism to procure a range of fresh goods including but not limited to beef, lamb, pork, poultry, prepared products, cooked meats and fresh fish. Users of the framework are likely to include schools, nurseries, leisure centres, community centres, social work, council buildings and civic centres.

This report summarises the outcome of the procurement process for this national framework arrangement and presents recommendations for award.

2. Scope, Participation and Spend

As part of the strategy development and through consultation with the User Intelligence Groups (UIG) the lotting would remain the same with a slight change to lot 4 Specialised Products to include Halal Products.

The lot structure remains unchanged from the previous generation however there has been a greater emphasis on the products listed within Lot 1 and also the addition of more halal products in lot 4.

In a bid to promote and encourage participation from suppliers, 42 Geographical sub lots were applied within the 'ability to service' section of the tender. The Argyll & Bute Council area was sub divided to encourage bids for some harder to reach locations. Suppliers recommended for award will be by geographical sub lot area, and these are fixed for the framework duration. Scotland Excel also engaged with organisations such as Scotland Food and Drink, the Soil Association, Quality Meats Scotland and National Farmers Union Scotland to encourage participation from local suppliers.

As detailed in Appendix 1, 28 councils and Tayside contracts have confirmed their intention to participate in this framework. Comhairle nan Eilean Siar, Dundee City Council, Orkney Islands Council and Shetland Islands Council have confirmed that they do not intend to participate as they currently have their own arrangements in place. The Moray Council have advised that they are likely to participate in lot 2 only.

The framework was advertised at a total value of £10 million per annum, which equates to an estimated spend of £40 million over the maximum 4-year term of the framework. This advertised spend allows for increased participation from councils and associate members not currently utilising the framework and to take into account:

- The Scottish Government's pledge to increase the provision of free early learning and childcare provision to 1140 hours per year by the end of 2022 which will include a lunch service
- The roll out of universal free school meals across primary 4 7 pupils which has already been introduced for primary 4 and 5 with primary 6 and 7 to follow during the current parliamentary term
- The Scottish Government's manifesto pledge to introduce free breakfast service for all primary school pupils and pilot programmes in selected high schools
- A fourth-generation framework where the availability of sustainable products is a significant factor

- Unknown trade deals in the wake of Brexit which could create volatility in the marketplace
- The distribution-intensive requirements of this contract, e.g., fuel costs in remote areas
- Record levels of inflation along with rising CO2 costs impacting on food pricing
- The Good Food Nation (Scotland) Act 2022 and the responsibilities it is likely to introduce on councils around local food sourcing.

3. Procurement Process

A Prior Information Notice (PIN) was published on 16 February 2022 which resulted in expressions of interest from 14 companies. Several supplier engagement meetings were held on the basis of Regulation 41 (Preliminary Market Consultation) of the Public Contracts (Scotland) Regulations 2015 to understand the current marketplace, inform the supply base of Scotland Excel's intentions and to generate interest from SME's.

Thereafter, the Contract Notice was published via the Find A Tender and Public Contracts Scotland (PCS) portal on 03 November 2022, with the tender documentation being immediately available via the Public Contracts Scotland Tender (PCS-T) system. The tender exercise was conducted and concluded in accordance with the law and procedures currently in force.

As a matter of best practice and to ensure that the framework aligned with councils' requirements, a programme of consultation was conducted to understand their service requirements, the technical aspects of these services and their current purchasing practices and the future requirements that could be covered by this framework. This information was used to generate the specifications and selection/award criteria.

Scotland Excel has taken cognisance of the current situation relative to the Coronavirus pandemic. Balancing the current situation with the need to provide a route to market for councils to obtain fresh meats, cooked meats, fresh fish and specialised products including halal products. Scotland Excel has carefully monitored the situation throughout the period of the tender and determined it was appropriate to undertake this renewal tender exercise and recommend the establishment of this framework.

The procurement exercise followed an open tender procedure to encourage maximum competition and participation. All suppliers were evaluated against the advertised selection criteria using the Single Procurement Document (SPD), and the stated award criteria of:

- 1. Technical 30%
- 2. Commercial 70%

Within the technical section, suppliers were required to evidence their knowledge and experience by responding to a series of technical areas which are detailed within table 2 below:

The commercial section of the tender was worth 70 points. Points were awarded in the commercial section based on comparison of all offers received, whilst accounting for the supplier response to the commercial award criteria. Whilst minimum requirements were set, Scotland Excel reserved the right to consider all submissions received, all in accordance with the published tender documents.

Following a full evaluation of all compliant offers, scoring was completed in accordance with the published tender evaluation methodology, and an overall score was calculated for each supplier. The scoring was based on each Geographical area as a stand-alone offer,

4. Report on Offers Received

The tender document was downloaded by 13 organisations, with 8 tender responses received by the specified closing date and time. A summary of all offers received is provided in Appendix 2.

Despite significant engagement with councils and the marketplace, as per the current framework, no offer was received for the following council regions and lots:

Argyll & Bute Council - Area E, Tiree & Coll – Lots 1, 3 & 4 Argyll & Bute Council - Area F, Islay & Jura – Lots 1, 3 & 4 Comhairle nan Eilean Siar – Lots 1, 3 & 4 Highland Council – Lots 1, 3 & 4 Orkney Islands Council – Lots 1, 2, 3 & 4 Shetland Islands Council – Lots 1, 2, 3 & 4 The Moray Council – Lots 1, 3 & 4

Based on the criteria and scoring methodology set out in the tender document, a full evaluation of the compliant offers received was completed. Appendix 3 confirms the overall scoring achieved by each supplier.

5. Recommendations

Based on the evaluation undertaken, and in line with the advertised criteria and weightings summarised above, it is recommended that a multi-supplier framework arrangement is awarded to 8 suppliers across four lots and for the related geographical areas as outlined in Appendix 3.

The recommended suppliers offer best value and represent a mix of small, medium and large organisations. By taking an inclusive approach this will provide members with a greater offering.

The range of suppliers recommended provides coverage for framework lots and competitive option for all participating bodies as well as offering a degree of choice and capacity.

The Executive Sub Committee is accordingly requested to approve the recommendation to award this framework as detailed within Appendix 3 (Scoring and Recommendations).

6. Benefits

Savings

Scotland Excel has conducted a benchmarking exercise comparing current costs against the costs submitted within the renewal tender. The result of this benchmarking is listed in Appendix 1. The projected average saving across all councils is 1.5% which equates to an estimated total saving of approximately £81,211 per annum based on current forecast spend levels.

In addition, it should also be noted that the current framework is currently operating at c.12% below current market conditions based on the established market indexation model. As such, this is forecast to generate a 12% saving through cost avoidance.

Price Stability

The framework applies 6 months fixed pricing to all lots. Thereafter, all requests for price increases will be evaluated according to the Terms and Conditions of the framework and require to be supported by documentary evidence.

Rebate

A rebate of 0.6% payable to Scotland Excel will be applied to framework spend above £100,000 per annum (excluding the initial £100,000) and will be calculated

based upon all framework spend with the supplier reported through management information returns.

Sustainability

Within the technical section of the tender, Scotland Excel included a sustainability related method statement, which included questions on the following:

- Recycling
- CO2 Emissions
- Food Miles
- Route Planning

Responses received as part of the tender exercise are summarised, below:

One supplier has moved into a purpose-built state of the art premises, meaning the building is highly insulated, low on fuel consumption, and is as energy efficient as possible.

One supplier is currently trialling HVO (Hydro-treated Vegetable Oil) on 10 vehicles in their Edinburgh depot, as it delivers up to 90% less CO2e compared to conventional diesel. This trial will assess the commercial and operational viability of HVO as a widespread alternative to diesel.

Further responses included lowering carbon emissions from delivery vehicles through consolidation of shipments, switching to electric vehicles as and when available at the request of customers, reducing the frequency of deliveries and by picking up shipments from suppliers on return journeys to prevent extra deliveries and "empty running".

Scotland Excel will continue to monitor any changes in legislation that may affect the framework during its lifetime and will work with successful suppliers and councils to implement these.

Community Benefits

Scotland Excel is committed to maximising community benefits delivery for our members. Suppliers were asked to commit to the delivery of community benefit initiatives, against pre-agreed spend thresholds outlined within the community benefits method statement. These aim to be reflective of the National Indicators outlined within the Scottish Government's National Performance framework, and their underlying vision and goals. Councils will accrue 'community benefit points' based on their level of spend with a supplier. These 'points' correlate to a negotiable benefit that the council can elect to receive at any given point throughout the lifetime of the framework. All of the recommended suppliers have committed to delivering these benefits. Scotland Excel will continue to engage with all appointed suppliers to drive maximum adoption and delivery of community benefits where appropriate

Within the published tender documents, suppliers were given a list of indicative community benefits that could be agreed with councils. Examples of these are:

- Improve the skill profile of the population
- Improve levels of education attainment
- Increase the proportion of young people in learning, training or work
- Increase the proportion of healthy weight children
- Improve people's perceptions of the quality of public services
- employability workshop or events in schools, college or community groups
- Reduce children's deprivation
- sponsorship of local sports teams and community events

Scotland Excel will monitor delivery of these commitments during the lifetime of the framework, and this will also be reported through ongoing contract management returns. Results reported on community benefits will be disseminated to councils on a yearly basis.

Fair Work First including the Real Living Wage

Scotland Excel and its members are committed to the delivery of high-quality public services and recognise that this is dependent on a workforce that is well-rewarded, well-motivated, well-led, has access to appropriate opportunities for training and skills development, are diverse and is engaged in decision making. Within the technical section of the tender, suppliers were assessed on their approach to fair work practices and payment of the Real Living Wage to their workforce. Of the recommended suppliers, 4 pay the Real Living Wage, as detailed in Appendix 4 - List of Recommended Suppliers with Living Wage Status.

Scotland Excel will continue to work with suppliers to encourage greater coverage in those that pay the Real Living wage, and also to monitor additional commitment made.

7. Contract Mobilisation and Management

As part of the mobilisation process, all suppliers will be offered a contract mobilisation meeting to outline the operation of the framework, including roles and responsibilities, management information and community benefit commitments. Both suppliers and participating members will be issued with a mobilisation pack containing all required details to utilise the framework.

In accordance with Scotland Excel's established contract and supplier management programme, in terms of risk and spend as detailed in Appendix 5, this framework is classified as class B. As such, it will require quarterly supplier meetings, six monthly surveys and annual user group reviews as appropriate. During the current market conditions Scotland Excel will continue to engage with suppliers on a regular basis to manage the response to the pandemic and ensure continuity of this essential service delivery for our members.

Meetings and engagement undertaken with suppliers will adhere to all applicable health and safety guidelines.

8. Summary

This is the fourth-generation framework for the Supply and Distribution of Fresh Meats, Cooked Meats and Fresh Fish and aims to maximise collaboration, promote added value and deliver best value. A range of benefits can be reported in relation to savings, price stability, sustainability and community benefits.

The Executive Sub Committee is requested to approve the recommendation to award this framework agreement as detailed in Appendix 3 (Scoring and Recommendations).

Appendix 5 – Segmentation classifications

0322 Supply and Distribution of Fresh Meats, Cooked Meats and Fresh Fish is classified as class B.

There are five segmentation classifications and these classifications are rated from Class A to Class E. Each classification has contract and supplier management activities associated with it based on pre-determined weighted criteria.

Class A

Due to the unique and bespoke nature of the frameworks that fall within this class, a contract management plan to be developed and agreed with CSG.

Class B

Quarterly supplier contact, six monthly surveys, annual UIG, frequent support to councils, suppliers and external stakeholders requiring high level of procurement expertise, extensive contract monitoring.

Class C

Six monthly supplier contact, six monthly to annual surveys, annual UIG, regular support to councils, suppliers and external stakeholders requiring procurement expertise, high contract monitoring.

Class D

Annual supplier contact, annual surveys, optional annual UIG, ad-hoc support to councils, suppliers and external stakeholders potentially requiring procurement expertise, regular contract monitoring.

Class E

Annual supplier contact (if required), optional annual surveys, no requirement for annual UIG, straightforward ad-hoc support to councils, suppliers and potentially requiring procurement assistance, basic contract monitoring.

Request for Associate Membership of Scotland Excel by Glen Oaks Housing Association Limited

1. Background

1.1 Scotland Excel operates an Associate programme to allow access to its frameworks and services to a wide range of other public service orientated bodies. Applications can be made for Associate Membership by organisations such as council arm's length organisations, community groups, charities, housing associations and voluntary organisations which are a public body or a body that engages in activities of a public nature.

Organisations apply to Scotland Excel for Associate Membership to allow them to access the frameworks for goods and services which are in place for members. Associates do not have the opportunity to influence the future contract delivery schedule which is reserved for the full local authority members.

Associate membership supports the wider aims of Scotland Excel by increasing overall spend against frameworks, providing additional income and supporting the goals of promoting excellent public procurement across Scottish organisations.

2. Organisation Background

- 2.1 Glen Oaks Housing Association Limited is located in the south of Glasgow representing the three communities of Arden, Darnley and Pollok with a housing stock of 1,348 properties. Glen Oaks Housing Association provide low cost housing for those in need, with a strong reputation as an innovative community-controlled organisation placing customer service, financial viability and being an excellent employer at its heart. Glen Oaks Housing Association Limited is a Registered Society (under the Co-operative and Community Benefit Societies Act 2014), a Registered Social Landlord and a Registered Scottish Charity.
- 2.2 Glen Oaks Housing Association Limited is a real living wage employer.

3. Associate Membership Process

- 3.1 Before any application is submitted for approval, a number of validation checks on the organisation are carried out. These include a review of the Memorandum & Articles of Association, the financial position and the type of contracts that the organisation is likely to access. It is confirmed that satisfactory validation checks have been completed in relation to this application.
- 3.2 Scotland Excel monitors all requests from applicants to become associate members to ensure that any legal requirements are met. In this case, Glen Oaks Housing Association Limited can be recommended for associate membership on the basis of the Local Authorities (Goods and Services) Act 1970 section 1 (1B)(c). Namely, that it has functions that are public in nature or engages in activities of that nature so long as the purpose or effect of access to Scotland Excel's services is to facilitate its discharge of those functions or activities.

3.3 Fees are determined in a number of ways:

Arms Length External Organisations (ALEOs) related to local authority members pay no fee as this is covered within requisition fees.

National Health Service (NHS) bodies, Colleges and Universities, and Non departmental bodies of the Scottish Government pay no fee under a reciprocal agreement that allows local authorities to utilise contracts created by the relevant procurement centres of expertise.

All other associate fees are calculated on a standard methodology agreed by committee. e.g. Housing Associations pay based on the number of houses within their portfolio.

4. Recommendations

4.1 It is recommended to committee that Glen Oaks Housing Association Limited application to join Scotland Excel as an associate member be approved, with an annual fee of £2,022 subject to the agreement document.

Update on the Contract Delivery Plan

1. Progress to Date

This report provides a progress update on the 2022/2023 contract delivery plan.

Appendices 1 – 4 of this report on the 2022/ 2023 Contract Delivery Plan detail new framework developments and renewals, flexible frameworks, framework extensions and frameworks with ongoing contract management activity.

At any given point there are around 70 frameworks in the Scotland Excel contract portfolio. It is intended 5 further frameworks will be developed and added to the portfolio in the coming year. 20 of these frameworks are to be renewed during 2022/2023 (Appendix 1).

A further 17 of the frameworks on the current portfolio have extension options that are available to be exercised in 2022/2023, with 13 of these extensions already being approved (Appendix 3).

The estimated forecast value of the Scotland Excel framework portfolio is approximately £2Billion.

Overall, efficiencies created by frameworks awarded so far during 2022/2023 are benchmarked at 1.73%, which is slightly below the forecast range. This figure does not include the additional cost management measures in place for each framework via the indexation model. This model provides data on how the framework pricing compares to market indices relevant to the commodity being sourced. This is provided to ensure Scotland Excel is able to manage pricing in volatile markets to ensure a favorable position for members.

A summary of spend and forecast savings per council between October 2021 and September 2022 can be found in Appendix 5, with an average forecast efficiency of c.1.27%. It should be noted that this does not include financial efficiency derived though cost avoidance measures, such as the avoidance of duplicate tendering activity or managing price variance below market movement. An enhanced reporting methodology to include such measures will be presented to members for consideration at a future meeting of the Executive Sub Committee.

In addition to the activity detailed in Appendices 1 - 4, Scotland Excel is exploring the benefits of further collaborative procurement across high spend, critical service areas in the construction, corporate, ICT and social care teams. In order to create capacity to add new activities to the portfolio and support strategically significant areas of spend, a consolidation of the existing portfolio is underway. This means some existing frameworks within related markets are being consider for merger and some lower value frameworks will not be renewed.

Social Care

A User Intelligence Group meeting in relation to **Care Homes for Adults with Learning Disabilities Including Autism**, was held on 18 January 2023, and was well attended. The survey issued to local authorities is complete and the results have been shared with the group. The findings highlighted that a number of local authorities have requested that the scope of the framework is expanded to cover other adult social care groups. This framework is due to expire on 16 September 2023. Any new developments will require an opportunity assessment to establish the timescale and resources required for purchasers and Scotland Excel if the scope of the framework were to be extended.

The **Residential Rehabilitation** project was commissioned by the Scottish Government with the remit of researching and developing national approaches for commissioning of alcohol and drug residential rehabilitation. The initial market research and analysis phase has concluded, and Scotland Excel is now moving on to development of a national framework agreement for residential rehabilitation services (including detoxification services).

The national framework agreement is anticipated to cover publicly funded placements across Scotland commissioned by Health and Social Care Partnerships and through Alcohol and Drug Partnerships. The focus will be on the quality of services and agreed requirements. The anticipated timescales are to establish a framework during 2023. The initial development work will include engagement with a range of stakeholders including people with lived experience of services.

During 2022, consultation with commissioners and the provider market was conducted on the opportunities and risks of re-opening the **Care and Support** framework. A User Intelligence Group was held on 26 January 2023, to present the consultation findings highlighting that the timescale and resources for purchasers, providers and Scotland Excel to respond to a further re-opening exercise, whilst undertaking development work for the 2nd generation, is challenging. With this in mind, directing time and resource to the develop the next generation were pivotal to the final decision not to re-open the framework. Scotland Excel will continue to support the current operation of the framework through User Intelligence Groups, and stakeholder meetings until 31 March 2024.

In January 2023, following a procurement exercise, Scotland Excel established the third-generation flexible framework agreement for the provision of trained and vetted **Social Care Agency Workers** in a variety of social care settings. A total of 34 Suppliers were awarded to the framework across 3 Lots and 17 Regional Sub-lots,

which reflect an increase in the number of participating suppliers. A User Intelligence Group is scheduled on 8 February 2023 and supplier sessions on 10 and 16 February 2023 to mobilise the framework.

There has been a change in direction for the redesign of the **National Care Home Contract (NCHC)**. The care home representatives in conjunction with COSLA and local authority representatives as signatories to the contract, have agreed that what is required at this time is an update of the current contract and a review of the current cost of care model. Once this is completed, it will re-engage these key participants in the redesign process. There has been an initial drafting of an updated contract to be shared with the signatories at this time. The review of the cost model will begin April 2023.

Scotland Excel continues to mobilise the **Children's Residential and Education**, **including Short Breaks**, **Services** flexible framework that went live on 1st October. This includes reviewing and streamlining the Management Information process and requirements for the framework. This process included developing a new template and both providers and UIG members reviewing and providing feedback. In addition, the fee uplift process for 23/24 fees is currently underway and Scotland Excel is working with a range of stakeholders regarding this.

Scotland Excel is engaging with stakeholders regarding the renewal contracts for **Secure Care Services**. The current contracts have been extended to 30th March 2024, however due to increased policy change in this area, work is underway relating to the next generation contracts, to ensure these are fit for purpose and meet the needs of children and young people.

An initial meeting regarding "Reimagining Secure Care" has been held between Scotland Excel and the Children & Young People's Centre for Justice (CYCJ). CYCJ has been appointed by Scottish Government to lead this work, specifically:

"'Reimagining Secure Care' as part of the 'Reimagining Justice Service' is designed to combine views, knowledge, and experiences of all stakeholders involved to create a comprehensive understanding of what will be effective, meaningful and sustainable for secure care services to meet the needs of all children and young people who are deprived of their liberty on welfare or justice grounds, from the Children's Hearing System or through Courts."

Scotland Excel will continue to engage with this work and ensure contract renewal work is aligned with this wherever possible.

Construction, Transport and Environmental Services

Scotland Excel's **Electric Vehicle Charging Infrastructure (EVCI)** framework has now been fully mobilised with both contractors and customers. The objective of the framework is to support the transition from petrol and diesel light commercial vehicles. This move to lower emission vehicles in Scotland is in line with the Scottish Government Climate Change Plans.

Since the workshop in October, there has been an increase in enquiries on utilising the framework. Several local authorities and other associate members have been in touch to discuss how to get the best out of the framework.

The **Energy Efficiency Contractors (EEC)** framework provides members with a pathway to upgrade Scotland's existing housing stock (c.660,000 homes) and buildings, with innovative energy efficiency measures to reduce carbon output and household bills.

After the focussed workshop at Mitsubishi in December, work on a survey in consultation with the Scottish Government and Scottish Enterprise has taken place on heat pump installations in Scotland. This is with a view to understanding better the public procurement opportunities which may provide potential to strengthen Scottish manufacturing capability.

From the beginning of 2023, there has been an uptake in activity on the Energy Efficiency Contractors Framework. Many councils confirmed work going through the framework when asked for their predicted forecasting.

One mini competition was confirmed to commence at the start of March for potentially ten million pounds worth of work. This same local authority has also made a separate enquiry on upgrading their domestic central heating. This will be gas boilers, electric storage, air source heat pumps, solar PV and various other renewables and low carbon technology.

Another local authority is planning to use the Energy Efficiency Contractors framework for External Insulation Projects. In addition, the NHS and numerous housing associations have also enquired as to how they best utilise the framework.

Several frameworks are currently under development:

Building Construction Consultancy has been presented to the Executive Sub Committee and is progressing through our award procedures.

The consolidated **Construction Materials** framework brings six mature goods-based frameworks together, creating efficiencies for our stakeholder groups. By harmonising tendering and contract management milestones, once awarded, this framework will enable a range of sustainable procurement outcomes. Development work is ongoing to finalise the procurement strategy and related tender documentation.

The evaluation of the first-generation **Property Maintenance and Refurbishment** framework is at an advanced stage. There has been a high level of interest in the arrangement with the tender soon entering recommendations and award stage. Once live this framework will provide a route to market for a broad range of repair, maintenance, and refurbishment services.

Following the decision at October's UIG, to merge and consolidate Grounds Maintenance Equipment and Light and Heavy Plant into one framework – **Grounds and Plant Equipment**, discussions have taken place with the technical UIG team to finalise the specifications, examine and revise the lotting structure. The procurement strategy and evaluation methodology is currently being finalised in preparation for Tender publication.

Street Lighting Materials was prepared for submission to the Executive Sub Committee but was subject to judicial interruption. An abandonment notice, in line with regulations 85(7) and (8) of the Public Contracts (Scotland) Regulations 2015, was published to all tenderers, through the PCS-T message board facility, for this tender exercise. Revised tendering documents and specifications are currently being prepared for re-tender.

Our strategy for the second-generation **New Build Residential Construction Framework** is nearing conclusion as attention turns to preparation of the tender documents. Through the published Prior Information Notice (PIN), a range of engagement is underway with our diverse stakeholder group to inform refinements to our offering, with revised scope and terms being developed as appropriate.

Security Services and Cash Collection has entered pre-strategy with the next generation of the framework scheduled for late 2023. **Asbestos related Works and Services** strategy has now been approved and tender development is underway following engagement with the User Intelligence Group (UIG) on a refined evaluation methodology.

Development work has commenced on a new framework for the provision of services for Scottish local authorities and the Scottish Government related to **Local Heat and Energy Efficiency Strategies (LHEES)**, heat network zoning and Local Area Energy Planning (LAEP).

Corporate, ICT and Operational Supplies and Services

Although overall inflation has started to fall, food inflation is still rising. The World Bank is predicting that global food prices will decrease by 5% in 2023, stabilizing at that level (which is still high) in 2024 which could have a knock-on impact in the UK. There are some other signs of improvement such as wholesale gas prices decreasing by 50% since the peak in Summer 2022. However, the Government's Energy Bill Relief Scheme for business is being scaled back in the Spring which may lead to retailers increasing food prices for citizens. Furthermore, labour shortages in the food industry look set to continue in 2023.

The next generation **Audio Visual Equipment** framework is due to go live in April 2023. This tender is currently being evaluated and recommendations will be presented at the March Executive Sub Committee meeting.

A contract notice has been published for **Commercial Catering Equipment** with tender documentation available through the Public Contracts Scotland Tender website. The tender is due to close in February, with evaluation taking place during February and March and recommendations due to be presented at the April Executive Sub Committee meeting.

Prior information notices have been issued through Public Contracts Scotland for upcoming tenders including **Bottled Gas**, **Fire Safety Equipment**, **Signage** and

Cleaning Equipment. Initial development is also underway for tenders relating to Alcoholic Beverages and Sheriff Officers.

The ICT team continue to develop the tender documents for the following contracts: National Shared Digital ARC, Technology Enabled Care frameworks. The National Shared Digital ARC project has experienced some delays in tender release, due to the complex nature of terms and conditions and cyber security requirements. The tender is expected to launch in Spring 2023

The team is engaged in several projects with our partner the Scottish Local Government Digital Office these projects include **Office 365**, **Security Operation Centre** and the **Scottish Technology Asset Management Platform (STAMP)** which is a central repository of data on ICT and digital solutions being used across local government. Work continues to onboard colleagues from Local Government.

The team regularly attends and provides procurement input for the following boards – Digital Assurance, Public Sector Innovation, the Department for Education four nations roundtable on commercial themes in schools and Telecare Steering Group. We are working with the Improvement Service to deliver three key projects on their behalf throughout 2023.

Associate Member Overview

1. Summary

1.1 This report provides an overview of the Scotland Excel associate membership programme.

2. Background


2.1 Scotland Excel associate membership can be classified into five main groups. Housing Associations, Council Arm's Length Organisations (ALEO), transport partnerships, organisations utilising the reciprocal arrangements (Scottish Government and Education) and other bodies (e.g., Charities).

In June 2018 the Joint Committee approved Associate member expansion as part of the income strategy and at the December 2018 Joint Committee members approved Scotland Excel's recommendation of a continued focus and a dedicated Associates team.

Between April 2017 and April 2019, associate member growth mainly came from housing associations as a result of participation in the Scottish Government Affordable Housing project known as the Procurement Commercial Improvement Programme (PCIP). However, the expansion of the contract portfolio, the growth of additional services and the appetite for greater collaboration since the COVID pandemic has significantly increased the membership from Scottish Government bodies, ALEO's and Universities and Colleges over the last two years and brought membership to the current level of over 140 members.

Figure 1 demonstrates the growth of associate membership since the last committee report in Jan 2021.





The breakdown of associate members by group is illustrated in table 1 below showing a comparison against the previous report in Jan21.



3. Update

3.1 The two staff within the associate team are fully funded from membership fees ensuring no detrimental impact on the core operations of Scotland Excel. The income breakdown of Scotland Excel associate members in January 2023 is shown in the following chart (Figure 2).

It should be noted that both ALEO and organisations covered by the reciprocal agreement, pay no fee.

Scotland Excel operates a reciprocal agreement with the other centres of procurement expertise, Advanced Procurement for Universities and Colleges(APUC), National Shared Services (NSS) and Scottish Procurement within Scottish Government to maximise collaboration and contract sharing to provide best value for the public sector. Scotland Excel provides a signposting service to ensure that councils achieve best value across a whole range of National arrangements. Councils make extensive use of frameworks beyond Scotland Excel and pay no fee as part of the reciprocal agreement.

Member Councils benefit from improved pricing on Scotland Excel contracts due to increased spend as a result of wider usage from other public bodies.

3.2 Housing associations make up the single largest group with forty-three members and currently provide the largest income from fees (figure 2). The revenue increased significantly after 2016 when Scotland Excel delivered the Scotlish Government PCIP programme from 2017 to 2019 and raised awareness to the sector of Scotland Excel's work. At the same time, Scotland Excel continued to grow sector membership by expanding the construction contract portfolio that offered housing associations compliant routes to market

in areas such as new build housing construction, energy efficiency contractors, engineering consultancy and domestic gas boiler maintenance.

The PCIP programme was well received, and many saw the positive benefits that robust procurement practices can bring to their organisation. The following quotes from two of the programme participants (who subsequently became Scotland Excel associate members) typifies the positive feedback and benefits many got from the programme.

Kingdom Housing Association said "Scotland Excel highlighted good practice and offered advice and assistance on areas of improvement. This allowed us to put in place a clear procurement improvement action plan across all departments of the organisation to continue to strive and improve on our PCIP score going forward".

Glasgow West Housing Association noted that "The assessment will be different for each organisation that takes part, with real opportunities for those that take the first step in the initial self-assessment and evidence gathering before the evaluation."

Scotland Excel will continue to encourage more housing associations to become members by promoting the contract portfolio at housing events, customer meetings and offering the new Continuous Improvement Programme for Procurement (CIPP). The CIPP was launched in December 2022 and forms part of the Scottish Government Affordable Housing Supply Programme guidance that mandates all developing associations complete a procurement assessment as a condition of grant funding. Unlike the previous PCIP programme that was fully funded by the Scottish Government, the CIPP will be a chargeable service from Scotland Excel to housing associations and available to both members and non-members.

- 3.3 There are currently twenty-six council arm's length organisations (ALEO) which are members of Scotland Excel and therefore benefit from frameworks and services. There is a total of one hundred and thirty ALEO aligned to local authorities. Scotland Excel staff continue to raise awareness and regularly encourage council staff at review meetings to alert ALEOs to the benefits of free membership. Scotland Excel will continue to raise ALEO eligibility with Finance Directors, highlighting the benefits of membership, collaboration and financial value. The associate team has had recent success in collaborating with Fife Council Procurement team to enrol the majority of their ALEO's to Scotland Excel and provide an overview of the benefits they can achieve from being a Scotland Excel associate member.
- 3.4 Other associate members come from a range of non-departmental public bodies (NDPB's), transport organisations, and a mixture of members from social care, education and other public bodies. The biggest growth area has been in the government sector with many of the NDPB's joining during the pandemic to primarily benefit from contracts such as Personal Protective Equipment (PPE) and janitorial supplies to assist with business continuity. Scotland Excel compliant contracts also relieved the pressure of re-tendering for these organisations. The growth in this sector membership can be seen in Figure 1.

3.5 Scotland Excel has engaged with the third sector over the last three years to promote the benefits of associate membership. There are over forty-five thousand charity organisations in Scotland within scope, ranging from micro one-person operations through to large national organisations. This sector presents an opportunity for Scotland Excel to provide a focused approach to a market that provides a vital part of our community and national supply chain.


The sector provides a unique challenge when discussing membership options as it has a diverse subset including - Charities, Social Enterprises, Supported Business and Community Groups. As the majority of Third Sector organisations are small without any in-house procurement capability, there may be a larger opportunity in this sector for some of Scotland Excel's wider paid services and procurement support.

Attracting new members from the third sector has proved difficult to date and Scotland Excel has attempted to raise its profile in the sector in a number of ways including the "free associate programme" which was available to all public sector organisations during COVID. Additionally, we have targeted the top 150 third sector organisations in 2022 to promote the benefits of joining Scotland Excel, with different membership options including pilot schemes and umbrella organisation membership. In November 2022, Scotland Excel wrote to all third sector Scotland Excel framework providers offering membership and are currently engaging with responders to discuss the benefits of joining Scotland Excel.

3.6 All potential associate members follow the same joining process irrespective of whether there is a fee to Scotland Excel or not. The current fee split is represented below (figure 4). All organisations requesting membership must provide the necessary evidence to pass the Local Authorities (Goods and Services) Act 1970 that it has functions that are public in nature.



3.7 Income from associate member fees has increased significantly over the last few years and the dedicated associate team has been able to encourage a wide range of new associates by promoting the benefits from the wider contract portfolio, the new Scotland Excel service offerings and the Academy. This can be seen in the following table (figure 5).



3.8 A full list of the current Scotland Excel associate members is provided in Appendix 1.

4. Key Membership Data

4.1 The associate membership base ranges across a number of public sectors and across a number of member regions. In addition to the benefits outlined previously, Scotland Excel also encourages and promotes a number of organisational fair work policies such as living wage, use of supported business and other key policy areas. Approximately 90% of members are Living wage employers.







- 4.2 Some associate members have provided valuable insight into their sectors which has been included into some of our contracts (particularly construction) and enriched the offering provided to all our members.
- 4.3 Within the last twelve months, our associates have spent £40 million through Scotland Excel frameworks with notably high spend on New Build Residential Construction, Security Services and Cash Collection. This additional spend benefits our core members and the enhanced buying power can be used to provide additional services in their local communities.

5. Next Steps

- With the CIPP programme launched in December 2022, the associate team will be conducting assessments for housing associations which need to meet the Scottish Government conditions of the housing grant funding application. This will continue beyond 2023 as Scottish Government see this as a continuous programme. While it is not mandated that Scotland Excel is the only provider of this service, our record of delivery and experience has seen a few enquiries already. As with the last programme, this represents a unique opportunity to promote the benefits of membership, collaboration, and promote our main construction frameworks such as the new build framework, energy efficiency contractors and the forthcoming property, repair and maintenance framework.
- The associate team will seek to increase growth in third sector associate membership. Engaging with their governing bodies, setting up meetings to promote Scotland Excel services, provide benchmarking of cost savings and highlighting areas of opportunity will continue to be a key focus of the team in 2023.
- .5.3 Scotland Excel will continue to review spend levels of associates to ensure that the fee reflects the usage from the associate. Accurate reporting from our suppliers continues to be a key measurement. It is important to establish if any significant changes to spend levels will be sustained by the associate over a consistent period and not for a one-off project.

6. Recommendations

6.1 Members are asked to note the progress made regarding the ongoing work with Associate members and to encourage suitable organisations to apply for membership.
