# **Apology**

#### **Declarations of Interest**

W Swanson, Paisley West & Central Community Council declared a non-financial interest in item 1 on the agenda as two of the applicants for membership of the Local Partnership were also members of Paisley West & Central Community Council. He intimated that he would remain in the meeting but not take part in the discussion or decision relative to the two applications.

# Membership of Paisley North, Gallowhill, Ferguslie and Paisley West& Central Local Partnership

There was submitted a report by the Chief Executive relative to the appointment of community representatives to vacant positions within the Local Partnership.

The report advised that in terms of the decision taken at the meeting of the Council held on 27 September 2018 membership of the Local Partnerships would be comprised of an equal number of elected members from Renfrewshire Council and community representatives with the standing members being those elected members which represented the Local Partnership area and a representative of each active community councils in the area. The 10 elected members eligible for membership of the Paisley North, Gallowhill, Ferguslie and Paisley West & Central Local Partnership were detailed together with the representatives of the three active Community Councils in the area. As a result, there were currently seven vacancies for community representatives.

Details of 13 organisations who had, to date, expressed an interest in providing a community representative on the Local Partnership were provided within the report. Criteria to assist members to come to a decision on the appointment of community representation was also provided.

The report intimated that the Gallowhill Community Council was currently inactive and it was agreed that the vacant position for the Community Council be left open to allow community groups from that area to apply for membership of the Local Partnership.

The Strategic Partnerships and Inequalities Manager advised that one of the applicants, representing Paisley Sea Cadets, had been included in this Local Partnership area in error and accordingly should not be considered at this meeting.

The members then considered the remaining applications received.

Councillor McNaughton moved that Alan Clark (CREATE Paisley), Alison Love (Disability Arts Forum), Christine Williams (Renfrewshire Effort to Empower Minorities), Darran Gillan (YMCA) and Heather Kay (Star Project) be appointed to the Local Partnership. This was agreed unanimously.

Councillor McNaughton, seconded by Councillor McEwan, moved that Margaret Dymond (Maxwellton Court Tenants' Association) be appointed to the sixth and final available community representative place of the Local Partnership.

Councillor Kennedy, seconded by J McIntyre, moved as an amendment that Morven Cruikshank (Renfewshire Access Panel) be appointed to the sixth and final available community representative place of the Local Partnership.

On a vote being taken, three members voted for the motion, two members voted for the

amendment and one member abstained. The motion was accordingly declared carried.

Councillor McNaughtan proposed that Community Planning contact those applicants who had not been successful in their applications to become members of the Local Partnership and set out the opportunities available to them to participate in the business of the Local Partnership on a non-voting basis. This was agreed.

#### **DECIDED:**

- (a) That the vacant position for the inactive Gallowhill Community Council be left open to allow community groups from that area to apply for membership of the Local Partnership;
- (b) That Alan Clark (CREATE Paisley), Alison Love (Disability Arts Forum), Christine Williams (Renfrewshire Effort to Empower Minorities), Darran Gillan (YMCA), Heather Kay (Star Project) and Margaret Dymond (Maxwellton Court Tenants' Association) be appointed to the Local Partnership; and
- (c) That Community Planning contact those applicants who had not been successful in their applications to become members of the Local Partnership and set out the opportunities available to them to participate in the business of the Local Partnership on a non-voting basis.





As recorded by the Scottish Index of Multiple Deprivation





#### SIMD 2016 - Access Deprivation




#### **Access Deprivation**

This measure includes drive time to GP, to retail centre, to petrol station, to primary and secondary schools, to post office and public transport time to GP, to retail centre, to post office.




#### **Health Deprivation**

This measure includes the Standardised Mortality Ratio; Hospital stays related to alcohol misuse; Hospital stays related to drug misuse; Comparative Illness Factor; Emergency stays in hospital; Proportion of population being prescribed drugs for anxiety, depression or psychosis; and Proportion of live singleton births of low birth weight.

#### Place Standard, 2017


200 residents from Paisley North Local Partnership area responded to the Our Renfrewshire, Place Standard Consultation in 2017. 67 % of the respondents were female and 31 % were male, with most respondents of working age.

#### Most positive responses



Most mixed responses were received about streets and spaces; play and recreation; facilities and amenities; and social contact.

#### Safer & Greener data

Safer and Greener – Exercises in Ferguslie, Shortroods and Gallowhill

Ferguslie 2016 – 64% of people feel safe/very safe. Priorities were rubbish/litter, animal nuisance, drug misuse/dealing.

Gallowhill 2017 – Priorities: drug issues, violent crime, housebreaking, vandalism, litter, speeding vehicles. Improvements suggested are local facilities for youth, more CCTV.

Shortroods - 67% of people feel very/fairly safe. Priorities: drugs misuse/dealing, violent crime, housebreaking, litter. Improvements: more activities/youth clubs, address dog fouling.

#### TITLE:

**Local Partnership – Future Arrangements** 

#### 1. Summary

- 1.1 Paisley North, Ferguslie Gallowhill and Paisley West & Central Local Partnership requires to take a number of decisions about its operation over the next year.
- 1.2 These decisions relate to the arrangements for meetings and the name the Local Partnership wishes to be known by. Members of the Local Partnership are invited to contribute to these decisions as set out in section 3 below.

#### 2. Recommendations

- 2.1 It is recommended that Paisley North, Ferguslie, Gallowhill and Paisley West & Central Local Partnership:
  - (a) Agree that three further meetings of the Local Partnership be held in June 2019, November 2019 and March/April 2020 with a wider community engagement event to take place during September/October 2019, as set out in paragraphs 3.1 3.3.
  - (b) Agree that members of the Local Partnership contribute their views on accessible venues for future meetings, as set out in paragraph 3.4.
  - (c) Agree that members of the Local Partnership contribute suggestions for its name going forward as set out in paragraphs 3.5-3.6, for decision at next meeting on Wednesday 19 June 2019.
  - (d) Note the arrangements for Community Representative expenses, as set out in paragraph 3.7.

#### 3. **Background**

- 3.1 Local Partnerships will meet a minimum of three times per year. The next meeting of Paisley North, Ferguslie, Gallowhill and Paisley West & Central Local Partnership will take place at 6pm on Wednesday 19 June 2019 in the Marriage Suite, Renfrewshire House.
- 3.2 It is proposed that each Local Partnership sets two further dates to meet in November 2019 and March/April 2020 and that the start time for meetings be agreed as 6pm.
- 3.3 In addition to the three Local Partnership meetings per annum it is proposed that a community event be organised to enable engagement with community groups, voluntary organisations and members of the public who are not members of the Partnership.
- Paisley North, Ferguslie, Gallowhill and Paisley West & Central Local Partnership is asked to consider whether it would prefer a single venue for all meetings or to alternate between different venues within the Local Partnership area. Members are asked to send any suggestions for accessible local venues to <a href="mailto:communityplanning@renfrewshire.gov.uk">communityplanning@renfrewshire.gov.uk</a> by Tuesday 7 May 2019.
- 3.5 Each of the seven Local Partnerships consist of groupings of Community Councils. The name currently being used for the Local Partnership is simply a list of the names of each Community Council in the area.
- 3.6 Each Local Partnership may choose its own name, by agreeing either to continue with its current name or changing to an alternative name. Proposals for an alternative name should be submitted to <a href="mailto:communityplanning@renfrewshire.gov.uk">communityplanning@renfrewshire.gov.uk</a> by Tuesday 7 May 2019 for consideration and decision at the meeting of the Local Partnership.
- 3.7 Under the previous Local Area Committee arrangements, community representatives were entitled to £50 per annum expenses to attend meetings. Members of the Local Partnership may continue to claim £50 per annum expenses for attendance at meetings. This resource would be drawn from the Local Partnership grant funding allocation as was the case previously under Local Area Committee arrangements.
