1. Summary

1.1 Section 18 of the Procurement Reform (Scotland) Act 2014 requires that any contracting authority which is required to prepare or revise a procurement strategy in relation to a financial year must prepare an annual procurement report on its regulated procurement activities as soon as reasonably practicable after the end of that financial year.

- 1.2 As a minimum this report must include:
 - a summary of the regulated procurements that have been completed during the year covered by the report;
 - a summary of community benefits fulfilled during the year covered by the report;
 - a summary of any steps taken to facilitate the involvement of supported businesses in regulated procurements during the year covered by the report; and
 - a summary of the regulated procurements the authority expects to commence in the next two financial years.
 - 1.3 The Annual Report attached in Appendix 1, provides an update on key indicators set in the Corporate Procurement Strategy for the period April 2020-2023.

2. Recommendations

2.1 The Finance, Resources and Customer Services Policy Board are asked to note the content of the Annual Report for the Financial Year 2022/23.

3. Background

- 3.1 Section 18 of the Procurement Reform (Scotland) Act 2014 requires that all public sector contracting authorities with a spend of more than £5million per annum publish an Annual Report relating to Regulated procurement activity. The content of the Annual Report is analysed by Scottish Government Procurement and the information included in the Scottish Ministers Annual Report on Procurement Activity in Scotland.
- 3.2 The Annual Report provides an opportunity to provide an update on procurement activity undertaken over the last financial year, and to give an indication of future contracting opportunities.
- 3.3 A Regulated Procurement is any procurement for:
 - Goods, Supplies and Services (excluding services covered under Schedule 3 Social and Other Specific Services of the Public Contracts (Scotland) Regulations 2015) with a total value of £50,000 up to £177,896.99;
 - Services defined under Schedule 3 Social and Other Specific Services of the Public Contracts (Scotland) Regulations 2015 with a total contract value of £50,000 up to £552,949.99;
 - Works contracts with a total value of £2million up to £4,447,446.99.
- 3.4 A procurement at or above the Threshold set by the Government Procurement Agreement is any procurement for:
 - Goods, Supplies and Services (excluding services covered under Schedule 3 Social and Other Specific Services of the Public Contracts (Scotland) Regulations 2015) with a total value of £177,897 and above;
 - Services defined under Schedule 3 Social and Other Specific Services of the Public Contracts (Scotland) Regulations 2015 with a total contract value of £552,950 and above; and
 - Works contracts with a total value of £4,447,447 and above.
 (The above amounts are exclusive of VAT)
- 3.5 The information provided in the Annual Report is gathered by Scottish Government Procurement and Property Directorate and included in the national "Annual Report on Procurement Activity in Scotland."
- 3.6 The Annual Report provides an opportunity to recognise the contribution that procurement can make to the economy and communities in Renfrewshire and to celebrate the success of the procurement team.

Introduction

Background and Purpose

On 1 April 2020, in accordance with Section 15 of the Procurement Reform (Scotland) Act 2014 (the Act), Renfrewshire Council published its Corporate Procurement Strategy for the period 1 April 2020 to 31 March 2023. This strategy described the fundamental role procurement had in supporting the delivery of the Council's strategic objectives aligned to the Council's Plan "Thriving People, Connected Communities" and established actions aligned to the 5 key outcomes of that Plan:

- · Reshaping our place, our economy and our future;
- · Building strong, safe and resilient communities;
- · Tackling inequality, ensuring opportunities for all;
- · Creating a sustainable Renfrewshire for all to enjoy; and
- Working together to improve outcomes.

Renfrewshire Council now has a new strategic plan for 2022 – 2027 which seeks to *Create a fairer Renfrewshire built on innovation, wellbeing and opportunity.*

This new Plan is high level in nature and sets out how the Council will work with partners, communities and businesses to progress 5 strategic outcomes:

- Place working together to enhance wellbeing across communities
- Economy building an inclusive, green and resilient economy
- Fair nurturing bright, happy and healthy futures for all
- Green leading Renfrewshire to Net Zero
- Living our values making a difference together

The Corporate Procurement Strategy will be reviewed and updated to this new Council Plan and future Annual Reports will focus on the new plan and strategy, however, this report is retrospective for the period 2022-2023 therefore the outcomes and indicators of this Report align to the Council Plan for the period 2017-2022 and the Corporate Procurement Strategy for 2020 – 2023.

Section 18 of the Act requires that:

"a contracting authority, which is required to prepare or revise a procurement strategy in relation to a financial year, to prepare an annual procurement report on its regulated procurement activities as soon as reasonably practicable after the end of that financial year".

This Annual Procurement Report provides an opportunity to report on our Regulated procurement activity over the financial year 2022 / 2023 in accordance with the requirements of the Act. It also provides an opportunity to update on procurement activity below the threshold for Regulated Procurement and to report on the progression of the Action Plan set out in Appendix 1 of the published Procurement Strategy 2020 - 2023 (Section 2 - Review of Regulated Procurement Compliance).

Procurement Overview

In the financial year 2022 – 2023, total recorded spend via external contractors, providing Goods, Services and Works to Renfrewshire Council was £253,392,487.

This spend was with 5,158 suppliers, of whom 1,507 were SMEs (accounting for 50% of the total spend), and 348 were local suppliers based within Renfrewshire. 18.29% of the spend was local, accounting for £46 million into the local economy.

All procurements with a value of £25,000 and above are carried out by the Council's Corporate Procurement team in accordance with the Standing Orders Relating to Contracts (available here: https://www.renfrewshire.gov.uk/article/4008/Standing-orders-relating-to-contracts)

The procurement team operate a Category Management approach covering:

- City Deal and Infrastructure
- Construction / Works
- Corporate and ICT
- Environment and Infrastructure; and
- Social Care and Education Services

Table 1 below provides an indication of spend across our key category areas. Note that in the year 2022/23 Construction related contracts accounts for 34% of our total spend and Social Care & Services accounts for 25% of our total spend.

All Council tenders with a value of greater than £50,000 are advertised on the Public Contracts Scotland portal and contracts above the Government Procurement Agreement (GPA) Thresholds are advertised on Public Contracts Scotland and the UK Find a Tender Service.

Tenders for supplies and services with a value of £25,000 - £49,999.99 are conducted via Quick Quote using Public Contracts Scotland and in the period 2022/23 Works contracts up to £177,897 were conducted via Quick Quote. The upper limit for works via Quick Quote was reviewed in accordance with CPN 9/2020 "Guidance on contract amendments to payment terms and the use of Construction Procurement Route 1A (Quick Quote)" and the Council's Standing Orders Relating to Contracts have been updated to allow the use of Quick Quote for Works Contracts up to £500,000, with a minimum of 75% local contractors invited to quote where possible.

Section 1 – Summary of Regulated Procurements Completed

The table below shows a summary of regulated procurements that were completed by Renfrewshire Council during the financial year 2022/23. A regulated procurement is any procurement for public supplies or services with value of over £50,000 and for public works with a value of over £2 million where an award notice has been published, or where the procurement process otherwise comes to an end. This includes contracts and framework agreements.

This summary demonstrates the Council's commitment to working in a transparent manner by highlighting the procurement activity that has taken place over the past year.

Section 2 – Review of Regulated Procurement Compliance

Section 18 of the Act requires that the Annual Procurement Report should include a review of whether Regulated procurements carried out in the Financial Year complied with the authority's procurement strategy.

Section 3 of the Council's Procurement Strategy sets out Strategic Priorities for Procurement in Renfrewshire Council and Section 8 of the Strategy confirms how procurement will monitor and review compliance and how progress with the strategic outcomes will be reported.

The key actions set out in the corporate procurement strategy were incorporated into the Chief Executives Service, Service Improvement Plan. This Plan is updated every six months and presented to the Council's Finance, Resources and Customer Services Policy Board. From 1 April 2023, the key actions will be reported in the Finance & Resources Service Improvement Plan.

The original Action Plan included within the Procurement Strategy provides the core indicators against which the performance of the Procurement team is monitored.

Table 3 below provides an update on progress with the Action Plan within the Financial Year 2022/2023.

Provide strategic guidance and leadership on all Procurement matters;	The Corporate Procurement Manager provided procurement leadership, guidance and advice on all procurement related matters, through meetings, working groups, Policy Boards, strategic project boards, the Corporate Management Team and representation on wider public sector forums. The procurement Category Managers engaged closely with their client service departments, providing expert input to help the Council deliver its strategic objectives in full compliance with the Procurement Regulations. Procurement in Renfrewshire Council is conducted in accordance with Regulation and the Council's
	Standing Orders Relating to Contracts. The Standing Orders are available online and provide clear, concise guidance for all staff.

Support the Council to ensure it continues to achieve value for money and work with stakeholders to help achieve efficiency savings; Through active participation in front line project teams and by adopting a proactive and commercial approach to supplier management the procurement team ensured that value for money was achieved throughout this financial year.

The Corporate Procurement team worked in partnership with the frontline services to understand and support the demand for products and services and worked collaboratively with suppliers to ensure that products remained available, and that pricing remained reasonable. Market conditions, demand for products and price fluctuations were closely monitored and this informed the buying strategy throughout.

Ensure the Council explores all opportunities to use its procurement activities to promote its wider policy objectives, including its social, economic and environmental objectives;

Procurement in Renfrewshire Council has a very strong focus on Sustainable Procurement and the Council's procurement led Community Benefits Forum continued to work in partnership with Invest in Renfrewshire, key internal stakeholders, suppliers and external partners to support the delivery of positive community benefits throughout Renfrewshire in the financial year 2022/23.

Community benefits were requested in all Regulated Procurements tendered under the Council's own terms and conditions of contract in this financial year and where appropriate and feasible in all below threshold procurements. [Note – some collaborative framework agreements established by other Contracting Authorities did not include Community Benefits]

During this period, the Procurement Manager continued to work closely with colleagues from Economic Development to promote Community Wealth Building in Renfrewshire. The Community Wealth Building Core Group provides a collaborative forum for procurement and economic development to plan and deliver a series of initiatives which promote Community Wealth Building and sustainable, inclusive economic growth in Renfrewshire.

On 29 November 2022, the Corporate Procurement and Economic Development teams co-hosted an event at Johnstone Town Hall providing a series of

informative presentations for local businesses about how to do business with Renfrewshire Council. The Supplier Development Programme provided input and an overview of the support available to Scottish suppliers to help them navigate the electronic tender processes used by the Public Sector in Scotland.

Fair Working Practices are a core priority for the procurement team, supporting the Council's ambition to create a fair Renfrewshire, enhance wellbeing across communities and build an inclusive and resilient economy. Fair Work Practices were evaluated in all relevant tender exercises and all of our suppliers are actively encouraged to support their workforce and to pay at least the Real Living Wage rate to all employees engaged in delivery of services to Renfrewshire Council.

Tackling the Climate Emergency is an area of focus for the Corporate Procurement team, who are providing active support to services to help the Council with its ambition to work towards being Carbon Net Zero by 2030.

Using all relevant tools and support available, the team seeks to identify opportunities for sustainability throughout the whole commissioning cycle.

Promote ethical procurement and work with our suppliers to ensure that they do not use exploitative labour;

During the financial year 2022/23 all tenders were evaluated in accordance with the requirements of legislation, statutory guidance and good practice. The Corporate Procurement team supported the Council's commitment to the Modern Slavery Charter and all Works contracts provided a link to the Council's Statement in Relation to the Procurement of Construction Contracts (the Construction Charter), which promotes fair and ethical treatment of the workforce and supply chain.

Develop and strengthen our approach to risk management;

Risks and issues were identified and documented throughout all procurement processes. All risks were allocated an owner and mitigating actions were set out in contract strategies.

Commodity risks were recorded both within the team and at wider Council level by Council's Risk Manager.

The Corporate Procurement Manager is a member of the Construction Contracts Oversight project board, providing procurement support and advice relating to managing procurement risks associated with construction contracts.

Engage effectively with stakeholders when developing our strategic commissioning and procurement plans; Throughout the year the Corporate Procurement team worked in partnership with colleagues from across the Council to develop procurement and commissioning strategies.

Continue to develop and improve the Council's procurement processes and support their effective adoption across the Council;

Throughout the financial year 2022/23 the Corporate Procurement team promoted a compliant, innovative, informed and inclusive approach to procurement. They continued to engage closely with Scotland Excel, the Centre of Expertise for Local Authority Procurement, and a number of Scottish Government procurement policy working groups to ensure that procurement in Renfrewshire Council continues to meet all statutory requirements.

Support the development and growth of local SMEs, third sector, social entrepreneurs and supported business; The Corporate Procurement Strategy set out an ambition to work closely with local and national business representatives and to actively engage with third sector and community partners and Economic Development to explore opportunities for developing and growing Renfrewshire's local SMEs, third sector organisations and supported businesses.

Procurement and Economic Development identified shared opportunities to support Community Wealth Building in Renfrewshire and formed a Community Wealth Building core group to drive our ambitions to actively encourage local businesses to engage with Council procurement processes. This Core Group continues to meet regularly and to drive our Community Wealth Building agenda.

The in-person Supplier Event held in Johnstone Town Hall on 29 November 2022 called "Doing Business with Renfrewshire Council" provided a range of relevant links for local businesses including:

- Access to up-to-date information about Council spend / contracts and procurement contacts;
- Access to local business support;

- Information about Net Zero and Business in Renfrewshire;
- An overview of Business Gateway Services; and
- Support available from the Supplier Development Programme

Ensure the Council meets the requirements of the procurement Regulations and the fundamental principles of non-discrimination, transparency and proportionality and actively seek to utilise the new flexibilities introduced to introduce innovative procurement approaches that can support the Council to achieve its objectives.

All procurements undertaken during the period 2022/23 complied with legislation and Statutory Guidance.

The Single Procurement Document was used for all procurements, including where appropriate and proportionate, under £50,000 procurements;

The Councils processes and procedures were fully aligned to the Scottish Government Procurement Journey, ensuring good governance and due diligence at all key milestones;

All Regulated tendering opportunities were advertised via the Public Contracts Scotland Suppliers Portal and tenders above the GPA Threshold were also advertised via the Find a Tender Service.

Section 3 – Summary of Sustainable Procurement Benefits

Community Benefits Summary

Renfrewshire Council identified one of its key objectives to be the exploring of 'all opportunities to use its procurement activities to promote its wider policy objectives, including social, economic and environmental objectives' in the Procurement Strategy. The importance of this was further emphasised by the active promotion of including community benefits clauses in tenders for all regulated procurements where possible, and where appropriate and feasible in un-regulated procurements too.

The inclusion of community benefits in tenders and the work of the Community Benefits Forum is a key enabler to support delivery of the objectives of the Council Plan, Renfrewshire's Community Plan and No One Left Behind.

Community Benefits make a real difference to the lives of people in Renfrewshire, helping communities, community groups, schools and individuals. Working together with our colleagues in the community benefits forum and our contractors, we aim to continue to maximise the social value that community benefits can bring.

Once a contract is awarded, the community benefits forum works closely with the Council's procurement officers to co-ordinate and support the delivery of community benefits. Forum members include officers from the Council's Economic Development Team, Invest in Renfrewshire, Childrens Services, and our third sector interface Engage Renfrewshire. As well as monitoring the delivery of community benefits in existing contracts, the forum is a platform to share new Contract Strategies and identify new opportunities for the delivery of community benefits.

The forum has significantly contributed to partnership working with providers, developing supplier capacity, local skills and employability by:

- Encouraging participation in Meet the Buyer events, attendance at workshops supported by Engage Renfrewshire and supporting the Chamber of Commerce mentoring programme;
- Supporting supplier development through the Supplier Development Programme, setting up supplier mentoring sessions and helping small businesses to identify new contract opportunities;
- Supporting school employability programmes helping school leavers to achieve positive destinations through education, employment and training;
- A free vacancy management service provided to advertise employment and work experience opportunities through Invest in Renfrewshire via Twitter;
- Providing opportunities for providers to meet and engage with potential candidates interested in vacancies associated with delivery of contracts.

Provided in Table 4 below is a summary of the community benefit requirements included as part of Renfrewshire Council's regulated procurements over the last financial year.

Highlight – during this period community benefits delivered the following benefits to individuals based in Renfrewshire:

- 24 new jobs
- 19 new apprenticeships
- 39 Work Experience placements
- 81 new Qualifications
- 145 community benefits in other categories.

Community Benefits Case Study

Paisley Town Hall

In March 2021 Renfrewshire Council awarded a contract for the refurbishment of Paisley Town Hall to Galliford Try Construction Limited, trading as Morrison Construction. The vision for the refurbished Paisley Town Hall was "to create a flagship venue for Paisley, Renfrewshire and West Central Scotland, enriching contemporary civic and cultural life". The refurbishment of the Grade A listed building was a key element of the plan for the longer-term regeneration of Paisley Town Centre and the community benefit strategy developed for this contract reflected these objectives.

Morrison Construction, in partnership with their sub-contractors and supply chain delivered:

 Six new on-site jobs, including employment for individuals who live locally in SIMD 1 / 2 areas; Three new Graduate apprenticeships plus a number of Modern Apprenticeships delivered by both Morrison Construction and their subcontractors:

- Eight new SVQ qualifications for sub-contractors staff on site at Paisley Town Hall;
- Business advice and support to SMEs working on the site;
- Ten work experience placements for local young people from Renfrewshire, supporting young people with real life experience in trades on site and helping them with advice on their career pathway;
- Morrison Construction are a strong supporter of My Future Pathway into Construction and through this programme, over 20 local young people from Renfrewshire schools were offered a place on the year-long programme. This provided support with learned skills and experiences, site tours, trade talks, employability support and work experience;
- In May 2022, in collaboration with the Paisley Townscape Heritage
 Conservation Area Regeneration Scheme, Renfrewshire Council and West
 College Scotland, Morrison Construction invited over 200 pupils from 12
 Renfrewshire schools to a Traditional Build Event. This provided pupils with a
 tour of the construction site and an opportunity to undertake practical learning
 experience to provide examples of future career pathways. This included an
 insight into trades such as: stonemasonry, painting, slating, leadwork,
 traditional wood turning, roof slating techniques, and painting and decorating;
- Morrison Construction and their sub-contractors also provided financial and non-financial support to local community groups worth £42,488, including donation of a stage to PACE.



Summary of Sustainability Benefits and benefits incorporated to tackle climate change

Renfrewshire's Plan for Net Zero

Our plan for net zero commits the Council to taking a leadership role to deliver our ambitious plans to be net zero on carbon emissions by 2030. More information about the plan for net zero is available online here:

The plan recognises that the Council only contributes about 2.5% of the total emissions in Renfrewshire however it also identifies a number of key ways in which the Council can seek to reduce our emissions, including:

- Targeting the energy efficiency of Council owned property and assets;
- · Reducing waste;
- Electrifying the vehicle fleet; and
- Increasing energy security and resilience.

Procurement has a key role to play in supporting the Council with the delivery of its net zero objectives. Funding received from the Climate Change Action Fund helped to ensure that the full Corporate Procurement team had access to a dedicated resource,, who established a framework for training and development to support embedding sustainable procurement in all of our practices.

The whole team have completed Climate Literacy e-learning and have also benefitted from additional support and input from internal and external experts to encourage new ways of thinking and to challenge the team to focus on sustainable solutions.

Every contract strategy considers all opportunities for embedding sustainability and how impacts should be measured. Our objectives are aligned to the Council's priorities and Table 5 below includes a list of contracts awarded in the financial year 2022/2023 which help to support the priorities of the Plan for Net Zero.

As well as the sustainability gains from the nature of these strategic projects, requirements built into contracts have helped support the Council's sustainability goals. Please see details below of regulated procurements awarded in this reporting period that include sustainability gains and contribute to Council priorities.

Highlight

Paisley Grammar School and Community Campus

In the financial year 2022/23 the Council awarded a number of contracts relating to the construction of a new Paisley Grammar School and Community Campus. The project is part funded by the Scottish Futures Trust (SFT) within the Stage 2 Learning Estate Investment Programme (LEIP). The LEIP metrics set out specific targets and outcomes which must be achieved to ensure that the project delivers a high quality, sustainable, low carbon and digitally enabled learning environment.

The outcomes include ambitious energy targets and a requirement to support inclusive economic growth in Renfrewshire.

The school and community campus will be built to Passivhaus standard which means that the building will be ultra-low energy and support Renfrewshire's response to the climate emergency.

Section 6 – Future Opportunities

Community Wealth Building ~ Progressive Procurement

Renfrewshire Council's Plan for the period 2022 – 2027 sets out the Council's ambition to build an inclusive, green and resilient economy.

Actions include:

Delivering a Community Wealth Building approach to a wellbeing economy in Renfrewshire - supporting local enterprises and the development of local assets, ensuring how we spend our money benefits Renfrewshire's communities and supports just labour markets and the progressive procurement of goods and services

Progressive Procurement is one of the 5 pillars of Community Wealth Building. Our aim is to build capacity in our local supply chain to enable more local businesses to access public sector tendering opportunities both as direct suppliers and subcontractors.

As an indicator of past performance and to establish a baseline for improvement, procurement have taken *Indicator ECON04 – Proportion of procurement spent on local enterprises* from the Local Government Benchmarking Framework 2021-22 data published by the Improvement Service.

(https://www.improvementservice.org.uk/benchmarking/explore-the-data/local-government-professionals)

In the financial year 2021/2022 across Scotland the average percentage of procurement spend with local enterprises was 29.9%. The "Family Group" average for the area was 22%.

[The Local Government Benchmarking Framework (LGBF) uses 'family groups' to allow local authorities to compare themselves with other councils with similar characteristics. Renfrewshire's family group for economic development indicators is Angus, Clackmannanshire, East Renfrewshire, Inverclyde, Midlothian, South Lanarkshire and West Lothian.]

In Renfrewshire, the spend with local enterprises in 2021/22 was 18.9%. This highlighted an area for improvement and demonstrated a need for Renfrewshire Council to work to increase its spend with local businesses.

The Corporate Procurement team in Renfrewshire Council have already established a positive working relationship with the Council's Economic Development team. Together both teams have been actively promoting opportunities for Community Wealth Building, in particular a desire to increase local spend not just with the Council but with the wider public sector.

Our approach to development of capacity across our local business community requires to be conducted in accordance with the general principles of procurement, but also aligned to our objectives to improve access to council contracting opportunities for local businesses.

Analysis of Council spend identified an opportunity to increase access to contracts which are below the Regulated thresholds of £50,000 for Goods and Services contracts and £2 million for Works Contracts.

In the financial year 2022/2023, over £75 million worth of contracts were let by Renfrewshire Council below the Regulated procurement threshold. This provides a positive opportunity to localise the impact of our spend. To support our ambition to develop local supply chains we have increased the threshold up to which Council services can procure from £10,000 to £24,999. The Guidance Note attached to our Standing Orders Relating to Contracts will be updated to provide information to services about how to access "Supplier Finder" via Public Contracts Scotland and how to identify local businesses when seeking quotes.

The update to our Standing Orders Relating to Contracts in June 2023 also included increasing the threshold for the use of Quick Quote for Works contracts up to £500,000 with a requirement that where possible, a minimum of 75% local businesses should be invited to quote.

Opportunities for local businesses to access public contracts as suppliers and subcontractors will also be prioritised in the coming year. Community Benefit clauses included in our Regulated procurements include Supply Chain Development community benefits. Contractors are encouraged to promote supply chain / subcontract opportunities through events targeted at businesses based in Renfrewshire.

Whilst a focus on improving ease of access to opportunities is important, the Corporate Procurement team is also keen to increase levels of face-to-face engagement with local suppliers and to help suppliers overcome some of the barriers they face.

To support this objective, the Corporate Procurement team and the Economic Development team have hosted two in-person events for local businesses, the first in Johnstone on 29 November 2022 and the second in Tweedie Hall, Linwood on 18 April 2023. Both events were well attended and highlighted a genuine interest in public sector tendering opportunities across the Renfrewshire business community.

Feedback from the April event will help to inform our future agendas for market engagement events. Suppliers have asked if future events could include more opportunities for suppliers to network. They also asked for more information about support available to help small local businesses grow, including support with recruitment, apprenticeships and business processes.

The next market engagement will take place in the on 11 October 2023. This event will include representation from NHS Greater Glasgow & Clyde, the University of West of Scotland and Scotland Excel.

Sustainable Procurement ~ "Green – leading Renfrewshire to Net Zero"

Renfrewshire Council is "committed to working towards net zero by 2030 for the whole of Renfrewshire to ensure a safer, healthier, greener and fairer place for everyone to live, work and spend time in."

Procurement has a key role to play in helping the Council to achieve our net zero ambitions by ensuring that sustainability is embedded into every stage of our procurement processes. The Corporate Procurement team utilise the Sustainable Procurement Tools to identify opportunities to build sustainability into all relevant tenders. Our strategy includes recognition that engagement with suppliers is critical to support the Council's drive towards net zero emissions by 2030.

By applying the new climate requirements of Question 4C.7 to our Single Procurement Documents from March 2023, bidders will have an opportunity to highlight the steps that they have taken to build their awareness of the climate change emergency and how they will respond. This approach will encourage suppliers to share their practical knowledge and experience.

Questions included within our tender documents will invite ideas from suppliers offering climate focused solutions. Actions will form part of our approach to contract and supplier management, measuring progress and celebrating success.

We recognise the value that our suppliers bring to our contracts and our wider communities through good practice and innovation. For our future procurements we want to encourage creativity and to provide an opportunity for suppliers to innovate.

Renfrewshire has a number of key strategic projects that relate to sustainability including the construction of our first Passivhaus School and Community Campus, our Cultural Infrastructure Programme, our City Deal projects and our Housing Regeneration and Renewal Programme.

Highlight Case Study – Artificial Pitch Upgrades

The Project: Upgrade of Artificial Pitches at three locations in Renfrewshire.

The Budget: Approximately £300,000 per pitch.

The Objective: Installation of high quality artificial sport pitches.

The Challenge: Sustainability test identified significant risk related to the disposal of

the existing materials.

The Mitigation: The tender required that all bidders should submit detailed

information relating to the reuse, repurpose, and disposal of

existing materials.

The Outcome: The supplier for the initial contract committed that 95% of used

materials will be re-used or recycled, including the diversion of existing shock pads from specialist landfill to be recycled and used

in all-weather outdoor arena surfaces.

The supplier for the subsequent two contracts committed to adopt a hierarchy of Reduce, Re-use and Recycle as a guiding principle in line with Scotland's Zero Waste Plan. Waste reduction measures included ensuring that material take-offs are accurate, ordering of materials are timely and material suppliers consider only essential packaging as well as working with their supply chains to ensure that off-cuts are kept to a minimum when detailing their installation schematics. Where there is unavoidable waste, local re-use networks such as The Community Resources Network and the Construction Material Exchange were used. To foster a culture of zero waste, regular onsite Toolbox Talks were planned to ensure that staff know how to reduce, re-use and recycle waste on site.

Future Opportunities - Projects

Housing Regeneration And Renewal Programme

Renfrewshire Council is embarking on an ambitious programme of investment in Housing Led Regeneration and Renewal in Renfrewshire. The investment of at least £100 million over a ten-year period will deliver modern, high quality, energy efficient, affordable Council housing that will not only significantly enhance the Council's housing stock but will also contribute to the wider transformation of communities and will be central to the economic and social recovery of Renfrewshire.

Contract requirements will include demolition of existing properties, building of new homes and associated design services, retrofit and refurbishment of existing properties, environmental works and construction consultancy services.

Tendering opportunities will be advertised via Public Contracts Scotland and the Find a Tender service. All contractors will be encouraged to advertise sub-contracting opportunities locally.

The Glasgow City Region City Deal

The £1.13bn Glasgow City Region City Deal (GCRCD) is an agreement between the UK Government, the Scottish Government and eight local authorities across the Glasgow City Region.

This City Deal will fund major infrastructure projects; create thousands of jobs and assist thousands of unemployed people back into work; improve public transport and connectivity; drive business innovation and growth and generate billions of pounds of private sector investment.

Renfrewshire Council is the lead authority on two City Deal Projects. Construction on the Glasgow Airport Investment Area completed in 2022.

Clyde Waterfront & Renfrew Riverside (CWRR)

The CWRR project includes the construction of a new opening bridge across the River Clyde, which will accommodate vehicles, pedestrians and cyclists, and the construction of the Renfrew North Development Road to better link communities and businesses on both sides of the river.

Construction began early 2022 and will complete in 2024. There may be sub-contracting opportunities available through the main contractor and information on these opportunities may be found on the Public Contracts Scotland website: https://www.publiccontractsscotland.gov.uk

The procurement of a specialist bridge maintenance contractor is anticipated to commence early 2024. More information will be published on Public Contract Scotland in due course.

AMIDS South

The Council has been successful in obtaining £38.7m of Levelling Up Funding from the UK Government for the AMIDS South Project. The AMIDS South project will provide a gateway route from Paisley town centre along Abercorn Street, Harbour Road and Inchinnan Road to Glasgow Airport and the manufacturing district AMIDS, includes new cycle routes and landscaping as well as a bridge crossing at Paisley Harbour for pedestrians, cyclists and road traffic. Also included is an east-west road link from Renfrew Road joining onto the new route, increasing connectivity to the manufacturing district and improving accessibility to the proposed new Paisley Grammar community campus, West College Scotland, Gallowhill area factory and businesses in the Abercorn area. Traffic calming works on Love Street will improve the environment for local residents and pedestrians, the area benefiting from a reduction in traffic flow due to the new routes. The project also includes measures to improve walking and cycling along Greenock Road between Inchinnan Business Park and AMIDS.

The procurement of a Main Contractor for the construction of the AMIDS South project is anticipated to commence early 2024. More information will be published on Public Contract Scotland in due course.

The Council has secured grant funding from the Transport Scotland Active Travel Transformation Fund to deliver active travel route improvements throughout Renfrewshire. Some of this funding will be used to deliver the Gallowhill Link, an early element of the AMIDS South project. The Gallowhill link is a short extension to the southern end of the Paisley to Renfrew active travel route using a section of the disused railway line to connect the cycleway to the Gallowhill area of Paisley, passing under Renfrew Road at the existing road bridge at the north end of the Renfrew Road retail development. The procurement of a contractor to construct the Gallowhill Link is anticipated to commence in October / November 2023. More information will be published on Public Contract Scotland in due course.

Cultural Infrastructure Projects

In collaboration with a range of partners, the Council has been implementing a cultural led economic regeneration programme within Paisley town centre. The current phase of the programme was approved by Council in September 2017, with £100 million investment to progress the delivery of the long term strategic regeneration agenda for Paisley town centre. These investment proposals address

major lifecycle maintenance needs in key assets, as well as directly supporting improvements and modernisation of cultural venues and town centre infrastructure.

Projects include:

Paisley Museum - a £42 million transformation into an international-class destination showcasing the town's unique heritage and collections, predicted to bring around 125,000 visitors a year into the town centre.

The main build works are underway, due to complete Spring 2024. The procurement of supply, delivery and install of AV Hardware, supply and delivery of furniture and fittings, the kitchen / café fit out and shop fit out are due to commence Autumn/ Winter 2023. More information will be published on Public Contract Scotland in due course.

Public Realm - Abbey Quarter: this project will change the layout of the public space in Abbey Close outside Paisley Town Hall, expand the space into the current grass area, make the riverside area more accessible and offer public realm space on Cotton Street. The procurement of a main contractor to carry out these works is anticipated to commence in early 2024. More information will be published on Public Contract Scotland in due course

Now complete / nearing completion:

Paisley Town Hall - a £22 million internal refurbishment to become one of the landmark entertainment venues in the West of Scotland.

Paisley Learning and Cultural Hub - a fully accessible and digitally connected space housing the town's library collections and a modern educational resource for the area's pupils, students and adults in the heart of Paisley High Street.

Operations & Infrastructure

Renfrewshire Council have committed to invest in infrastructure projects to support growth throughout Renfrewshire. Future opportunities within this area will be advertised on Public Contracts Scotland and will include:

Provision of Lift Maintenance Services: The future tender will include for the inspection, servicing, reactive and emergency repairs to passenger lifts throughout the Councils estate.

Red Smiddy Phase 3a Barnsford Road: Improvements to existing Non-Motorised User (NMU) travel provision to provide a high quality, shared use, segregated two way cycle/ pedestrian track located from the end of the existing Glasgow Airport cycle route at St James Interchange to the A726 / Inchinnan Drive / Barnsford Road roundabout. The proposed works involve widening of the existing Northbound footway to form a shared footway & cycleway. Tactile paving will be installed at uncontrolled crossings. Some localised drainage works will also be required.

Linside Link Paisley – Construction of an active travel route in Erskine following external design works to provide link from new housing development on Hawkhead Road to Seedhill Road including Hawkhead Train Station and Schools.

Bus Shelter Advertising: This contract will include approximately 200 advertising shelters and the cleaning and maintenance of a further 200 non advertising shelters.

Adults And Children's Services

A new Flexible Framework Agreement for Care at Home Services will be tendered in 2024 to replace the current framework agreement within the next 12 – 24 months. The Flexible Framework will be used by Renfrewshire Health and Social Care Partnership (RHSCP) to purchase services which will support people to live independently in their own homes for as long as possible with care and support packages tailored to individual needs.

The current Supported Living contracts are due to end on 30 June 2024, Renfrewshire Health and Social Care Partnership are keen to partner with more Registered providers of Supported Living with services located in Renfrewshire.

The current contract for Technology Enabled Care Alarm Receiving Service contract expires on 1/8/2024. A tender for renewal of this service should be issued by the end of this year to be awarded in May 2024.

A tender for Community Based Mental Health Services will be released later this year.

The current flexible framework for the provision of Early Learning and Childcare Services will be re-opened in October 2023 for award by March 2024.
