RECORDING OF MEETING

Prior to the commencement of the meeting, the Chair intimated that this meeting of the Local Partnership would be recorded and that the recording would be available to watch on the Council's website.

DECLARATIONS OF INTEREST

Iain McMillan (Johnstone Community Sports Complex) declared an interest in item 4 – Applications for Local Partnership Funding to Johnstone and Linwood Local Partnership 2020/21 - FR1144 – as he was related to a member of the organisation.

Councillor Mackay declared an interest in item 4 – Applications for Local Partnership Funding to Johnstone and Linwood Local Partnership 2020/21 - FR1118 – as he was a member of the organisation and indicated that he would remain in the meeting but not take part in discussion of voting thereon.

George MacDonald (Corseford Tenants' and Residents' Association) declared an interest in item 4 – Applications for Local Partnership Funding to Johnstone and Linwood Local Partnership 2020/21 - FR1180 – as his organisation had benefitted from activities provided by the applicant.

1 MINUTE

2 BUDGET MONITORING REPORT AND 2020/21 FUNDING APPLICATION FEEDBACK

There was submitted a report by the Chief Executive relative to the final budget position for this Local Partnership for 2020/21 together with feedback from groups awarded funding during 2020/21 detailing how their awards had been utilised and had benefitted the local community.

<u>DECIDED</u>: That the budget monitoring report and feedback from recipients of funding in 2020/21 be noted.

3 ELIGIBILITY OF APPLICATIONS FOR LOCAL PARTNERSHIP FUNDING AND OPTIONS FOR APPLICATION OF CRITERIA TO ASSIST DECISION MAKING

Under reference to item 5 of the Minute of meeting of this Local Partnership held on 2 February 2021 there was submitted a report by the Chief Executive relative to the eligibility to apply for Local Partnership funding and the potential to apply criteria to assist in making decisions on funding applications.

The report included a link to a guidance document which was available to all funding applicants which helped to ensure that applicants provided the information that Local Partnerships needed to make funding decisions.

The report identified the key criteria for assessing funding applicants as being how the applications fitted with the agreed local priorities for the area. Accordingly, applications for funding had been set out in the following item of business in terms of those applications with direct reference to Johnstone and Linwood local priorities located in or specific to Johnstone and Linwood; applications with direct reference to Johnstone

and Linwood local priorities not located in or specific to Johnstone and Linwood; applications with partial or no reference to Johnstone and Linwood local priorities; and ineligible applications.

lain McMillan suggested that the key criteria be included as a standing item on all future agendas where grant funding was being considered. This was agreed.

DECIDED:

- (a) That the guidance provided to applicants, the presentation of the applications in meeting papers and the circulation of an allocation proposal in advance of this meeting be noted;
- (b) That consideration be given to the need for further criteria to be developed in future; and
- (c) That the key criteria be included as a standing item on all future agendas where grant funding was being considered.

4 APPLICATIONS FOR LOCAL PARTNERSHIP FUNDING TO JOHNSTONE AND LINWOOD LOCAL PARTNERSHIP 2021/22

There was submitted a report by the Chief Executive relative to applications for funding from The Villages Local Partnership in 201/22.

The report intimated that the available allocation for the Local Partnership was £48,203, made up of £47,044 from the General Grant Fund and £1,159 underspend carried forward from 2020/21. The carry forward of underspend was agreed due to the exceptional circumstances of the Covid pandemic which impacted on the ability of community organisations to undertake activities due to restrictions in place over the period. The normal arrangement whereby underspends could not be carried forward into the next financial year would be reinstated for 2021/22. The sum of £50 per community representative required to be ringfenced for potential claims for administrative expenses, which left a balance of £47,503 for allocation.

The report advised that the Youth Challenge Fund component of the Local Partnership's funding, now known as Celebrating Renfrewshire, was £21,697. This would be allocated by young people through a participatory budgeting process, which would take place during autumn 2021.

TITLE:

Eligibility Of Applications For Local Partnership Funding And Options For Application Of Criteria To Assist Decision Making

1. Summary

- 1.1 Johnstone and Linwood Local Partnership received a report at the meeting held on 22 June 2021 regarding eligibility of applications for Local Partnership funding and options for the application of criteria to assist decision making. It was agreed at this meeting that this information be included as a standing item on Johnstone and Linwood Local Partnership papers
- 1.2 A guidance document is available to applicants to Local Partnership regarding eligibility (see link below). The guidance seeks to ensure that applicants provide the information that Local Partnerships need to make funding decisions, including alignment with local priorities and how the local community benefits.

- 1.3 The key criteria for assessing funding applicants is fit with the agreed local priorities of each area. Local Partnerships also have flexibility to determine for themselves a methodology for determining grant allocations. Examples of this include a cap on the maximum funding awarded, the award of funding requests in full up to a specified amount and requiring feedback on any previous awards made.
- 1.4 This presentation is intended to provide information to the membership about fit with local priorities and link to the Johnstone and Linwood area. Prior to the meeting, members will also receive separately a proposal from the Chair outlining an indicative allocation of funding, as a starting point for discussion at the meeting.

2. Recommendation

2.1 It is recommended that members of Johnstone and Linwood Local Partnership:

Note the standing item regarding eligibility criteria.

3. **Background**

- 3.1 Johnstone and Linwood Local Partnership has a set of local priorities for action. Community and voluntary groups are invited to apply for Local Partnership funding for projects that align to the local priorities. At the Local Partnership meeting on 2 February 2021, members raised issues regarding the following aspects of funding allocation:
 - Large organisations submitting Local Partnership applications, when national funding or raising their own funds might be an option.
 - Groups applying for general running costs.
 - The sustainability of groups seeking funding.
 - Application of criteria in relation to the purposes of the fund.
 - Whether Local Partnerships could be prescriptive in relation to groups applying for funding.
 - Potential conflict of interest if community planning partners apply for funding.
 - Public perception in granting awards to faith-based groups.
 - Scrutiny undertaken in relation to grant applications
 - Flexibility for Local Partnerships to limit awards solely to projects in the local area and any potential practical difficulties.
- 3.2 The guidance to applicants provides a response to many of the issues raised above. Any community or voluntary group with a constitution and bank account is eligible to apply, with the merits of the application considered by the Local Partnership. All applications should be specific to the Local Partnership area and clearly state the benefit to the community. Information is provided to applicants on sources of advice to apply for other sources of funding, including national funding.
- 3.3 Groups may apply for a portion of their running costs, but not their full running costs. The guidance also states that groups should consider any award as a "one-off" and that Local Partnership funds are not intended to provide ongoing funding. Applicants are advised to consider the sustainability of their project beyond the one-year funding term.
- 3.4 Applicants are advised to make clear how their project aligns to the priorities of each Local Partnership. Information on these priorities is also made available to applicants. This provides Local Partnership members with criteria against which to assess applications.

- 3.5 As Renfrewshire Council grants, applications are open to groups meeting the eligibility criteria. All applications from eligible groups are presented for consideration by the relevant Local Partnership. While Local Partnerships do not have the authority to be prescriptive about who applies for funding, they can commission projects to be delivered by named groups. Any such proposals require to be agreed by the Local Partnership members.
- 3.6 Community planning partners, with the exception of Renfrewshire Council, are eligible to apply for Local Partnership funding, but not for core activities. As with any applicant, community planning partners present at the meeting would require to declare an interest in any application and take no part in the discussion.
- 3.7 The guidance states that applications must encourage equality of opportunities. Faith-based groups may apply for activities open to the wider community, but not for purposes related to the faith itself.
- 3.8 Applicants are required to submit documentation in relation to their bank account and constitution when making an application for Local Partnership funding. Information on applications is presented in summary form in Local Partnership papers. Successful applicants are requested to provide feedback on projects at the end of the financial year.
- 3.9 Local Partnerships have the flexibility to use additional criteria such as locality in determining awards of Local Partnership funding. However, Local Partnership funding is the main source of funding available to community groups in Renfrewshire and members may wish to consider the potential impact on Renfrewshire-wide projects if funding was to be restricted to those operating from the local area. The requirement for groups applying to more than one Local Partnership area to make separate applications setting out the benefit to the local area was introduced to provide as much locally-relevant information as possible.

Fund Aims and Criteria

Promote and develop good mental health and wellbeing - protect against the impact of distress and mental ill health within the adult population

Tackle issues within the Scottish Governments Transition & Recovery Plan such as; suicide prevention, social isolation and tackling loneliness

Address the mental health inequalities exacerbated by the pandemic and the needs of 'at risk' groups – women, BAME, disability, socio-economic, bereavement, older people, LGBTI, geographic, refugees, trauma,...

Focus on supporting projects with a strong community focus - delivered by groups and clubs, voluntary or community organisations, registered charities, and not-for-profit company or Community Interest Companies.



Applications...

Appropriate 'light touch' application process to enable access to the fundsome guidance will follow but flexible to local processes

Amount of funding – expectations of some smaller grants (i.e. £10K and under) and flexibility to provide some larger grants (i.e. around £50k)

Potential for smaller amounts to Non-constituted groups

Monitoring, 'light touch' local suggestion of evidence gathering of programme's impact via experiences of participants, i.e. groups provide a story of change for participants, could be via photos, video, poetry, tbc

Scottish Government would like to see local application processes open to applications by 30th November – we intend to be going ASAP!

1. Summary

- 1.1 Johnstone and Linwood Local Partnership provides funding to community groups to undertake projects. This funding is allocated from the General Grant Fund and, through a Participating Budgeting exercise known as Celebrating Renfrewshire, the Youth Challenge Fund.
