#### 1. Summary

- 1.1 The Police and Fire Reform (Scotland) Act 2012 sets out that the main purpose of policing is to improve the safety and well-being of persons, localities and communities in Scotland. It ensures an enhanced focus on local delivery of policing with a designated local commander for each local authority area accountable for local service provision.
- 1.2 Each local commander is required to prepare a local policing plan that meets the needs of the local area and is approved by the local authority. In response to this the local authority has a statutory power to monitor the delivery of police services and to provide feedback to the local commander.



#### 2. Recommendations

2.1 The data within this report, which relates to the period 1st April 2016 to 2nd October 2016, is extracted from Police Scotland internal systems and is correct as of 2<sup>nd</sup> October 2016. The data is a year to date comparison with the previous year. It includes both recorded and detected crime data and covers all priority areas as set out in the local police plan. Members are asked to scrutinise policing performance for the period outlined and provide feedback where appropriate.

# 3. Background

3.1 The local commander is required to provide reports at an agreed timescale for scrutiny by elected members. Formal scrutiny of the Renfrewshire Police Plan falls under the governance of the Renfrewshire Police and Fire Scrutiny Sub Committee under the auspices of the Housing and Community Safety Committee (HACS) which meets five times per year. The information is contained at Appendix 1.

Complaints regarding disorder continue to be scrutinised daily by the partnership hub which comprises of social work, housing and education authorities. This joint engagement ensures that information is shared and that all agencies work together to help minimise disorder. Within the Renfrewshire Safer Communities team Officers frequently attend schools and education facilities to provide information and presentations on different aspects of disorder. Where anti-social behaviour is identified as a frequent problem, Officers are defaulted to patrol in this area to prevent further instances.

Hate crimes incorporate Homophobic, Disablist and Racial crimes with a high percentage being recorded against Police officers whilst on duty. All evidential avenues are thoroughly investigated to maintain this high detection rate. Increasing confidence to report hate crimes has become one of Police Scotland's high priorities and we work closely with the 'I Am Me' Charity who raise awareness of disability hate crime. We have also developed 22 reporting centres for hate crime in Renfrewshire along with a dedicated Safer Communities team, in addition to local community officers, all of whom actively work to tackle hate crime in all its forms.

## **APPENDIX "A" - AUDIT METHODOLOGY**

## Audit 1 - Crime Related Incidents and Associated Recorded Crime

The audit sample was selected from Command and Control incidents over a specific four day period



with initial call types CR-60 to CR-79 within the Crime category, and incidents with initial call types AB-57 Communications, AB-58 Hate Crime, PW-40 Domestic Incident and PW-76 Child Protection. The incident sample selected for audit ensured, working to a 95% confidence level with a confidence interval of \*/-3%, that the sample audited was statistically representative of all incidents of this type recorded during the four day audit period. A formula was applied to the total number of incidents per Command Area and apportioned out between Divisions in that Command Area in order to obtain sample sizes. These were subject to a minimum of 150 and a maximum of 300 per Division.

Compliance in each of the two Tests is achieved with a result of 95% or above.

The audit tested:

#### Test 1 - Crime Related Incidents

- That incidents initially inferring a crime or apparent criminal activity and closed as a non-crime contained a satisfactory narrative to eliminate any inference of criminality and fully justify a non-crime disposal.
- That each incident clearly indicated a crime or non-crime as a disposal on the incident text.
- Where an incident was closed as a crime, the corresponding crime record was traced.

#### Test 2 - Recorded Crime

 The correct application of SCRS on recorded crimes in respect of the Scottish Government Counting Rules and the correct classification of crimes. In terms of compliance with SCRS each individual crime over or under-recorded, or incorrectly classified was counted as having failed the audit.

#### Audit 2 - Recording of Specific Crime Types (Divisional Crime Audit)

To ensure that a number of different areas of crime recording are represented by Audit 2, samples were obtained from the following categories:

- Assault (Common Assault only)
- Group 1 Crime (Crimes of violence)
- Group 2 Crime (Sexual offences)
- Group 3 Crime (Crimes of dishonesty)
- Group 4 Crime (Damage to property)
- Other Crimes from Groups 5, 6 and 7

While not as statistically representative of all records within the audit period as Audit 1, the sample sizes in Audit 2 were weighted to take into account higher volumes of crime being recorded in some Divisions subject to a minimum of 100 records and a maximum of 300 records.

The audit tested the correct application of SCRS on recorded crimes in respect of the Scottish Government Counting Rules and the correct classification of crimes. In terms of compliance with SCRS each individual crime over or under-recorded, or incorrectly classified was counted as having failed the audit.

Compliance in this audit is achieved with a result of 95% or above.

#### Audit 3 - Crime Records Reclassified to "No Crime"



The third principle of SCRS states "once recorded, a crime will remain recorded unless there is credible evidence to disprove that a crime had occurred".

The audit tested the correct application of this principle in respect of recorded crime which was reclassified to "No Crime" following Police enquiry into the reported circumstances. In terms of compliance with SCRS each individual crime reclassified incorrectly was counted as having failed the audit.

The sample sizes in Audit 3 were weighted to take into account the higher number of records reclassified to "No Crime" in some Divisions subject to a minimum of 50 and a maximum of 100.

Compliance in this audit is achieved with a result of 95% or above.

In order to allow Divisions a reasonable period of time to ensure that records are complete and compliant with SCRS, audits are generally undertaken once a period of three months from the date of the incident/crime has elapsed. Any record incomplete at the time of audit will be audited based on the information available at the time.



#### <u>APPENDIX 'B' – LOCAL INITIATIVES</u>

Renfrewshire continue to promote partnership engagement within all possible areas of Policing. We prioritise promoting and educating safe practices, whether it be through safe driving, safe drinks promotions in licenced premises or educating Children and Young People on safe lifestyle practices. Some local initiatives we have been involved in for this reporting period include:

- Licensing seminar The Renfrewshire Festive Licencing Seminar took place within the function suite at 'the Little Steakhouse' in Sma'Shot Lane, Paisley. This event was opened by Chief Inspector Martin Gallagher in front of 60 attendees from the local licensing trade. Specialist officers from the Drugs Unit, Roads Policing, Crime Scene Management and Counter Terrorism delivered inputs and highlighted Police Scotland's focus on 'Keeping People Safe'. Partner agencies such as, Renfrewshire Council, Best Bar None and Paisley First all provided relevant inputs.
- 'Grey Space' Community This Community Tension monitoring meeting was developed and continues to numerous communities. This has brought together senior representatives from the Catholic Church; Church of Scotland; Local Mosque; Buddhist Community; West of Scotland Racial Equality Council; LGBT+; Polish Community; Create Paisley; the 'I Am Me' Disability Awareness Charity; West College Scotland; University of West of Scotland (including corporate, student body and academic research staff); Renfrewshire and Inverclyde Local Authorities; NHS; CHSCP; and Police Scotland. This group has a specific focus on addressing hate crime, and has met on a quarterly basis since establishment. It is undertaking a number of positive actions in support of awareness raising around hate crime in the area.
- Road Safety for Older Adults The Divisional Roads Policing Unit are running a road
  safety event for older adults in order to provide advice around responsibilities and direction
  agencies who can support them with concerns. These events were run in conjunction with
  numerous partners including Road Safety Scotland, local support services, Age Scotland,
  Alzheimers, NHS the feedback was very positive and focuses on an identified vulnerable
  group in terms or road safety.
- School Bus Road Safety DRPU are also running a check across the Division in conjunction with Strathclyde Passenger Transport and DVSA around school buses and their road worthiness. This has largely demonstrated a high level of compliance however there have been several vehicles that have been required to have been put off the road for safety reasons due to defects.
- Safer and Greener A Police lead multi-agency tasking group in Renfrewshire which includes statutory and third sector partners to develop the principles set out in the Building Safer Communities National Strategy of reducing victims of crime and unintentional harm through interventions in key communities to help them build capacity to resolve issues affecting their areas. Gallowhill is currently the focus of this initiative which began with an extensive consultation period with the community via a survey and focus groups to identify their main areas of concern. All partners have contributed to the action plan currently being implemented to address these concerns, with the police focus being on high visibility patrols after school and in the evenings to provide reassurance and regular advice and guidance to local residents around specific issues such as personal/internet/road safety and antisocial behaviour. It is envisaged that the community will take an active part in developing



solutions to some of the issues raised, supported by the Partnership to implement sustainable measures.

- **PSYV** The Police Scotland Youth Volunteers have been involved in leaftlet drops in areas that have been identified as being targeted by Bogus Workmen to help raise awareness. The Youth Volunteers have accumulated 109 hours volunteering for the month of October. Within this period they have attended numerous events in Renfrewshire including, Garden clean-up of Barshaw 'Peace' Gardens, Johnstone Town Hall Adult Protection Conference, Paisley Halloween Parade in partnership with Renfrewshire Council and many more.
- **Renfrewshire Special Constables** 3 new Special Constables were sworn in on Sunday 23<sup>rd</sup> October at Tulliallan and have all been active in their duties. There are now 31 Special Constables in all of K Division who have contributed 361 hours for October.
- **Johnstone Adult Protection Conference** An Adult Protection Conference was held within Johnstone Town hall. The local area commander for KB delivered an input on hate crime along with the 'I Am Me' project.
