There were no declarations of interest intimated prior to commencement of the meeting.

#### 1 MINUTE OF PREVIOUS MEETING

There was submitted the Minute of the meetin of the Renfrewshire Forum for Empowering Communities Group held on 3 December 2018.

**<u>DECIDED</u>**: That the Minute be approved.

#### 2 ROLLING ACTION LOG

The Rolling Action Log was submitted for approval.

#### 3 RENFREWSHIRE FALLS PREVENTION GROUP

C Robertson, ROAR updated the Group on the work of the Falls Prevention Group. She advised that the Group was made up of local government, health and third sector professional with the focus on preventing people from falling and strengthening their resistance. It was noted that leaflets had been produced with exercises and helpful information.

**DECIDED:** That the verbal presentation be noted.

#### 4 UPCOMING COUNCIL CONSULTATION

S Graham gave a verbal presentation on a new consultation which the Council was undertaking which was aimed at redefining the Council's values and its relationship with communities, partners and businesses. He advised that engagement relative to what communities wanted to see in their local areas and the relationship between the community and the Council would be developed. It was highlighted that staff engagement within the Council had commenced and would look at the values that supported a positive working environment to create the best possible conditions for staff.

**DECIDED:** That the verbal presentation be noted.

#### 5 LOCAL PARTNERSHIP UPDATE

There was submitted a report by the Chief Executive, Renfrewshire Council relative to an update on the Local Partnership meetings.

The report advised that seven Local Partnerships had been established to provide a focus for partnership working in localities to address priorities. The Partnerships would have greater involvement with community representatives and partner organisations, while retaining the function of allocating funding to local community activity. It was noted that the first meetings would take place between 19 March and 4 April 2019 and a programme of further meetings and events would be scheduled to take place during 2019/20. There then followed a discussion in relation to Local Partnerships, key strategies and priorities. L Devine, Save the Children advised that if communities were applying for

Greenspace Funding they would not be eligible if the projects were on Council land. It was noted that this would impact on future projects being developed by local partnerships and . It was agreed that

S Graham gave an update relative to activities taking place within partner organisation to celebrate Year of Young People. ## TITLE: Local Partnership Conferences 2019

#### 1. Summary

- 1.1 As reported to Renfrewshire Forum For Empowering Communities previously, the seven Local Partnerships are now in operation throughout Renfrewshire and are engaged during June 2019 in considering grant applications and allocating funding.
- 1.2 A series of Local Partnership conference events, one for each area, will take place during September 2019. Dates will finalised by the end of June 2019.
- 1.3 The conference events will be an opportunity for Local Partnerships to engage with the wider community and voluntary sector and with local people.

#### 2. Recommendations

- 2.1 It is recommended that Renfrewshire Forum For Empowering Communities:
- (a) Note that Local partnership conference events will take place during September.
- (b) Agree to support and publicise the events to encourage wide participation in the conferences.
- (c) Note the broad outline of the community conference events as set out in section 3.3.

#### 3. **Background**

- 3.1 Renfrewshire Community Planning Partnership regularly hold conference events attended by local residents, community groups, third sector groups, the private sector and the public sector.
- 3.2 Seven Local Partnerships have been established in Renfrewshire in 2019 and conferences in each area will enable connection to be built between the Local Partnerships and the wider communities in each area.
- 3.3 The 2019 conferences will focus on:
  - Local priorities for each Local Partnership area and how partners can work together to deliver these.
  - Activity taking place during 2019 in each Local Partnership area. This will
    include information about projects receiving Local Partnership funding in
    2019 and a look back at the impact of projects supported by the previous
    Local Area Committees.
  - Exploring how groups and organisations working within an area can work together to progress their own projects and support those of others. This will include opportunities to support organisations that applied for Local Partnership grants, but were not warded funding.
  - Informing Local Partnerships about the nature and extent of community activity within each area to build knowledge and understanding of current operation and future projects.
