#### **Order of Business**

Prior to the commencement of business, Councillor McNaughtan advised that it was his intention to change the order of business by taking item 3 – Heritage Trail Restoration - at the start of the meeting.

### 1 Heritage Trail Restoration

The Head of Economy & Development Services, Chief Executive's gave a presentation relative to the Heritage Trail Restoration project, highlighting a number of costed options relative to the enhancement of the trail including the replacement of modern lamp posts; the removal of graffiti; signposting the trail as a link from Gilmour Street to Paisley Museum; repairs; and the potential inclusion of the trail on the paisley is website. He advised that there were no plans to extend the existing CCTV network in the area.
