Chart 1: UK and overseas equities; 1 July 2010 to 16 November 2015

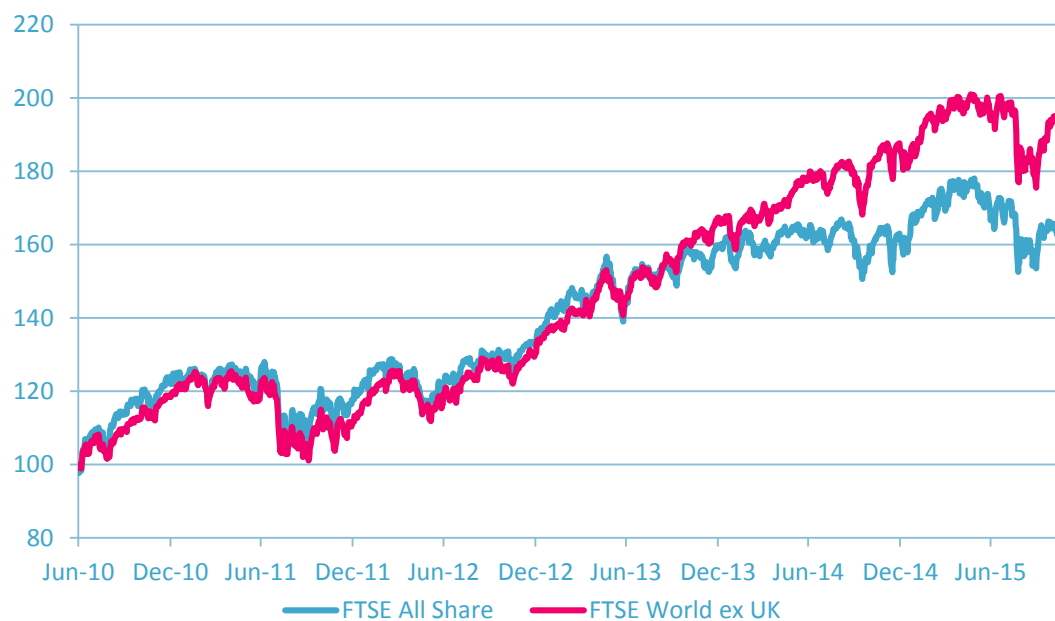


Chart 2: Equities versus Bonds; 1 July 2010 to 16 November 2015

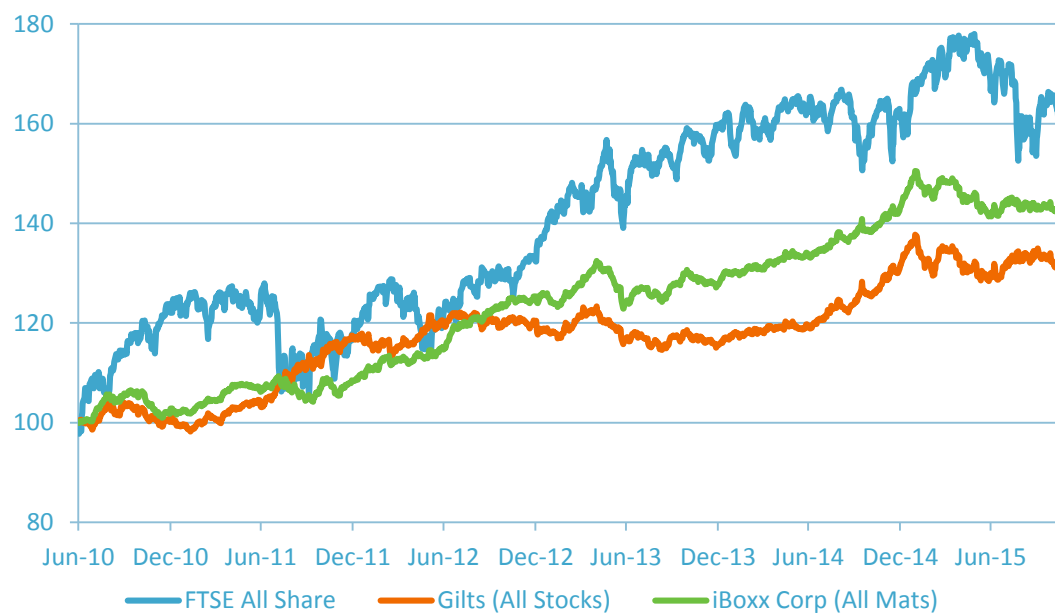


Chart 3: UK, US, Eurozone and Japan GDP; Q1 2008 to Q3 2015

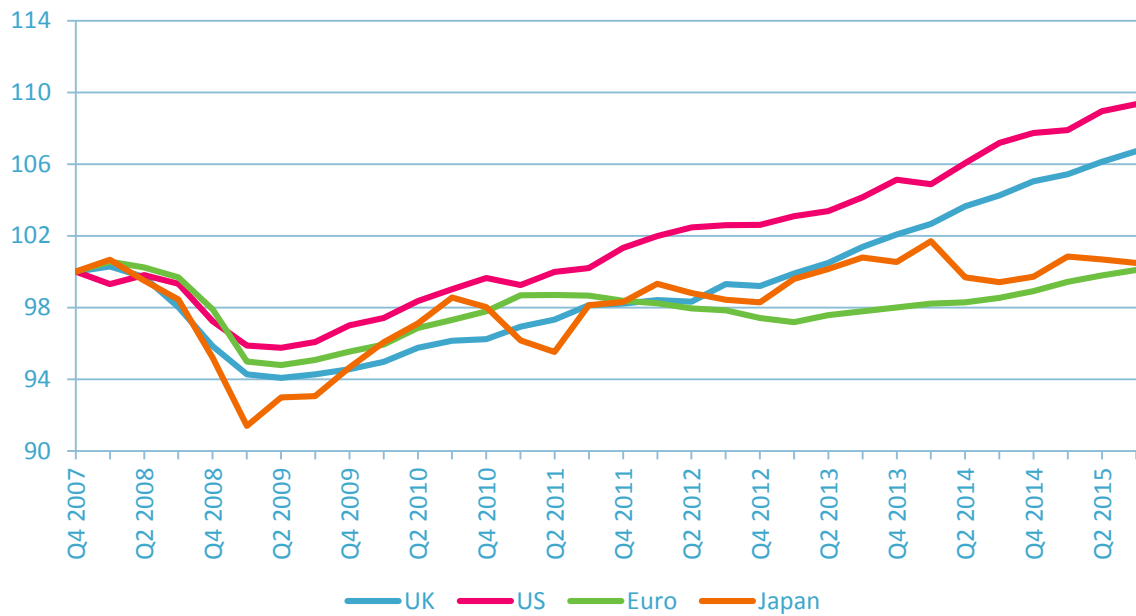


Chart 4: Global Equities – Value versus Growth; Q2 2006 to Q3 2015

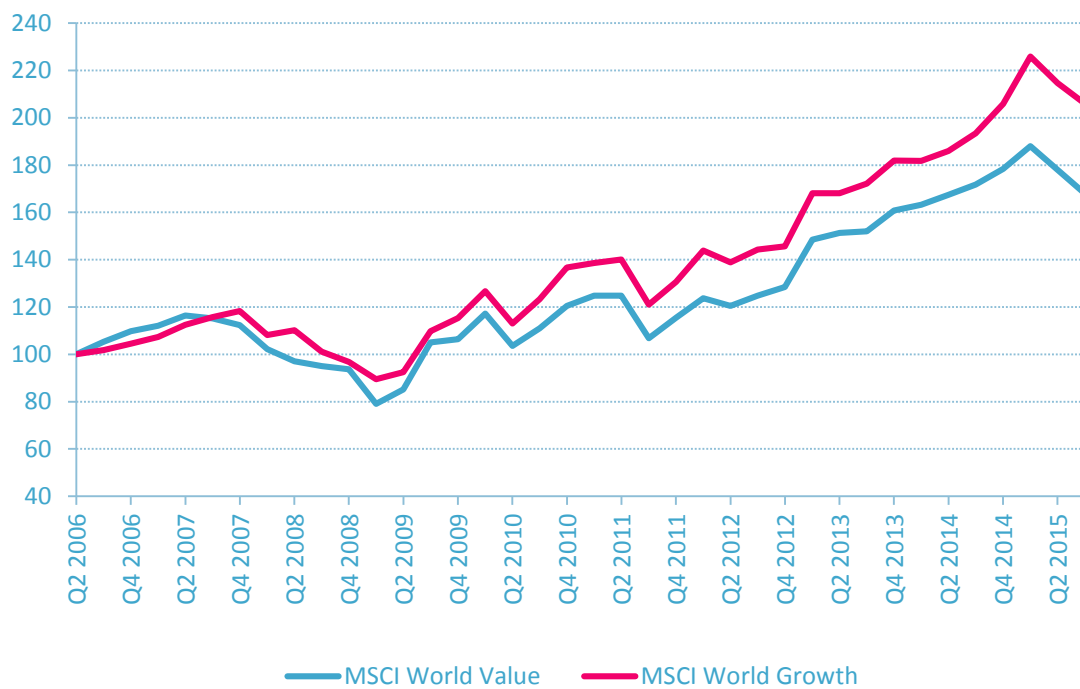


Chart 5: Headline CPI Inflation

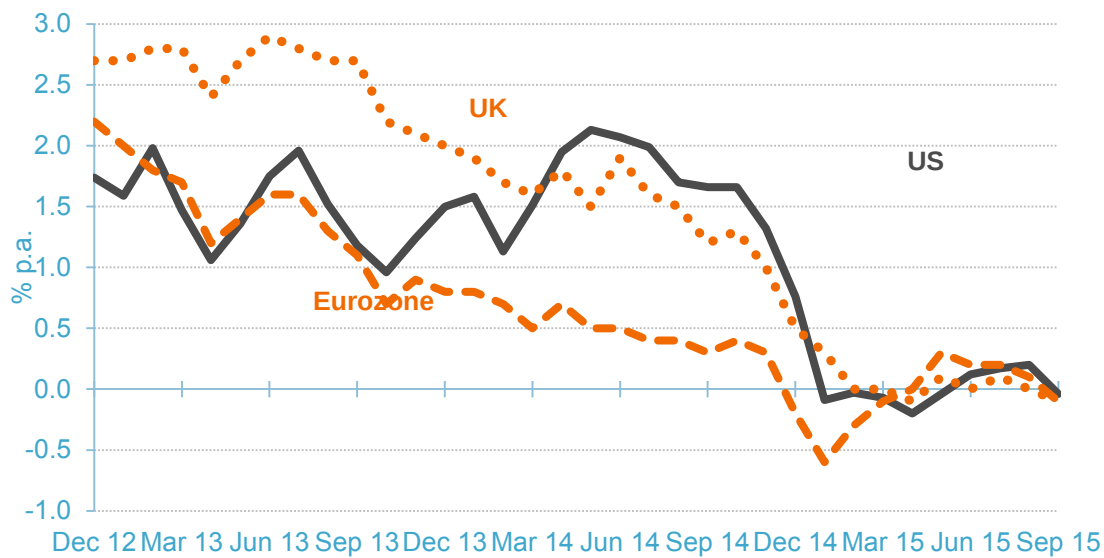
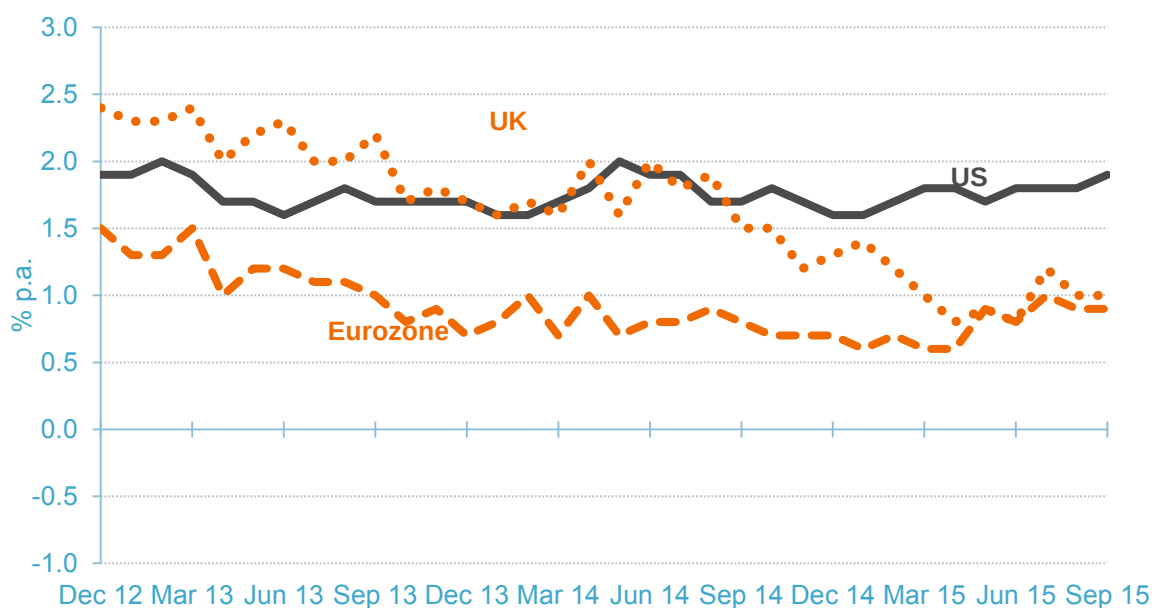


Chart 6: Core CPI Inflation
