Heading: Culture, Heritage and Events Fund

1. Summary

- 1.1 The purpose of this report is to seek approval from the Leadership Board for the award of grants selected from the second round of 2016 Culture, Heritage and Events Fund applications.
- 1.2 The Culture, Heritage and Events Fund has been designed to act as a significant building block in the development of Paisley's bid to become UK City of Culture in 2021. The total fund amount of £500,000 is intended to support relevant activities to support the bid from April 2016 and up to year 2021. This is the second of three rounds in 2016. A further three will be planned for 2017, during the UK City of Culture bidding period which is a critical time to demonstrate that the fund is unlocking creative potential and building cultural capacity in Renfrewshire.

2. Recommendations

- 2.1 It is recommended that the board:
 - i. note the high level of interest again generated in this second round of the Culture, Heritage and Events fund;
 - approve the grant awards as recommended by the Paisley 2021 Partnership Board, as detailed in Section 4 of this report to the total value of £128,396;
 - iii. note the status of the additional projects supported by delegated authority during at the first round of applications;

- iv. Note the need for the development and approval of a bespoke application form specific to the Culture, Heritage and Events Fund that supports the description and outputs of cultural and creative projects;
- v. Approve an amendment to the CHEF guidelines that will advertise the next funding round in December as outlined in paragraph 6.3.

3. Background

- 3.1 The Economy and Jobs Board of 18 November 2015 approved the establishment of a Culture, Heritage and Events Fund. The fund was launched on 8 February 2016 and applications were encouraged from individuals, businesses and networks that would help to develop capacity to support the ambitions of Paisley's UK City of Culture 2021 bid. The fund has been publicised via the Bid's creative and cultural networks, Creative Scotland website and social media channels. The deadline for submissions for the second round of grants was 1 August 2016.
- 3.2 Potential applicants received guidance on the aims, objectives and outcomes required to be successful for grant funding. Furthermore a clear evaluation framework was set out to allow assessment of applications received. These guidelines are attached as an appendix to this report.
- 3.3 The key objectives of the fund are to:
 - increase the number of people taking part in creative activity in Renfrewshire;
 - increase opportunities for young people to develop their creative ambition;
 - stimulate the local economy;
 - realise the potential contribution creativity can make to education, social inclusion and quality of life;
 - strengthen and broaden the network of people developing exciting cultural and creative projects and events in Renfrewshire;
 - increase the number of people visiting Renfrewshire; and
 - raise the profile of Renfrewshire throughout the UK.
- 3.4 The total fund amount of £500,000 is intended to support relevant activities to support the bid from April 2016 and up to year 2021. Three grant application rounds have been planned in 2016 and a further three in 2017, during the UK City of Culture bidding period which is a critical time to demonstrate that the fund is unlocking creative potential in Renfrewshire. The total amount of funds committed to projects to date is £217,830.

4. Second Round Grant Recommendations

4.1. Thirty six applications were received by the deadline date of 1 August 2016. The total value of requested grants to the second round of grants was £309,096. A specially convened assessment panel met on 18, 23 and 24 August 2016 to conduct an assessment of applications, and following consultation with the Paisley 2021 Partnership Board, 18 grant applications are recommended for approval in this round.

 - public benefit/audience
 - legacy opportunities
- 4.4 Subject to Board approval, the Bid team will now correspond with all applicants to provide feedback and where appropriate to encourage future applications.

5. Update on Additional Projects Supported by Delegated Authority (Round 1)

At the Leadership Board of 29 March 2016 delegated authority was given to progress a number of projects subject to satisfactory completion of the assessment process. The following five projects have now been approved.

6. Revisions to CHEF Application Guidelines

- 6.1 There have now been two rounds of funding deadlines which have resulted in observations and feedback from numerous applicants and assessing officers about how the application process can be simplified. Approval is sought to make adjustments to the guidelines and application form in advance of the next funding deadline. In particular to:
- 6.2 Introduce a bespoke application form rather than use the current generic Council grant form so as to make it easier for applicants to detail the specifics of their proposed cultural project and to describe their track record and their capacity to deliver their proposed initiative.
- 6.3 Amend the guidance to highlight that applications are encouraged in particular from communities that are underrepresented in the applications received to date e.g. BME communities and to draw attention to the specific art forms and types of cultural activities in which more applications are welcome such as projects that bring professional artists to work in community settings; projects that demonstrate the building of cultural capacity such as training courses in cultural production, research visits and imaginative use of digital in the delivery of projects these amendments are suggested in order to align the outcomes of the fund with Department of Culture Media and Sport and Creative Strategies that have been published since the fund was established.

7. Spend to Date

The Board are asked to note the overwhelming interest in the Culture, Heritage and Event Fund since it was initiated. The combined number of applicants over the first two funding rounds has been 108 - from communities, businesses and cultural organisations in Renfrewshire and across Scotland. This amounts to a total funding request so far of £1,280,000 of which 34 projects have been supported, amounting to £217,830 committed funds to date which leaves £282,170 available from the £500,000 approved by the Economy and Jobs Board in 2015.

Implications of the Report

1. **Financial** – The Jobs and Economy Board approved the establishment of a £500k fund over the period to 2021. The applications are subject to the Council's new grant conditions which were revised and will be implemented April 2016.
