#### 1 Minute

There was submitted the Minute of the meeting of this Local Partnership held on 4 February 2021.

It was noted that Brenda Whitelaw was detailed in the Present and Apologies sections in the Minute and that the reference to Brenda Whitelaw being present should be deleted from the Minute.

**DECIDED:** That, subject to the above amendment, the Minute be approved.

### 2 Applications for Local Partnership Funding in Villages 2021/22

There was submitted a report by the Chief Executive relative to applications for funding from The Villages Local Partnership in 201/22.

The report intimated that the available allocation for the Local Partnership was £56,644, made up of £51,191 from the General Grant Fund and £5,453 underspend carried forward from 2020/21. The carry forward of underspend was agreed due to the exceptional circumstances of the Covid pandemic which impacted on the ability of community organisations to undertake activities due to restrictions in place over the period. The normal arrangement whereby underspends could not be carried forward into the next financial year would be reinstated for 2021/22. The sum of £50 per community representative required to be ringfenced for potential claims for administrative expenses, which left a balance of £55,894 for allocation.

The report advised that the Youth Challenge Fund component of the Local Partnership's funding, now known as Celebrating Renfrewshire, was £23,609. In addition, an underspend of £14,223 would be carried forward to 2021/22, making the total £37,832. This would be allocated by young people through a participatory budgeting process, which would take place during autumn 2021.

Following the resignation of the Chair, officers had prepared a proposed method for considering the applications, which had been circulated to members prior to the meeting.

Following discussion, it was agreed that the proposal be amended by moving applications FR1084 by Rainbow Turtle; FR1134 by Loud n Proud; and FR1171 by Elderslie Community Council into category 1.

- (d) That a workshop be held early in the new year at which members could examine options and methods for allocating grant funding that were fair, equitable and focussed on the Local Partnership's priorities.

## The Villages Local Partnership Budget Monitoring Report and 2020/21 Funding Application Feedback

There was submitted a report by the Chief Executive relative to the 2020/21 budget allocated to this Local Partnership. An appendix to the report detailed the distribution of funds.

The report also provided feedback from the local groups that had received funding in 2020/21 on the success of their projects and the benefits delivered to local communities. It was noted that efforts continued to encourage more recipients of awards in 2020/21 to provide feedback.

It was acknowledged that the Covid-19 pandemic and resultant lockdown restrictions had affected the ability of groups to pursue projects and spend their allocated grant funding during 2020/21. In recognition of this, and the fact that some groups had returned funding, it had been agreed that underspends in 2020/21 would be carried forward and added to the budget for 2021/22.

<b><u>DECIDED</u></b> : That the budget monitoring report and feedback from recipients of funding in 2020/21 be noted.

# **Communities Mental Health and Wellbeing Fund**

£15 million National Communities Mental Health and Wellbeing Fund - £509,542 for Renfrewshire

To provide significant investment into community support for adults, building on the children and young people's community wellbeing supports currently being rolled out across Scotland

Fund will be locally focused – work with local partners and strong connections with community groups - Engage Renfrewshire is the point of contact for enquiries, applications, delivery of grant monies and collection of monitoring

This year's funding to is be fully allocated by the end of the financial year (31st March 2022), but anticipating further funding 2022/23 (subject to confirmation)



# **Fund Aims and Criteria**

Promote and develop good mental health and wellbeing - protect against the impact of distress and mental ill health within the adult population

Tackle issues within the Scottish Governments Transition & Recovery Plansuch as; suicide prevention, social isolation and tackling loneliness

Address the mental health inequalities exacerbated by the pandemic and the needs of 'at risk' groups – women, BAME, disability, socio-economic, bereavement, older people, LGBTI, geographic, refugees, trauma,...

Focus on supporting projects with a strong community focus - delivered by groups and clubs, voluntary or community organisations, registered charities, and not-for-profit company or Community Interest Companies.



# Applications...

Appropriate 'light touch' application process to enable access to the fundsome guidance will follow but flexible to local processes

Amount of funding – expectations of some smaller grants (i.e. £10K and under) and flexibility to provide some larger grants (i.e. around £50k)

Potential for smaller amounts to Non-constituted groups

Monitoring, 'light touch' local suggestion of evidence gathering of programme's impact via experiences of participants, i.e. groups provide a story of change for participants, could be via photos, video, poetry, tbc

Scottish Government would like to see local application processes open to applications by 30th November – we intend to be going ASAP!

# TITLE: The Villages Local Partnership Budget Monitoring Report

### 1. Summary

- 1.1 The Villages Local Partnership provides funding to community groups to undertake projects in the Local Partnership area which are aligned to the Partnership's Local Priorities. This funding is allocated from the General Grant Fund and through a youth-led Participating Budgeting exercise known as Celebrating Renfrewshire.
- 1.2 This report sets out the funds allocated by The Villages Local Partnership at its meeting on 10 June 2021, as well as the spend against this budget.
- 1.3 At the meeting on the 10 June, a number of applications were referred onwards to the Green Spaces and Villages Investment Funds for consideration. All of the referred applications were successful in applications to these funds.
- 1.4 The results of the Celebrating Renfrewshire youth participatory budgeting process were announced at an announcement event organised by the youth steering group on the 12<sup>th</sup> November 2021. Successful projects and amounts awarded are detailed in the table below.
