## **Declarations of Interest**

Councillor Campbell declared an interest in item 2 on the agenda as she was an employee of NHS Greater Glasgow and Clyde but not in the Council's area and intimated that she would remain in the meeting during consideration of the item.

## 1 Minute of Previous Meeting

There was submitted the Minute of the meeting of the Board held on 7 May 2020.

**DECIDED**: That the Minute be approved.

## 2 Update on Covid 19

There was submitted a report by the Chief Executive relative to the Council's current arrangements and response to the ongoing international Coronavirus, COVID-19 pandemic. The report provided information on the national position including the number of cases and deaths at both Scottish and UK levels. The recent publication of updated figures and analysis from the National Records of Scotland was also included which showed that the rate of increase in deaths from COVID-19 was beginning to slow. A summary was also given of policy and guidance updates that had been released since the previous meeting of the Board on 7 May 2020.

It was noted that as at 14 May 2020 there were 233,151 confirmed cases of COVID–19 in hospitals in the UK up from 194,990 reported on 7 May 2020. In Scotland there were now 14,117 confirmed hospital cases, up from 12,709 reported on 7 May 2020. Of these, 3,628 cases were within the Greater Glasgow and Clyde Health Board area, up from 3,203 reported on 7 May 2020. In the GGCHB area there were 473 people in hospital, and 26 in intensive care, down from 509 and 30 reported on 7 May 2020 respectively, as either confirmed or suspected cases.

The report intimated that the UK now had more deaths than any other country except for the United States. However a more accurate comparison was to consider the number of deaths in relation to population size and on this measure (when removing countries with very small populations) the UK currently ranked 4th with 495 deaths per million population, behind Belgium (768 deaths per million population), Spain (584 deaths per million population) and Italy (514 deaths per million population). It was noted that the National Records of Scotland had now published its 6th weekly report which indicated the numbers of deaths registered in Scotland that noted COVID-19 as a factor in the death. As at 10 May 2020, there had been a total of 3,213 deaths registered in Scotland where COVID-19 was mentioned on the death certificate, up from 2,795 deaths registered up to 3 May 2020.

The report highlighted the support being provided for communities and provided information in relation to Care Homes and safeguarding and supporting vulnerable residents being looked after in their own homes; included up to date figures on the numbers and types of support being provided to some of the most vulnerable residents in Renfrewshire; an update on the support being provided to Council Housing Tenants and an overview of the impact of COVID-19 on the work of the service; a workforce planning update for the Council, including the current position in relation to availability of PPE; on employee testing procedures; the current position in relation to the impact of

absence on the availability of employees; redeployment of staff into priority front-line roles; and information on work undertaken to support businesses to comply with the Health Protection (Coronavirus) (Restrictions) (Scotland) Regulations 2020.

The report also sought approval for the previously scheduled Renfrewshire Council Joint Negotiating Committee for Teaching Staff (JNC) to be arranged and held remotely on 2 June 2020.

The Board heard from the Chief Executive in relation to the report in general and in particular to the situation in Renfrewshire where deaths involving COVID-19 were above the national average, and more so in areas of deprivation, and the work that was ongoing by officers to determine if further analysis could be undertaken on this; on the recovery arrangements and union consultation; from the Acting Head of Health & Social Care (Paisley) in relation to the situation within care homes and care at home services; from the Head of Communities, Housing & Planning in relation to support for housing tenants, including allocations and homelessness; sheltered housing and gas servicing works; from the Director of Infrastructure & Environment in relation to street cleaning; and civic amenity sites and from the Communities & Regulatory Manager in relation to the deployment of wardens.

Officers responded to members' questions and it was noted that if members had queries in relation to volunteers who had not been contacted, that these should be raised directly with the Head of Policy & Commissioning in the first instance. It was proposed that the Chief Executive examine whether there was any opportunity for volunteers to help in the recovery phase or in other roles. This was agreed.

#### DECIDED:

(a) That the current national and local situation with regards to COVID-19 and the impact on communities, businesses and the Council and its partners be noted;

(b) That the response measures being put in place by the Council and its partners be noted;

(c) That it be agreed that a remotely-held meeting of the Renfrewshire Joint Negotiating Committee for Teaching Staff (JNC) be held on 2 June 2020; and

(d) That the Chief Executive examine whether there was any opportunity for volunteers to help in the recovery phase or in other roles.

## 3 Financial Update

There was submitted a report by the Director of Finance & Resources relative to the current estimated financial impact on the Council arising from the COVID-19 pandemic. It was noted that the financial implications for the Council continued to emerge and develop as the impact and consequences of the pandemic both for Council services and for communities across Renfrewshire evolved. The report intimated that the overall net financial impact on the Council's revenue budget, at this stage, was estimated to be circa £26-27 million in 2020/21 based on existing assumptions and the continuation of the lockdown period to the end of June 2020. If the lockdown period continued beyond the end of June or if there was a need for the Council to continue to provide significantly enhanced ongoing support arrangements as part of the Test, Trace, Isolate and Support phase and the recovery phase it was expected that these estimated costs would increase further. These costs did not include other costs the Council was incurring in supporting the Renfrewshire Health & Social Care Partnership on the basis that these costs would be recoverable from the Scottish Government.

It was noted that the Right for Renfrewshire (RfR) programme had been paused and it was not clear when the programme would be able to recommence; therefore there would be no material delivery of savings in this financial year. In relation to capital investment plans it was noted that the full impact would not be understood fully for some months. However, it was anticipated that there would be significant risk of substantial additional costs arising from live projects as the closedown and social distancing restrictions drove up the costs of live construction sites and built in unavoidable time delays and costs into the completion of projects.

The report highlighted that the financial and economic consequences of the pandemic were expected to be significant in the short term, with unprecedented financial interventions made by national governments to support the immediate COVID-19 response, the economy and businesses. However, despite this the report intimated that the economy across the UK and Scotland would experience the sharpest and deepest downturn in modern history and there was a growing concern that the period of recovery, although sharp would not be as immediate as was first considered a possibility and could be more drawn out with some industries and sectors being more significantly affected and taking longer to recover than others.

The report outlined that this unprecedented economic turbulence and scale of required state intervention would have both short and longer term implications for public finances across the UK and Scotland which would require the Council to reconsider its existing 2020/21 budget and fundamentally reassess its medium and longer-term financial planning and investment programme as the full financial, economic and fiscal impact of the pandemic became clearer and as the Council in response re-shaped its priorities moving forward.

In relation to the impact on the Council's 2020/21 budget, the report proposed that the Corporate Management Team begin to process detailed preparatory work to develop a range of options that would support the Council's considerations for a revised budget for 2020/21 and actions that would support a re-framed medium-term financial outlook.

The report indicated that Renfrewshire Leisure (RL), an arms length organisation, wholly owned by the Council and which was responsible for managing its own financial affairs on a not-for-profit basis, was reliant on a service payment from the Council in respect of leisure and cultural services in order to cover its operating costs which could not be fully met through commercial operations. However, due to the current lockdown the majority of RL operations and facilities were closed and providing ongoing financial support was recognised as part of the exceptional costs being experienced by the Council as a result of COVID-19 and this was expected to continue beyond when facilities re-opened. RL was actively seeking to make savings wherever possible in order to offset losses, including the furloughing of relevant staff and mitigate the overall financial support requested from the Council. The report intimated that in preparing their 2019/20 financial accounts the impact of COVID-19 on the organisation would require to be disclosed and their external auditor would seek assurances over the financial going concern of the Trust over the 12-month period 2020/21. In order to meet this requirement the Council would need to provide a letter of support providing assurance that RL would over the course of 2020/21 be financially supported by the Council to offset the loss of commercial income to allow the 2019/20 accounts to be completed on a continued going concern basis.

The Board heard from the Director of Finance & Resources in relation to the report and in response to members' questions.

#### DECIDED:

(a) That the initial financial assessment completed of the potential revenue and capital consequences of the COVID-19 pandemic and emergency response along with the

anticipated disruption to the Council's planned savings in 2020/21 as outlined in sections 4-6 of the report be noted;

(b) That the update provided at section 7 of the report of the funding that had been confirmed by the Scottish Government to support local government's response to COVID-19 and wider financial interventions made by the Scottish Government, some of which were being administered and delivered by local authorities on the Government's behalf, be noted;

(c) That it be noted that the funding confirmed to date along with anticipated shares of as yet undistributed funding for the Council was significantly less than the estimated net additional costs to the Council; and that it be noted that in this current context it was expected that the Council' existing un-allocated reserves would require to be fully deployed as part of the wider financial strategy developed in response to the COVID-19 emergency;

(d) That it be noted that the Council was continuing to work actively with CoSLA to support consistent financial reporting of the net additional costs to local authorities nationally of responding to the current pandemic to inform ongoing engagement with the Scottish Government over the requirement for further additional funding support;

(e) That it be noted that it was expected that the net financial impact of responding to the pandemic would continue to increase and develop more fully over coming months as the national response continued to place demands on Council services for support to local communities and that this would continue through to and during the eventual recovery phase;

(f) That the proposed actions outlined in section 8 of the report be agreed to prepare the Council for a mid-year reconsideration and revision of the 2020/21 budget and medium-term financial strategy and that it be noted that it would be intended that a full report be targeted for September 2020 in this regard;

(g) That it be agreed as outlined in section 9 of the report that a letter of financial support is provided to Renfrewshire Leisure from the Council as part of providing the necessary level of assurance to external audit as part of the closure of its 2019/20 accounts; and

(h) That it be noted that further updates on the developing financial position and outlook would be provided to the Board on a regular basis over the coming weeks and months as material developments emerged.

#### Heading: Update on COVID-19

#### 1. Background

- 1.1 This report provides an update of the Council's current arrangements and response to the COVID-19 pandemic. Information is provided on the national position including the numbers of cases and deaths at both Scottish and UK levels. The recent publication of updated figures and analysis from the National Records of Scotland is included and continues to show that the rate of increase in deaths from COVID-19 is beginning to slow.
- 1.2 On 21 May 2020 the First Minister made an announcement that set out details and proposed stages for moving on from lockdown and opening up businesses and services. The key points made in this announcement are included in Section 3 together with initial details on the work being undertaken by senior officers to prepare for recovery as the Council adapts its services and facilities for an extended period of living with COVID-19. A summary is also provided of other policy and guidance updates that have been released over the past week in this section.
- 1.3 Section 4 highlights the support being provided for communities with information in relation to Care Homes and safeguarding and supporting vulnerable residents being looked after in their own homes. This section also includes up to date figures on the numbers and types of support being provided to some of the most vulnerable residents in Renfrewshire.
- 1.4 Section 5 provides a workforce planning update for the Council. It confirms the current position in relation to availability of PPE; employee testing procedures; the impact of absence on the availability of employees; and redeployments.
- 1.5 Section 6 provides an operational update from Communities and Public Protection on the Test, Trace, Isolate and Support contact tracing process and from

Environment and Infrastructure Services on the plans to reopen Household Waste Recycling Centres.

#### 2. Recommendations

- 2.1 It is recommended that the Emergencies Board:
  - (a) Note the current national and local situation with regard to COVID-19 and the impact on communities, businesses, the Council and its partners
  - (b) Note the response measures being put in place by the Council and partners as set out in this report

### 3. National Situation

#### Numbers of Cases

3.1 Currently there are 250,908 confirmed cases of COVID – 19 in hospitals in the UK up from 233,151 reported on 15 May 2020. In Scotland there are now 14,856 confirmed hospital cases (up from 14,117). Of these, 3,806 cases are within the Greater Glasgow and Clyde Health Board area (up from 3,628). In GGCHB area there were 400 people in hospital (down from 473) (16 in intensive care – down from 26) as either confirmed or suspected cases.

#### **Numbers of Deaths**

- 3.2 At a UK level, reports are indicating that there have now been 36,042 deaths across the UK (up from the 33,614 deaths reported on 15 May 2020). The UK still ranks second for overall numbers of recorded deaths, behind the United States where over 93,000 deaths have been recorded (283 per million population). When considering the number of deaths in relation to population size (removing countries with very small populations) the UK currently still ranks 4<sup>th</sup> with 521 deaths per million population, behind Belgium (790 deaths per million population), Spain (594 deaths per million population) and Italy (532 deaths per million population).
- 3.3 The latest National Records of Scotland report shows that at 17 May 2020, there had been a total of 3,546 deaths registered in Scotland where COVID-19 was mentioned on the death certificate up from 3,213 deaths registered up to 10 May 2020.
- 3.4 The graphs below show the increase in the overall numbers of deaths recorded at a UK and a Scottish level since 1 April 2020 and in each case show that the rate of increase is slowing, with the numbers recorded now sitting below the linear trajectory of increase over that period of time.



- 3.5 The National Records of Scotland analysis also provides additional information on the outbreak so far in Scotland, including some further positive indicators of progress in responding to the outbreak:
  - Of the total number of deaths registered in the week from 11 to 17 May 2020, there were 332 where COVID-19 was mentioned on the death certificate, a decrease of 83 from the previous week. This is the third weekly reduction since the first COVID-19 death was registered in March.
  - The proportion of all deaths involving COVID-19 has also decreased for the third week in a row:
    - 36% of all deaths in week to 26 April 2020
    - 31% of all deaths in week to 3 May 2020
    - 29% of all deaths in week to 10 May 2020
    - 23% of all deaths in week to 17 May 2020
  - The proportion of all COVID-19 deaths which took place in care homes initially rose each week and represented 59% of all COVID-19 deaths in the week to 3 May 2020. This dropped back slightly in the week to 10 May 2020

to represent 57% of all COVID-19 deaths and in the latest week to 17 May 2020 represented 55% of all COVID-19 deaths.

- The number of deaths in care homes also reduced for the third week in a row down to 184, 54 fewer than the previous week.
- When looking at all deaths with COVID-19 registered to date there is little change from previous weeks:
  - 46% relate to deaths in care homes
  - 47% were in hospitals
  - 7% of deaths were at home or non-institutional settings
  - 76% were people aged 75 or over
- 3.6 The National Records of Scotland information provides additional detail to understand the position and changing impact of the outbreak in Renfrewshire. This week, it suggests that the figures recorded in the week from 4 to 10 May 2020 were unusually low and out of line with the overall trend in reductions being seen:
  - In Renfrewshire, the number of COVID-19 related deaths recorded in the week to 17 May 2020 was 17 up 6 from the previous week. However, during the week from 4 to 10 May 2020 the deaths recorded dropped very sharply to 11, from 33 the previous week. (Figure 1: Appendix 1)
  - Similarly, in the week to 17 May 2020, COVID-19 related deaths represented 28% of all deaths recorded in Renfrewshire. While this was an increase from 21% of all deaths recorded in Renfrewshire in the week from 4 – 10 May 2020, again, that figure was a sharp reduction from 44% the previous week. (Figure 2: Appendix 1)
  - The COVID -19 related death rate for all of Scotland has reached 6.5 per 10,000 population (an increase from 5.1 per 10,000 population last week).
  - The death rate in Renfrewshire reflects this and has also risen during the past week to 9.8 per 10,000 population (from 8.9 the previous week). This means Renfrewshire still has the fourth highest death rate in Scotland. Inverclyde remains the area in Scotland with highest COVID-19 related death rate. (Figure 4: Appendix 1)
  - The proportion of deaths that have occurred in care homes in Renfrewshire rose slightly to 50%, up from 49% the previous week and remains slightly above the national average of 46%. (Figures 3 and 5: Appendix 1)

#### Recovery – Living with COVID-19

- 3.7 On 21 May 2020 the First Minister made an announcement in the Scottish Parliament setting out a phased process that is currently planned to allow the lockdown to be eased over future weeks and months. The key stages set out in this plan include:
  - **Phase 1:** When the virus is not yet contained but cases are falling. Planned from 28 May 2020, people should be able to meet another household outside in small numbers. Sunbathing will be allowed, along with some outdoor activities like golf and fishing. Garden centres and drive-through takeaways can reopen, some outdoor work can resume, and childminding services can begin. There will also be a phased resumption of some aspects of the criminal justice system, as well as face-to-face Children's Hearings, and people at risk will be able to have more contact with social

work and other support services. NHS services which were cancelled because of the coronavirus crisis will "carefully and gradually" resume.

- **Phase 2:** When the virus is controlled. People can meet larger groups outdoors and meet another household indoors. Construction, factories, warehouses, laboratories and small shops can resume work. Playgrounds and sports courts can reopen, and professional sport can begin again.
- **Phase 3:** When the virus is suppressed. People from more than one household can meet indoors. Non-essential offices can reopen, along with gyms, museums, libraries, cinemas, larger shops, pubs, restaurants, hairdressers and dentists. Live events could take place with restricted numbers and physical distancing restrictions. Schools should reopen from 11 August 2020.
- **Phase 4:** When the virus is no longer a significant threat. University and college campuses can reopen in full; mass gatherings are allowed. All workplaces open and public transport is back at full capacity.
- **3.8** The situation will be reviewed every three weeks, with further phases of easing being introduced if enough progress is being made on keeping the virus under control. The First Minister described the first steps as proportionate and suitably cautious and stressed that the default message during phase one will remain "stay at home as much as possible".
- 3.9 In the announcement the First Minister indicated that Schools will reopen on 11 August 2020 to a "blended model" where pupils will do a mix of school and home learning. Further information on plans being made for this in Renfrewshire is contained in Section 6 of this report.
- 3.10 A summary description of the main changes being considered by the Scottish Government for each phase of the process has been attached as Appendix 2 to this report.
- 3.11 Since the emergence of the pandemic and the associated lockdown, the Corporate Management Team have been focused on ensuring that essential services and support continue to be provided across Renfrewshire's communities. As has been reported to board each week, there has been an ongoing requirement to respond to the crisis and to deliver on new requirements at pace, in relation to issues such as, for example, shielding, PPE and testing amongst many others.
- 3.12 An Emergency Management Team structure was established to provide senior officer leadership and direction of the Council's response to the crisis, to ensure oversight and consideration of emerging issues and to act as a strategic planning function to respond quickly and effectively to the developing crisis. The Emergency Management Team currently meets three times per week, with one meeting each week attended by key partners such as Police Scotland and the Scottish Fire and Rescue Service.
- 3.13 The Corporate Management Team has now developed an initial approach to support recovery planning at a strategic level. This next phase of activity will clearly be informed by any easing of lockdown measures confirmed by the Scottish Government in the coming days and weeks, and will be required to recognise that Scotland along with the rest of the UK and international community,

will need to find new ways of "living with coronavirus" for a period of possibly 12-18 months depending on the success of testing approaches and the pursuit of an effective vaccine.

- 3.14 The impact of the pandemic is likely to be deeply felt over the medium to long term, and there will be a requirement for Council services to continue to operate flexibly to meet the changing needs and behaviours of local communities, potentially providing new services or adapting others to reflect emerging Scottish Government guidance and considering the resources available at each stage. There is also an ongoing requirement to consider the availability of the Council's workforce to deliver services, as it is possible that high levels of absence may continue to be experienced as staff remain unable to work normally, due to illness or factors such as shielding or self-isolation.
- 3.15 The Corporate Management Team will meet weekly going forward to develop these recovery plans and have identified a number of workstreams spanning areas such as health and social care, learning, community wellbeing, economic impact, financial and contractual issues and key Council operational and support functions. These meetings will be in addition to the Emergency Management Team meetings taking place which will continue to focus on the crisis response. The workstreams will involve key chief officers and senior managers across the Council in the development of evolving plans and will also seek to engage with key local and national partners to ensure the right knowledge and skills are available to support this approach. Regular updates will be provided to elected members on recovery planning through the Emergencies Board.
- 3.16 In terms of health and social care, members of the board are asked to note that each health board has been asked by the Interim Chief Executive of NHS Scotland to prepare a mobilisation plan, effectively outlining the roadmap for a return to normal levels of health and social care provision. Renfrewshire HSCP is actively engaging in these discussions within NHS Greater Glasgow and Clyde, and it is anticipated that there will be further engagement with the Integrated Joint Board in early June on the mobilisation plan and its implications for Renfrewshire. A distinct workstream is also being progressed in partnership with Renfrewshire Leisure.
- 3.17 At both a Scottish and UK Government level, the policy context in relation to the response to COVID-19, continues to develop at a rapid pace. Changes to existing policies; the introduction of new processes; and announcements on future developments, are all being closely monitored. Since the last Emergencies Board meeting on 15 May 2020, the following policy changes have been announced:
  - The Scottish Government have announced an extension to the current testing arrangements in Scotland, with testing now opened to everyone who is symptomatic over the age of 5. Under the arrangements, individuals displaying any of the three symptoms of COVID-19 continuous cough, high temperature, or loss of sense of taste or smell will be able to book a test at drive-through or mobile test centres. The Scottish Government confirmed this extension in testing eligibility comes ahead of the rollout of the new Test, Trace, Isolate and Support (TTIS) approach which will be used to keep transmission in communities low as the country moves out of lockdown. A pilot involving several health boards is underway to allow health boards to test tracing software and methodology in advance of the

full roll-out programme. Loss of taste and smell (anosmia) has also now officially been added as a recognised key symptom of coronavirus.

- In relation to care home provision, Jeanne Freeman, Cabinet Secretary for • Health and Sport, has written to all health boards, local authorities, Health and Social Care Partnerships and care home providers, to implement new arrangements intended to strengthen oversight of care home activities during the current pandemic. From 18 May, clinical and care professionals at NHS boards and local authorities were designated as having a lead role in the oversight of care homes in their area, with every health board and local authority requiring to put in place a multi-disciplinary team comprised of key clinical leads and the area's Chief Social Work Officer. The Cabinet Secretary has also written this week to vary the role of the Executive Nursing Director within each health board to be accountable for the provision of nursing leadership, support and guidance within the care home and care at home sector. Escalation procedures for significant issues have also been put into place through the health board and local authority to Scottish Government.
- Councils will get more support to deal with increased levels of domestic abuse and gender-based violence during the coronavirus outbreak with new Equally Safe guidance published jointly by the Scottish Government and COSLA this week. The guidance signposts to local resources and assists decision-makers in identifying women and children at risk as well as the short, medium and long term steps they can take to support their recovery and wellbeing. The guidance is part of a range of measures introduced to tackle higher levels of abuse and violence, including a £1.5 million funding package for the women's aid and rape crisis network. It will help to maximise the effective protection and provision of support for those experiencing gender-based violence, both during this immediate crisis period and in the longer term.
- 3.18 The Coronavirus (No2) (Scotland) Bill has completed its passage through the Scottish Parliament. A detailed note on the terms of the Bill will be sent to all elected members, however the Bill contains a number of provisions that have implications for local authorities that are worth highlighting including:
  - Power to Purchase "Distressed Care Services": The Bill introduces a power for local authorities and health bodies to purchase: care homes; care at home services; or the assets or liabilities of either, under certain circumstances. The purchase may only proceed with the agreement of the owner. The power to purchase only arises where the provider: is in serious financial difficulty; or where there is a threat to the life, health or wellbeing of the persons receiving services; or the provider has recently ceased to provide the services
  - Non-Domestic Rates Relief: The Bill makes provision to allow Ministers to make regulations to allow for the remit or reduction of non-domestic rates in financial year 2020/21
  - Freedom of Information: The Bill reverses the changes introduced at the start of the COVID-19 crisis that gave Councils more time to respond to Freedom of Information requests. The timescales will revert to the original statutory timescales which include responding to requests within 20 working days. One change that remains is that the Information Commissioner can

still take the COVID-19 emergency into account when considering whether the authority has good reason for failing to meet the statutory deadline.

• There are other provisions relating to: Listed Building and Conservation Area consents; the removal of criminality lability for obstructing roads where a person is involved in the hospitality sector and they have placed chairs and tables outside their premises; and concerning a duty on the Scottish Ministers and the National Records of Scotland to make arrangements to ensure marriage and civil partnership ceremonies can take place during the emergency period.

#### 3.19 Guidance Updates:

- Clinical and practice guidance for adult care homes has been updated and provides targeted advice about COVID-19 to support those working with adults in care homes. It includes updated advice on: PPE; admissions and testing; strengthening advice on infection control; health care support for residents; caring for someone depending on their COVID-19 status; workforce; staff and resident wellbeing; and mutual support for care homes. Additional information on this is provided in section 4 of this report.
- Guidance on physical distancing in education and childcare settings has been updated to ensure provision made within education and childcare settings is as safe as possible for staff and children. The update details the general infection prevention and control measures to be followed - namely hand hygiene and dealing with coughs and sneezes. There is a recognition that physical distancing is not always practical in essential service delivery and new information on use of PPE is provided, including guidance on PPE in the delivery of intimate care and assistance with medical interventions.
- Guidance for businesses offering support for the ongoing effort to tackle the coronavirus (COVID-19) emergency has been issued. Scottish Government have established a single point for contact to help prioritise these offers and direct them to where they will have most impact. It is recognised that the need for support is varied but key areas might include manufacturing, medical equipment and supplies, infrastructure, transport and distribution.
- Information for stakeholders of the European and Structural Investment Funds programmes from 2014 to 2020 has been provided as a question and answer update addressing the most common queries received by Scottish Government.
- Guidance has been provided that outlines support available for those working in the cultural and creative industries
- 3.20 Following agreement of CoSLA Leaders, all local authorities are now submitting a data return on a weekly basis. The data includes a range of indicators already collected and reported for other national monitoring purposes. Work is underway by the Improvement Service and SOLACE to analyse these returns. Appendix 2 provides a copy of the data return submitted by the Council to COSLA on 15 May 2020. Due to the data verification process and timescale for submitting the return the information reported in Appendix 3 may be different from similar data contained elsewhere in this report which is more current.

## 4. Support for Communities

#### Care Homes

- 4.1 Renfrewshire has a mixture of residential care homes and extra care housing directly operated by the Health and Social Care Partnership; nursing homes and a smaller group of residential care homes operated by the independent sector.
- 4.2 As in previous reports to the Board the data available is based on self-reporting by all 22 care homes and discussions with the Care Inspectorate, which are held weekly. Sadly, 108 people have now been reported by care homes as dying with COVID-19 since 18 March 2020. 11 care homes are now reporting residents with symptoms of COVID-19, or have confirmed cases, with a total of 35 residents now reported as symptomatic or confirmed. This information continues to be subject to frequent change.
- 4.3 The extension of testing for all Renfrewshire care home residents has continued to be rolled out. Initially this was prioritised and undertaken where there had been a new infection in a care home in the 14 days prior to the commencement of enhanced testing on 1 May 2020. This phase has now been concluded. Testing in the event of new outbreaks is currently ongoing and sample testing of homes with no reported COVID-19 related issues will follow.
- 4.4 This is providing a fuller understanding of the level of infection present in the homes where testing has been carried out.

#### **HSCP-Operated Care Homes**

- 4.5 There are 3 HSCP-operated care homes and 4 HSCP-operated extra care units. As previously reported, one resident in an HSCP-operated care home has died, with the death certificate noting the secondary cause of death as suspected to be COVID-19 related. Testing of all residents and staff in this care home has been undertaken. Resident testing has now concluded, with one further resident testing positive.
- 4.6 Resident and staff testing is now underway in the two other HSCP-operated care homes, on the basis that they are sister homes to the care home where we have one positive case in the resident group. The 4 extra care units which have a similar vulnerable resident population to the residential care homes will also be tested as part of the precautionary measures.

#### External Care Homes

- 4.7 Testing is currently underway in 12 external care homes. At the time of writing 494 residents have been tested, with 49 testing positive.
- 4.8 As previously highlighted to the Board, one local care home experienced a significant number of residents who tested positive for COVID-19. Additional support has been provided to this care home including input from the clinical lead for palliative care, senior nurse manager for the enhanced care home liaison service, and palliative care nurse who all visited and provided care to residents. Additional staffing had also been arranged, however the care home advise this is no longer required due to improved staffing levels as they return from periods of self-isolation. The HSCP will continue to work closely with the care home, Public

Health and the Care Inspectorate to ensure that all appropriate care and support is provided to the residents.

#### **National Guidance**

- 4.9 On 17<sup>th</sup> May 2020, the Scottish Government published new national COVID-19 guidance to provide for support and oversight of care home and care at home services. The guidance requires that clinical and care professionals at NHS boards and local authorities have a lead role in the oversight for care homes in their area.
- 4.10 Every NHS Board and Local Authority must put in place a multi-disciplinary team comprising of key clinical and care leads, including Public Health and the Local Authority's Chief Social Work Officer which will convene daily. This team is 'responsible and accountable' for: providing oversight, analysis and response to emerging issues; infection prevention and control; and clinical and care support to service users.
- 4.11 Further guidance is expected and work is ongoing to develop local arrangements. The existing close working relationship between the HSCP, the Council Chief Social Work Officer, the Public Health team and the Care Inspectorate will be of benefit in establishing these oversight procedures and maintained. Robust and collaborative arrangements are already in place locally and will be developed to include:
  - A daily call to every care home through which home by home information will be captured that provides a clear understanding about staffing levels; PPE; infection control; numbers of residents who are symptomatic; numbers of deaths and the status of testing. This will be reported to a new Oversight Huddle
  - A daily Oversight Huddle involving at least the senior HSCP Manager, Chief Social Work Officer, HSCP Clinical Director /senior clinician, HSCP Chief Nurse/senior nurse and the HSCP Contracts and Commissioning Manager. This Huddle will be responsible for reviewing the daily care home status report; ensuring this leads to appropriate advice and support to all homes; and identifying clear improvement actions where required
  - A weekly local Care Homes Support Meeting led by the senior HSCP Manager and Clinical Director. It is intended that all local care homes must join this call. Its purpose is to provide a forum for clinical and care advice and support to all registered homes.

#### **Care at Home Services**

- 4.12 At present, Renfrewshire HSCP is supporting approximately 1,600 service users through its internal and external Care at Home services. There are a small but growing number of these people, living within their own homes with suspected or confirmed COVID-19.
- 4.13 Appropriate PPE is worn by staff when supporting service users in their homes, with all appropriate precautions being taken to maintain safe and effective care delivery. Access to testing is available for eligible people and staff who are symptomatic or have household members who are symptomatic.

- 4.14 At the time of writing, sadly 14 Care at Home service users have died, with the deaths reported as being related to COVID-19. In addition, 6 service users have been confirmed as having COVID-19 and another 6 are currently being reported as having COVID-19 like symptoms. As is the case with care homes, this information is subject to frequent change and the expanded testing programme will provide a fuller understanding of the impact of COVID-19 in this vulnerable community.
- 4.15 Staff across care home and care at home services are working in challenging circumstances and their welfare is a priority. Access is provided to mental health and wellbeing services across Renfrewshire and online. Staff hubs have also been put in place to allow care at home staff appropriate places to take rest periods whilst being able to access snacks and drinks when working within a community setting. This provision will be enhanced by the national wellbeing hub established and launched this week.

#### Shielded and Vulnerable Residents

4.16 To date the local helpline has received 5,348 calls in relation to shielding enquires and the following support has been provided:

4.17 Group 2 vulnerable residents have also made 820 calls through the national helpline, with the level of support provided through the Local Assistance Team to vulnerable people in this category, outlined in the table below:

- 4.18 The initial focus of work has been to ensure that support is provided on an emergency basis to those most vulnerable, with a strong focus on those that needed support to access medicine or food safely and urgently.
- 4.19 The initial crisis response phase of assistance is now more or less complete. The Local Assistance Team have made contact with the majority of people on the local shielding list around 90% and in the past week only a further 136 names were

added to the list of people being asked to shield. Where contact has not been made directly by the team it is being checked through the HSCP with GP's.

4.20 As the Council moves forward with establishing virtual neighbourhood hubs and wider community support, it is continuing to support residents to access advice and welfare services, to access food at a local level, to offer activity that supports wellbeing and a sense of connection, or to support people to access food independently through some of the new service offerings being developed by supermarkets. A detailed report providing progress with taking forward the development of virtual neighbourhood hubs and volunteering will be provided at the next meeting of this Board.

### 5. Support for Employees

#### Sourcing and Stocks of PPE

- 5.1 There are sufficient supplies for the next 7 days to support the current service profile in the HSCP and other frontline services.
- 5.2 All guidance continues to stress that physical distancing, hand washing and respiratory hygiene, are the most important and effective measures to adopt to prevent the spread of coronavirus.

#### Staff Testing

- 5.3 Testing arrangements have become an important element of maintaining resilience across the workforce supporting key workers who are displaying symptoms of COVID-19, or live with people who are, to get tested early. If the early testing proves negative, this facilitates an earlier return to work for the employee than would be experienced under self-isolation arrangements without testing. This in turn supports services to maintain higher levels of available staff resource to continue to meet the significant demand for services.
- 5.4 As previously reported, NHSGGC has already established its own system of testing which has facilitated 106 HSCP staff to be tested, with 38 testing positive for COVID-19. Of the 70 staff who did not test positive, this process has allowed 53 to return to work and 19 have moved to general absence.
- 5.5 At present, there are a total of 111 HSCP staff unavailable to work due to a COVID-19 diagnosis, family contact or actual symptoms. This is a slight increase in these figures over the last week.
- 5.6 Further to the expansion of the testing arrangements outlined to the Board in the previous report, the First Minister announced on the 18 May 2020 that testing was being expanded to include everyone who is symptomatic over the age of 5. This means anyone who is now displaying any of the three symptoms of a continuous cough, high temperature, or loss of sense of taste or smell will be able to book a test at drive-through or mobile test centres. Tests were previously available to over-65s, key workers and to anyone who needs to work and cannot do so from home. They were also available to household members of those groups. Services across the Council continue to be supported by HR&OD to refer eligible employees and their households for testing.

- 5.7 To date, 53 non-healthcare Council employees have been tested for COVID-19. 8 employees have tested positive, 39 employees have tested negative, 5 employees are awaiting results and 1 test returned as inconclusive. Of the 48 employees who have received test results, 39 have returned to work and 9 are currently recorded as sickness absence.
- 5.8 In addition to this, staff testing is also happening routinely across Renfrewshire Care Homes. At the time of writing, 140 staff working at HSCP-operated Care Homes have been tested. 27 have tested negative, and we are awaiting the remaining tests results.

#### Staffing Update

5.9 Amongst Renfrewshire Council employees there are currently 350 employees selfisolating either because they have symptoms; or because they have other people in their household experiencing symptoms; or because they are following government and health guidance. (This is a decrease from 436 reported on 15 May 2020). Of the 350, 126 are currently working from home. The decrease in cases is due to on-going work between HR&OD and Service Managers facilitating a return to work from self-isolation. Whilst the majority of employees returned to work after the appropriate self-isolating period, a small number of employees have moved to the "at risk" category.

5.10 The 350 are split across Services as follows:

- 5.11 The number of employees in the at-risk category and unable to perform frontline duties is 985, down from the figure of 1,105 reported on 15 May 2020. Of these 338 are currently working from home. Where employees are not able to carry out their normal duties from home, options for redeployment on a home working basis are being actively considered and put in place.
- 5.12 Mental Health Awareness Week (18-24 May 2020) is the UK's national week to raise awareness of mental health and inspire action to promote the message of good mental health for all and hundreds of events have taken place around the country to raise awareness for mental health.
- 5.13 Further to the package of support being provided to employees as outlined to the board previously, the Council has launched its 'Mental Health Awareness Campaign' earlier this week, aligned to the national theme of kindness, supporting employees to look after their own and friends and family's mental health and wellbeing. #KindnessMatters.

- 5.14 Every day this week, a different key theme of the campaign has been highlighted to employees, along with useful information and support to help with their physical and mental well-being whilst at work or in the home. The key themes each day were:
  - 1. General wellbeing advice and support for good mental health (Monday)
  - 2. Healthy habits for wellbeing while you are homeworking (Tuesday)
  - 3. The link between healthy eating and good mental health (Wednesday)
  - 4. Boost your wellbeing with exercise (Thursday)
  - 5. Kindness and self-care tips (Friday)
- 5.15 An evaluation of the week and the impact it has had across the Council will be reported to a future board.

#### Redeployment

- 5.16 Currently around 1,000 employees have been redeployed within their Services to focus on the delivery of priority services for the community. Corporate, cross service redeployment requests into priority front-line roles also continue to be received. So far, of the 153 requested posts, 114 have been filled:
  - 47 Drivers supporting food and pharmacy deliveries as well as social distancing arrangements within waste collection.
  - 25 Call handlers supporting responses to shielded and other vulnerable citizens
  - 38 Coordinators, team leads and managers supporting the local response hubs
  - 4 Food packers
- 5.17 A number of other posts are in the process of being filled:
  - HWRC site and traffic attendants
  - Call handlers
  - Coordinators
  - PPE packers

## 6. Service Updates

6.1 Relevant service updates on specific issues that have not been reported before are included below:

#### Service Update – Communities and Public Protection: Test, Trace, Isolate and Support Model

- 6.2 As previously reported, a key tool to prevent the transmission of Covid-19 will be introducing a Test, Trace, Isolate and Support model. This will be led and delivered predominantly by NHS Scotland.
- 6.3 At the West Local Resilience Partnership (LRP) on 15 May 2020, the partnership agreed for local authority Environmental Health Officers (EHOs) to work with NHS Greater Glasgow and Clyde Health Board to implement the Test and Trace parts of the model. All 6 local authorities have agreed to release full time equivalent staff at varying degrees, however, Renfrewshire Council will initially release 2 EHOs (FTE) over the 3 month period.
- 6.4 Staff training has been undertaken this week and to ensure appropriate resilience, Renfrewshire Council trained all EHOs as part of the process to allow cover and flexibility in the deployment of staff.
- 6.5 It should be noted that discussions remain on-going with COSLA and the Scottish Government with regards to the Isolate and Support part of the model. Whilst local authorities have set up appropriate workstreams for shielded and vulnerable people within the community, further detail is required to assess the responsibilities and financial impact that this new Group may have on the Council.

### Service Update: Children's Services

#### **Reopening of Schools and Early Learning Centres**

- 6.6 Schools and early learning centres were closed on 20 March 2020 as part of the lockdown. As previously reported, while most buildings have been closed, learning has continued from home, with staff engaging remotely with children and young people. In addition, emergency childcare provision has been established in some premises for the children of key workers and vulnerable families.
- 6.7 On 21 May 2020, the First Minister published a road map for recovery which indicated the intention to reopen schools and early learning centres. Provided progress continues to be made in controlling COVID-19, early learning centres will start to reopen in June and throughout the summer. Schools will reopen to pupils on 11 August 2020 with a blended approach of learning at home and in school.
- 6.8 It is intended that staff will return to school buildings prior to the end of the current session in June 2020. This will allow time to ensure schools are ready to receive children and young people and that all appropriate measures have been put in place to protect both children and staff. In addition, staff will have the opportunity to plan for implementing the blended learning approaches which will be required. There is also now an opportunity for small groups of children to have access to school in June to support an effective transition into Primary 1 and Secondary 1.
- 6.9 A recovery programme for Schools and Early Learning Centres is now being developed with detailed plans and timescales based on the understanding that

these may have to change should government guidance change. This will be brought back to a future meeting of the Emergencies Board.

- 6.10 Planning is underpinned by an evidence-based framework taking account of national guidance as well as enabling establishments to devise their own individual recovery plans, based on the specific circumstances they operate within. The experiences of neighbouring local authorities across the West Partnership alongside case studies from other countries such as Denmark will allow best practice to be shared and developed within Renfrewshire.
- 6.11 An education recovery governance group has been established including representation from all services. This breadth of expertise will ensure effective partnership and coordinated working. The experience gained from the provision of the emergency childcare hubs is providing a significant understanding of how schools can operate safely. In addition, an extensive parental survey has been undertaken with hundreds of responses received and responded to. This has provided an extremely helpful understanding of the priorities of families at this time.
- 6.12 Throughout the period of school closures, there has been ongoing and very positive engagement with unions ensuring any issues have been resolved quickly and effectively. This will continue during the next phase of recovery planning.

#### Service Update – Environment and Infrastructure Household Waste Recycling Centres

- 6.13 Local Authorities across Scotland have been working together with COSLA, Waste Regulators and the Scottish Government to agree a national approach to the reopening of household waste recycling centres, on a phased basis, with centres being ready to open from Monday 1<sup>st</sup> June, where it is safe to do so.
- 6.14 In Renfrewshire (pending Scottish Government confirmation) all five household waste recycling sites will reopen from 1 June 2020, initially accepting bagged household waste only. Not all sites will open seven days a week at this time due to the high level of additional resources required to support reopening and physical distancing arrangements at each site to ensure the safety of staff and the public during this pandemic.
- 6.15 The table below sets out the detailed days and opening hours for each of Renfrewshire's household waste recycling centres. These arrangements will remain in place for the month of June and will be reviewed towards the end of June with arrangements for late June/July 2020 onwards being developed to take account of current national guidance and local resource availability.

6.16 When the household waste recycling centres do reopen, residents will be asked to visit only if it's <u>essential</u> to dispose of extra household waste. As part of the phased process for reopening sites for the first 2 weeks the sites will only accept bagged household waste. The table below sets out the timetable of waste streams that will be accepted at the sites over the next 4 weeks. The phased approach to the types of waste being taken is to support the high volume of vehicles expected to visit the centres and to support physical distancing within the centres.

- 6.17 All other normally accepted materials will be taken from week beginning the 29th June 2020.
- 6.18 It is expected that initial demand for the household waste recycling centres will be high. Physical distancing arrangements will be in place across all the household waste recycling centres to protect both employees and the public and this will impact on, and reduce, the number of vehicles that can enter the centres at any one time. Temporary traffic regulation orders will be in place for all 5 centres to control the flow of traffic into and out of the sites, allowing the safe passage of vehicles. To begin with, <u>only cars</u> will be allowed into sites. Provision for trailers and vans access will be reviewed later in June. Residents who visit the centres must be able to remove the waste from their vehicle and place it into the designated skip themselves, as staff will not be able to assist, due to the close contact this would require with the householder.
- 6.19 A communications campaign has been prepared for the reopening of the household waste recycling centres, which will contain the information set out in this report and promote the traffic management arrangements for each site. Temporary signage will also be erected and used to direct householders to the centres. Information will be provided to all Elected Members, Community Councils and promoted through the Council's media channels in advance of the opening, to support residents to safely access and use the centres.

#### Implications of the Report

- 1. Financial although at this stage not quantified, the Council will experience a wide range of significant financial pressures arising from the impact of the pandemic on the population as well as the economic and social disruption caused by the associated restrictions being deployed by national governments. Significant financial pressures will emerge in a wide range of forms from loss of income, exceptional service costs, significant increase in demand for services, the need for additional and new interventions, urgent and immediate support arrangements and services from the Council to help individuals, families and businesses across Renfrewshire as well as the Council's workforce. The Scottish Government has provided a range of immediate funding announcements to provide specific support via local authorities to both individuals and businesses as well as a degree of general funding to assist local authorities in managing immediate financial pressures. Engagement will continue between COSLA and the Scottish Government regarding further funding as the period of emergency extends, however notwithstanding, the Council will experience significant financial impact and disruption that will require it to draw heavily on all its financial reserves and which is likely to take some time to recover
- 2. HR & Organisational Development the Council's workforce represents a major part of the local population and as such is being impacted directly by the spread of confirmed cases, but much more significantly by the public health directions for self-isolation given to those displaying symptoms and those with family members displaying symptoms as well as those in the at risk groups instructed to pro-actively implement strict social distancing arrangements. Full support and communication are being provided to all staff members to ensure they remain fully informed of the developing situation and where appropriate and practical, are being supported to work safely at home and or safely return to active work once recovered or free of recommended self-isolation periods. The impact of these factors will increase exponentially over coming days and weeks and therefore the scale of availability across the Council's workforce will come under unprecedented pressures. Working closely with national government, partners and trade unions the Council will by necessity be required to actively manage and redeploy staffing resources to meet the most critical services over this exception emergency period.

#### 3. Community/Council Planning -







Figure 3 - Renfrewshire, Location of COVID-19 Deaths
