### 1 Motion

Council notes the current economic and political uncertainty caused by the result of the EU Referendum. Council further notes that a report to the Council meeting on 28 April 2016 highlighted that a vote to leave would be economically damaging for the UK and could lead to a reduction in economic growth which would reduce Government fiscal receipts and put additional pressure on public spending. The report further highlighted potential areas of financial and economic risk for the Council and Renfrewshire in relation to access to direct EU funding and foreign inward investment.

In light of the result of the EU Referendum which will see the UK leaving the European Union; Council now offers its full support to the Scottish Government in its efforts to reduce the impact of the EU Referendum result on Scotland.
