### **DECLARATIONS OF INTEREST**

J Wilby declared an interest in Item 9 on the agenda as he was Chair of a Community Council that had submitted an application for funding for Stalled Spaces and indicated his intention to leave the meeting during consideration of the item and not to take part in any discussion or voting thereon.

### 1 MINUTE OF PREVIOUS MEETING

There was submitted the Minute of the meeting of the Greener Renfrewshire Thematic Board held on 5 March 2015.

**DECIDED**: That the minute be approved.

### 2 ROLLING ACTION LOG

The Rolling Action Log was submitted for approval.

### GR.02.10.13(4B) - ESTABLISHMENT OF DATABASE

The Clerk gave a verbal update in S Marklow's absence. It was noted that the database was now established and a demonstration of how the web page would work would be given at the next meeting of the Board. It was agreed that this action could now be removed from the action log.

### GR.22.04.12(4) - MEMBERSHIP STRUCTURE

J Brown advised that all groups had been set up and the first meetings had either been held or were due to be held. It was agreed that this action could now be removed from the action log .

### **DECIDED**:

- (a) That completed action GR.02.10.13(4b) Establishment of Database be removed from the action log;
- (b) That completed action GR.22.04.12(4) Membership Structure be removed from the action log; and
- (c) That the Rolling Action Log be otherwise noted.

### 3(a) GREENER COMMUNITITIES UPDATE ON PROGRESS

There was submitted a report by the Greener Communities Sub Group relative to the progress made in delivering the actions endorsed by the Greener Renfrewshire Thematic Board in March.

The report advised that the first meeting of the group was held on 23 April 2015 and it was agreed at the meeting that the group would have a core membership with others to

be invited to join for particular meetings as appropriate. The meetings would be used to share information, ideas and knowledge as well as discussing initiatives any group was working on in relation to the Greener Renfrewshire agenda. It was agreed at the meeting that members of each organisation would recruit new signups for the Greener Pledge in order to reach the target of 500 signups by the end of 2015/16.

The report also advised that the Stalled Spaces initiative was making good progress; an audit of community groups was underway; and a questionnaire relating to greener activities had been sent to 97 educational establishments and the results were being studied.

**DECIDED**: That the report be noted.

### 3(b) GREENER TRANSPORT UPDATE ON PROGRESS

There was submitted a report by the Greener Transport Sub Group relative to the progress made in delivering the actions endorsed by the Greener Renfrewshire Thematic Board in March.

The report advised that the first meeting of the group was held on 13 May 2015. Electric vehicles; Renfrewshire Council's cycling strategy; the WorkBus scheme; and the Greener Transport action plan were discussed at the meeting.

**DECIDED**: That the report be noted.

### 4 GREENFLEET SCOTLAND

There was submitted a report by the Interim Head of Public Protection relative to the present situation with alternative fuel vehicles amongst Renfrewshire Community Planning partners.

The report indicated that Renfrewshire Council and its Community Planning Partners had received grant funding from Transport Scotland over the past four years which had enabled investment in electric vehicles and related infrastructure.

It was noted that funding had already been secured by Renfrewshire Council for 2015/16 which would enable a further 6 electric vans to be purchased which would meet the Community Plan target of 5% of the vehicle fleet using alternative fuels. The report also stated that three pilot projects were currently taking place across the country and the Board would be advised of the results in due course.

J Binning indicated that SPT operated a Journeywide Scheme which gave card holders free bus travel in Scotland and reduced fares on trains and Subway in the Strathclyde area. He intimated he would provide information on this at the next meeting.

### DECIDED:

- a) That the present situation with alternative fuel vehicles amongst Renfrewshire Community Partners be noted;
- b) That it be agreed that a presentation and demonstration on electric vehicles be delivered at the next meeting of the Board; and

c) That SPT provide information relating to the Journeywide Scheme at the next meeting of the Board.

# 5 GREENER RENFREWSHIE UPDATE ON RED IMPACT MEASURES FOR REPORTING TO COMMUNITY PLANNING PARTNERSHIP BOARD

There was submitted a report by the Interim Head of Public Protection relative to those impact measures which were identified as being 10% or more outwith target (red alert).

The report indicated that two impact measures from the Greener Renfrewshire Single Outcome Agreement fell within the red alert status. An analysis of the progress of these indicators was contained within the report and it was highlighted that this would form part of the overall progress report to the Community Planning Partnership Board in June 2015.

### **DECIDED**:

- a) That the update provided on the indicators be noted; and
- b) That it be agreed that the update be reported to the Community Planning Partnership Board at its meeting on 24 June 2015.

# 6 GREENER RENFREWSHIRE - PROGRESS AGAINST TARGETS AND PROPOSED REVISIONS TO SINGLE OUTCOME AGREEMENT

There was submitted a report by the Interim Head of Public Protection relative to further work which had been undertaken to refine the detail of performance information for future years, building on the experience of the Board to date and refining the level of detail available to the Board in order to monitor progress more effectively.

The report advised that work was ongoing and details of a refreshed suite of indicators were included in the report.

### **DECIDED**:

- a) That the performance against impacted measures as highlighted within the report be noted; and
- b) That the performance measures being used to support delivery of the headline indicators included in the Greener Renfrewshire element of the Single Outcome Agreement be agreed.

# 7 "STREETS FOR ALL" - IMPROVING ACCESSIBILITY OF STREETS, PAVEMENTS AND PUBLIC SPACES IN RENFREWSHIRE

There was submitted a report by Renfrewshire Access Panel/Engage Renfrewshire relative to making streets and public places within Renfrewshire more accessible to disabled people and other people with mobility difficulties.

The report advised that the charity Living Streets published an analysis of statutory

Equality Objectives of Scottish councils called "Streets For All?" which was contained within the Appendix to the report. The report highlighted that by improving accessibility within the environment this would directly benefit a wide range of individuals with temporary or permanent mobility issues, reduce the costs to individuals and public services of preventable falls and would also widen access to public services and the local economy. The Renfrewshire Forum For Empowering Communities proposed to work with the Board to develop appropriate practical actions as proposed in "Streets For All?" to improve the accessibility of streets, pavements and public places.

S Cruickshank advised that Renfrewshire Access Panel would be willing to do a street audit in an area specified by the Board and it was agreed that as the report had already been submitted to the Safer & Stronger Thematic Board and was due to go on the agenda for the Jobs and the Economy Thematic Board that Engage would write to each Lead Officer to identify areas to ensure no duplication. The Board also asked the Access Panel to identify any areas where they considered there were issues and which were appropriate.

### **DECIDED**:

- (a) That the report be noted;
- (b) That it be agreed that Renfrewshire Forum For Empowering Communities develop the work with the relevant Lead Officers to improve the accessibility and attractiveness of streets, pavements and public places, which will contribute to achievement of the relevant equality outcomes in Renfrewshire, as outlined within the report;
- (c) That the Renfrewshire Access Panel identify any areas where they considered there were issues and which were appropriate; and
- (d) That it be agreed that a report with recommendations regarding practical ways to improve accessibility and attractiveness of streets, pavements and public spaces in Renfrewshire be considered at a future meeting of the Greener Renfrewshire Board.

### 8 AN OVERVIEW OF THE ZERO WASTE SCOTLAND PROGRAMME

C Devine gave a presentation relative to the Zero Waste Programme Plan. The presentation highlighted the goals and themes for Zero Waste Scotland for 2015/18; outlined how they would encourage sustainable consumer behavior; why there was a need to improve recycling performance; how they planned to demonstrate the value of a circular economy approach; how they planned to deliver resource efficiency savings; and what the key corporate and strategic goals were.

**DECIDED**: That the presentation be noted.

### **DECLARATION OF INTEREST**

J Wilby having declared an interest in relation to the following item of business, left the meeting and did not take part in any discussion or voting thereon.

### 9 STALLED SPACES SCOTLAND

There was submitted a report by the Lead Officer relative to the Stalled Spaces project which aimed to improve town centres by bringing derelict, vacant or underused land, collectively known as stalled spaces, back into positive use while it was lying unused or awaiting development.

The report advised that two community engagement events were held on Tuesday 12 May 2015 and Thursday 14 May 2015 at Engage Renfrewshire's offices to promote the Stalled Spaces Scotland programme to community groups and educational establishments across Renfrewshire following the allocation of £20,000 of funding to Community Resources as part of the wider Stalled Spaces Scotland programme, managed by Architecture & Design Scotland. The appendix to the report detailed expressions of interest already received from community groups for proposed projects and it was anticipated that there would be a number of applications submitted over the coming weeks which could be considered at the next meeting of the Board.

The Lead Officer advised that an application had already been received and outlined the nature of the application. Following discussion, it was agreed that a short term working group would be set up to score the application and any subsequent forms with the recommendations being submitted to the next Greener Renfrewshire Thematic Board.

### **DECIDED**:

- (a) That the report be noted; and
- (b) That a short term working group be set up to score the application forms with the recommendations being brought to the next Greener Renfrewshire Thematic Board.

### 10 DO YOUR BIT FOR GREENER RENFREWSHIRE

E Borland and J Brown gave a presentation relative to the Warden Service within Renfrewshire.

The presentation highlighted the new community clean up booklet; a number of large clean-up projects that had taken place; the educational workshops that the wardens had delivered; and the engagement events that the wardens had participated in.

**<u>DECIDED</u>**: That the presentation be noted.

### 11 OVERVIEW OF INITIATIVES AND GOOD PRACTICE EXAMPLES

There was submitted a report by the Chief Executive's Service which provided an overview of recent developments, initiatives and funding streams made available to Community Planning Partnerships in Scotland.

**<u>DECIDED</u>**: That the report be noted.

### **RENFREWSHIRE TRANSPORT OUTCOMES REPORT 2015/16**

### 1 Summary

1.1 This report will:

- Inform the Renfrewshire Community Planning Partnership of the preparation by SPT of the Renfrewshire Transport Outcome Report (TOR);
- Highlight the connection between SPT activities and local outcomes from the Single Outcome Agreement; and
- Highlight the focus given within the TOR to the services and benefits that SPT has delivered in 2014/15 together with details of the SPT – Renfrewshire joint work streams for 2015/16.

### 2 Recommendations

2.1 It is recommended that the Board note the contents of the report.

### 3 Background

- 3.1 SPT has prepared a TOR for Renfrewshire annually since 2008 as a means of demonstrating our commitment and contribution as a Community Planning partner through the delivery of key services, projects and initiatives.
- 3.2 The TOR is now directly linked to the SPT Regional Transport Strategy (RTS) Delivery Plan 2014 2017<sup>1</sup> and is the local monitoring and planning element of SPT's suite of strategic plans.

- 3.3 SPT officers worked with Renfrewshire colleagues to agree the key areas for partnership working (known as the 'joint work streams') for 2015/16.
- 3.4 The TOR summarises our commitment and contribution as a Community Planning Partner by detailing the links between the joint work streams and Renfrewshire's local outcomes from the Single Outcome Agreement.

### 4 TOR Content

- 4.1 The detailed content of the 2015/16 TOR is as follows:
  - Working in Partnership This section sets out the 4 RTS Outcomes and the associated joint work streams, as agreed with each council;
  - Improving outcomes for local residents This section explains the relationships between the local outcomes from each council's Single Outcome Agreement and the TOR joint work streams that most support the achievement of the local outcomes;
  - Living and Travelling in the local area This section presents a few key statistics and information about the local area including population and car ownership;
  - SPT Activity and Investments This section highlights the SPT activity including services and initiatives that have benefitted that council area's residents over the past year and capital investments made over the past three years;
  - Measuring progress This section shows a key transport-related measure for each strategic outcome with figures for both the local area and SPT area as a whole;
  - Main body of the document The main body of the TOR includes four sections one for each of the four RTS Outcomes and each section provides a progress update on investments, other work undertaken under each joint work stream and a look at the year ahead. Key supporting statistics are provided<sup>2</sup>;
  - Appendices These sections provide a list of supported bus services operating in the council area during 2014/15 and a list of the 2015/16 capital projects for the council area; and
  - Back cover The back cover includes contact details for the main public transport operators within the council area.

### 5 Joint work streams

5.1 The SPT – Renfrewshire joint work streams for 2015/16 are as follows:

- Bus Policy, Statutory Quality Partnerships & Bus Infrastructure Improvements and Smart & Integrated Ticketing;
- Fastlink, Strategic Rail Enhancements, Strategic Road Enhancements, Freight and Integrating Land-Use and Transport Planning;

Detailed background information for each work stream is located in the RTS Delivery Plan and the 2014/15 TOR Renfrewshire Transport Outcomes Report | 2



- Socially Necessary Bus Services, Access to Healthcare and Equal Access Improvements; and
- Park and Ride, Cycling and Travel Behaviour Change.
- 5.2 The TOR summarises the role of transport in achieving local outcomes. The relationship between the joint work streams and the SOA local outcomes is set out in section 3 of the TOR.

### 6 **Supporting Local Outcomes**

- 6.1 The TOR summarise the role of transport in helping to achieve local outcomes with the following outcomes specifically highlighted:
  - Our children and young people have good physical, emotional and mental health and wellbeing;
  - Our residents will be supported to live independently as long as possible in their own homes and communities;
  - Renfrewshire will be the best connected local economy in Scotland, internationally, nationally and regionally;
  - Renfrewshire will have attractive environments and successful town centres created through successful area regeneration that contribute positively to local economic growth;
  - Carbon reduction; and
  - Our residents will have improved positive healthy behaviours: eat healthier; be physical active; only use drugs as prescribed; and avoid or stop smoking.
- 6.2 The joint work streams that most support these local outcomes are set out in the TOR.

### 7 Prevention

7.1 The work undertaken through the Greener Renfrewshire Thematic Board helps achieve the sustainability of transport across Renfrewshire.

### 8 **Community Involvement/Engagement**

8.1 The Transport sub group within the Greener Renfrewshire Thematic Board involves representatives from the Community Planning Partners.

# Transport Outcomes Report: Renfrewshire 2015/16



### **ABOUT US**

**Strathclyde Partnership for Transport** (SPT) is the Regional Transport Partnership for the west of Scotland and is a partnership of twelve councils. SPT was established by the Transport (Scotland) Act 2005, which created Scotland's seven Regional Transport Partnerships. SPT is the Public Transport Authority for the west of Scotland and is responsible for the development of the Regional Transport Strategy (RTS). SPT is a statutory participant in Community Planning and a 'key agency' in the Development Planning process.

SPT has a range of operational responsibilities including the management and operation of the Subway, bus stations and bus infrastructure, supporting socially necessary bus services, delivering schools transport on behalf of eleven of our partner councils and coordinating the MyBus demand responsive transport service. SPT also acts as the secretariat for the Strathclyde Concessionary Travel Scheme on behalf of our partner Councils and the coordination of ticketing schemes including Subway smartcard and the ZoneCard multi modal scheme.


**Renfrewshire Council** (RC), in addition to wider responsibilities, is the local Roads Authority and Planning Authority for Renfrewshire. RC is responsible for the development of the Local Transport Strategy<sup>2</sup> and Local Development Plan<sup>3</sup> and is lead partner in the development of the Renfrewshire Single Outcome Agreement.<sup>4</sup> RC has a duty to manage and maintain local public roads, footways, street lighting and traffic signals and the powers to improve infrastructure as necessary. RC also has responsibility for road safety and flood risk management.

SPT, RC and partners work together to deliver a range of solutions to enhance and develop our transport network, infrastructure and services; to promote sustainable development; to mitigate and adapt to the impacts of climate change on the transport network and to promote accessible travel choices. This includes investment in and delivery of public transport infrastructure, active travel infrastructure, park and ride and strategic roads projects.

### 1. Foreword

This Transport Outcomes Report (TOR), produced annually by SPT in partnership with each council in the west of Scotland, outlines the impact of transport improvements in each area to achieve more sustainable, healthy, inclusive and resilient communities across the SPT area.

SPT continues to focus on achieving the four strategic outcomes from the Regional Transport Strategy – Attractive, Seamless, Reliable Travel; Improved Connectivity; Access for All; and Reduced Emissions – which underpin the successful delivery of key social, economic, environmental and health outcomes at national, regional and local levels.

One in every three Renfrewshire residents use the bus every week<sup>5</sup> and one in every eight (12%) use a bus to travel to work.<sup>6</sup> It is therefore vital that the public transport network in Renfrewshire – an area that has several bus operators providing more than 60 local services - is stable, safe and integrated to support all residents to meet their everyday travel needs as well as encourage more people to choose public transport. The **Attractive**, **Seamless**, **Reliable Travel** section outlines key progress in this area.

More than 100,000 commuters travel to, from or across Renfrewshire every day<sup>7</sup> and the local economy (including Renfrewshire, East Renfrewshire and Inverclyde) generates around 5% of the Scottish GVA.<sup>8</sup> It is therefore vital that the strategic transport network is efficient, safe and reliable for employees and business; supports regeneration efforts and sustainable development; and is of a standard to attract investment to the area to sustain and grow the economy. The **Improved Connectivity** section outlines key progress in this area.

Transport should enable all residents to meet their everyday needs and live full, independent lives. In Renfrewshire, key accessibility concerns include connecting the one in five local residents who live in areas of high deprivation<sup>9</sup> with employment, healthcare and education opportunities, supporting the growing older population<sup>10</sup> to remain independent and improving links for small towns and rural areas. The **Access for All** section outlines key progress in this area.

Reducing the negative impacts of transport on the environment and on population health remains a priority for SPT and Renfrewshire Council. Carbon emissions from transport in Renfrewshire have fallen<sup>11</sup> and the modal share of car (as proportion of all journeys) has decreased,<sup>12</sup> but much work remains to reduce travel by private car, improve local air quality and encourage more people to walk and cycle more often. The **Reduced Emissions** section outlines key progress in this area.

This TOR outlines SPT's investments, projects and services for the past year and current year. The TOR also sets out the role of transport in achieving improved outcomes for local residents and business in Renfrewshire.

For the longer term, SPT will continue to work with Renfrewshire Council and our other partners on such key initiatives as integrating respective Glasgow and Clyde Valley City Deal projects to maximise socio-economic benefits of this major investment; to plan new transport infrastructure to support sustainable economic growth; and to deliver material change to the regional bus market and public transport ticketing to realise safe, integrated, affordable and stable public transport services for all.

### 2. Working in partnership with Renfrewshire

The 2015/16 Transport Outcomes Report follows the same structure as last year's report, with the principal sections based on the four strategic outcomes and the associated joint work streams, which fall from the Regional Transport Strategy Delivery Plan 2014-2017. These are set out in Figure 2.1 below. This year's report provides an update on the joint work streams, whilst the 2014/15 TOR and the Delivery Plan provide additional background information on the work streams.

SPT and Renfrewshire officers agree the joint work streams each year, with the key change for 2015/16 being the inclusion of Freight. The principle of the 'joint work streams' underlines the shared responsibility of delivering the projects and services that support each strategic outcome, whether through policy development, stakeholder engagement, planning, project delivery or funding.

Services, projects, investments and initiatives that benefit the local area are detailed under each joint work stream within the main body of the report (sections 7 - 10).

### 3. Improving outcomes for Renfrewshire residents

SPT is a statutory participant in Community Planning and works in partnership with Renfrewshire Council (RC) and other partners across a range of themes including health, education, accessibility, social inclusion, equalities and community safety. Our four strategic outcomes are closely linked to Renfrewshire outcomes and support national community planning policy priorities including independence for older people, improving the lives of young people, economic growth, stronger communities, more employment and reducing health inequalities.

The Renfrewshire CPP Single Outcome Agreement 2013 – 2023 has six local outcomes that have a clear role for transport. Figure 3.1 shows these six local outcomes and the joint work streams that support each outcome.

In support of local outcome 1 (as shown in figure 3.1) - Good access to education, healthcare and safe leisure opportunities is essential for every child to thrive and a safe, high-quality walking and cycling network supports young children and their families to be more active and live healthier lives. Sustainable development and land use patterns supports families to reduce car usage and increase active travel, and improves road safety.

In support of local outcome 2 - Safe, accessible transport supports independent living by improving access to services and facilities and reducing isolation by making it easier to visit family and friends and attend social events. Improving conditions for active travel encourages healthy lifestyles. Sustainable development improves local access to goods and services.

In support of local outcomes 3–5 - High-quality, modern transport infrastructure supports physical regeneration efforts; an efficient, reliable transport network built upon sustainable land use development reduces the cost of transport and congestion for business and residents and supports environmental targets; and good access improves employment opportunities. Sustainable development reduces dependency upon private car.

In support of the sixth local outcome - Good access to services supports residents to realise the full benefits of available healthcare, education and training opportunities. Promoting active travel and investing in cycling infrastructure supports healthy lifestyles.

### 4. Living and travelling in Renfrewshire

This section provides a brief overview of the Renfrewshire population and travel patterns.

### 4.1 Population change

The resident population of Renfrewshire is growing with a small increase (0.2%) between 2013 and 2014. The number of residents aged 75 years or older increase by nearly 3%, or 377 people, and the number of residents aged 30-44 decreased by 2% in the past year. The projected figures indicate largest growth likely to be in residents aged 30-44 and 75 or older, whilst the number of residents aged 45-74 is projected to decrease.

### 4.2 Urban – Rural composition

Nearly nine in every 10 Renfrewshire residents live in urban areas, which make up about one-fifth of the Renfrewshire area. One in every twenty residents live in rural areas, which make up more than three-quarters of the Renfrewshire area.



### 4.3 Access to car

More than one-third (34%) of households in Renfrewshire do not have access to a car and more than half of all households (57%) located in the most deprived areas in Renfrewshire do not have access to a car. Approximately one in every 8 households (12%) in Renfrewshire's rural areas or small towns does not have access to a car. Figure 4.1 provides further detail.

### 4.4 Travel demand snapshot – commuting trips

Around 100,000 commuters travel from, to or across Renfrewshire on an average weekday. Figure 4.2 shows the commuters' origins and destinations by local authority area.<sup>21</sup>





### 7. Achieving 'Attractive Seamless Reliable Travel'

### 7.1 Bus Policy

SPT continues to progress its '10 Point Plan' for bus policy, which sets out a menu of proposed changes to legislation, regulations and powers, which would strengthen the role of Public Transport Authorities like SPT in delivering a better offering for bus passengers and a more active return for the considerable public sector investment in the bus market. A key progression this year has been Transport Scotland's consultation on proposed changes to the bus registration process, which were very much in line with SPT's 10 Point Plan. SPT will continue to work with the national Bus Stakeholder Group and other partners to progress our bus policy initiatives.

### 7.2 Statutory Quality Partnerships & Bus Infrastructure

In 2014/15, SPT service compliance inspectors identified 55 breaches of traffic regulations and made 2 reports to the Traffic Commissioner across 21 days of local service monitoring in Renfrewshire. SPT inspectors checked 6,749 vehicles and made 1 report to the Traffic Commissioner across 125 days of monitoring within the Paisley SQP. These breaches include instances of engine idling, illegal parking and services not operating as registered. Inspectors will continue to undertake local monitoring throughout 2015/16.

SPT bus station staff managed 135,000 departures at Buchanan Bus Station and 31,000 departures at Greenock Bus Station for bus services operating within Renfrewshire during 2014/15.

In 2014/15, SPT maintained 1,020 bus stops under agency agreement and maintained 897 SPT-owned, pole-mounted information cases in Renfrewshire. SPT delivered 8 new stops, 42 bus stop pole upgrades and 86 bus stop graphics upgrades in 2014/15 with £20,000 from SPT capital programme. SPT will seek to deliver further upgrades in 2015/16.

Renfrewshire Council delivered a variety of bus infrastructure improvements across Renfrewshire including within the Paisley SQP with £400,000 investment from the SPT capital programme in 2014/15.

RC will seek to deliver a new bus hub for Paisley town centre and further infrastructure improvements on bus corridors throughout Renfrewshire with £1.4 million of SPT capital funds in 2014/15.

SPT will continue to monitor the Paisley SQP and to work with RC and bus operators to make further improvements to bus travel in Renfrewshire for the benefit of passengers including extending the existing sQP boundaries beyond Paisley.

In the longer term, SPT will seek to extend real time passenger information across the region as part of the Strathclyde Bus Investment Programme - SPT's £30 million City Deal project.

### 7.3 Smart and Integrated Ticketing

SPT continues to promote ZoneCard integrated ticketing products and provides administrative and secretarial support to the ZoneCard Forum. Renfrewshire residents bought an estimated 23,000 ZoneCards and made around 1,100,000 trips using a ZoneCard in 2014/15 – saving Renfrewshire residents an estimated £670,000.

SPT is working with ScotRail to integrate rail and Subway ticketing systems in 2015/16, allowing passengers to pay for rail or Subway travel with either ScotRail or Subway smartcards. Additionally, a substantial proportion of the Strathclyde Bus Investment Programme is targeted towards developing an interface with commercial bus operators with the aim of establishing fully integrated ticketing across all public transport modes.

Figure 7.1 Bus mileage in Renfrewshire<sup>26</sup>






Figure 7.2 Use of local bus services (adults aged 16+ living in Renfrewshire), 2012/13<sup>27</sup>





### 8. Achieving 'Improved Connectivity'

### 8.1 Rail

SPT will continue to work with RC to develop the case for rail enhancements across the area including possible service improvements as part of the wider network improvements to be delivered by rail partners.

SPT, through the West of Scotland Rail Forum, West of Scotland Transport Integration Forum and other engagement activities, will continue to co-ordinate and lead on regional input to the ScotRail franchise including service and timetable changes, fares and ticketing; investment in rail infrastructure; network planning; and new station development.

In the longer term, improved sustainable access to the airport remains a key priority and this is reflected in the projects agreed as part of Glasgow and Clyde Valley City Deal, with RC and Glasgow City Council as joint lead partners.

### 8.2 Roads & Freight

In 2014/15, RC completed design works for road safety improvements at Inchinnan with £32,000 investment from the SPT capital programme.

In 2015/16, RC will seek to construct the junction improvements at Inchinnan to improve road safety for all users including passengers waiting for buses on the A8. The SPT Partnership may consider approving £400,000 in capital funds for this project later in 2015.

### 8.3 Fastlink

In 2014/15, Renfrewshire Council progressed detailed design works for the Fastlink extension between the new South Glasgow Hospitals campus to Renfrew via Braehead with £104,000 in funds from the SPT capital programme.

In 2015/16, SPT will continue to support RC in taking forward proposals for the 'western approach' (Renfrew via Braehead) to the new South Glasgow Hospitals campus.

### 8.4 Integrating Transport and Land Use Planning

In 2014/15, SPT worked with RC and developers to provide advice and input on the development of local bus services, integration of public transport, provision of public transport information and development of active travel routes for the Royal Ordnance site at Bishopton and developments at Braehead. SPT worked closely with Clydeplan team in providing input for the development of and responded on the Strategic Development Plan Main Issues Report.

In 2015/16, SPT will continue to work with the Council and developers to ensure that sustainable transport measures are embedded in the delivery of new development and with the Clydeplan team to ensure that the relationship between transport and land use planning at the regional level remains at the heart of the proposed Plan. This includes a review of the key corridors at the heart of the West of Scotland Conurbation Public Transport Study, which provides the transport plans that underpin the Clydeplan spatial development strategy.

Additionally, as part of the City Deal, RC is lead on two major projects – Clyde Waterfront / Renfrew Riverside and the Glasgow Airport Investment Area – in addition to the airport access project referred to above. Ensuring appropriate transport improvements are delivered as part and in support of these significant land use projects will be central to their success, and SPT is working with City Deal partners to maximise the opportunities from these investments.

Figure 8.1 Patronage at rail stations in Renfrewshire<sup>29</sup>





Figure 8.2 Traffic volumes on roads in Renfrewshire<sup>30</sup>



### 9. Achieving 'Access for All'

### 9.1 Socially necessary Services

In 2014/15, SPT supported 16 local bus services in Renfrewshire on contracts that carried 365,000 passengers in total. SPT MyBus services in Renfrewshire carried 30,000 passengers.

In 2014/15, SPT managed 168 school bus contracts on behalf of Renfrewshire Council that transported 3,600 children to school every school day. SPT compliance inspectors made 219 inspections on site at schools, SPT vehicle examiners inspected 249 vehicles operating on school contracts and SPT processed 244 Disclosure Scotland clearance applications for potential drivers on school contracts.

In 2015/16, SPT will continue to provide socially necessary services in Renfrewshire to support greater access to education, employment, healthcare, shopping and other travel purposes.

### 9.2 Access to Healthcare

In 2014/15, SPT supported NHS Greater Glasgow and Clyde to roll out local bus information and directional maps at hospitals and key healthcare facilities. SPT also supported local bus services that provided direct access to Royal Alexandria Hospital and Vale of Leven Hospital, provided MyBus services for healthcare appointments and supported the Glasgow Hospital Evening Visitor Service.

In 2015/16, SPT will continue to provide socially necessary bus services and MyBus services and support Community Transport services to improve access to healthcare.

### 9.3 Equal Access


In 2014/15, the SPT Mobile Travel Centre made 20 visits to Bridge of Weir and Bishopton to provide travel advice and information to residents. SPT Travel Centre staff helped 1,063,000 people with travel enquiries and SPT maintained 7 Travel Points in Erskine, Johnstone, Paisley (2), Renfrew, Royal Alexandria Hospital and University of the West of Scotland campus to provide public transport timetables and journey planning information in easily accessible locations.

In 2014/15, RC delivered improvements to footpath links to bus stops and high access kerbs at bus stops to improve access onto buses. In 2015/16, RC will seek to deliver more high access kerbs and other access improvements for bus passengers as part of the £350,000 in approved SPT capital funding for bus infrastructure improvements in Renfrewshire.


In 2014/15, Renfrewshire residents saved an estimated £550,000 on rail and Subway travel through the Strathclyde Concessionary Travel Scheme and SPT processed 2,400 National Entitlement Card (NEC) applications or renewals on behalf of RC and handled 6,200 enquiries on NECs from Renfrewshire residents. SPT will continue to deliver these services in 2015/16.


Figure 9.1 Supported bus services in Renfrewshire, 2014/15 (indicative network)

## 10. Achieving 'Reduced Emissions'

### 10.1 Park and Ride

In 2014/15, SPT, Renfrewshire Council, Transport Scotland and ScotRail worked in partnership to deliver an extension to Johnstone rail station park and ride. SPT provided £985,000 in capital funds to support the project, with further financial contributions from Renfrewshire Council and Transport Scotland.

Johnstone park and ride is one of the most heavily used park and ride sites in the SPT area and the expansion brought total capacity to 425 spaces, helping accommodate the extensive demand from commuters and other travellers.

SPT will work with Renfrewshire to develop proposals for improved park and ride at other locations including Hawkhead and Bishopton, which are priorities in the Renfrewshire Local Development Plan.

## 10.2 Cycling

In 2015/16, RC will complete design works to support delivery of cycle network infrastructure across Renfrewshire with £55,000 in capital funding from SPT. Additionally, SPT will support the development of the local cycling strategy and support the delivery of the Renfrewshire Community Planning Greener Transport Sub Group Action Plan.

### 10.3 Travel Behaviour Change

SPT will continue to support car sharing through JourneyShare, which currently has 4,635 members across the region, and will continue to promote best practice in sustainable travel promotion through the Sustainable Travel Group, of which Renfrewshire is a member. Topics in 2014/15 included Smarter Choices, Smarter Places; Community Links funding; local cycling strategies; cycle routes to the South Glasgow Hospitals; integrating rail and active travel; delivering cycle friendly campuses for tertiary education institutions; and influencing travel habits.

SPT will continue to support the season ticket employer loan scheme; to encourage mode shift for commuter journeys through Bike Week, Walk to Work Week and the Cycle to Work scheme; to improve conditions for cycling and walking through the SPT capital programme and will provide travel planning support within available resources.

Figure 10.1 Park and ride sites and capacity in Renfrewshire, 2014




Figure 10.2 Number of bicycles available for private use by households (in Renfrewshire), 2012/2013<sup>33</sup>





Figure 10.3 Frequency of walking in past week as a means of transport (adults aged 16+ in Renfrewshire), 2012<sup>34</sup>

## **STALLED SPACES SCOTLAND - UPDATE**

## 1. Summary

1.1 Stalled Spaces Scotland: Renfrewshire received one application in the first round of funding following the June 2015 deadline. It is expected that further applications will be submitted for consideration by the Board following the August 2015 deadline.

## 2. Recommendations

## 3. Background

- 3.1 Community groups have been invited to apply for £250 £5,000 to bring derelict or vacant land back to temporary use within the Renfrewshire area as part of the Stalled Spaces Scotland programme. 75% of projects funded must be town centre based, and applications will be assessed by the Greener Thematic Board, having been initially assessed for essential criteria by the Greener Thematic sub-group. It is anticipated that the majority of awards will be for projects between £250 and £2,000.
- 3.2 The application form, guidance notes and scoring matrix are available on the Renfrewshire 2023 website (<a href="www.renfrewshire2023.com">www.renfrewshire2023.com</a>). The scoring matrix will be used by the Greener Board to assess each application.



#### **Community Involvement/Engagement** 4.

- 4.1 Community groups were invited to attend two community engagement events in May 2015, where data was collected from organisations interested in applying to the programme. Following these engagement events, one application was received by the June 2015 deadline, however further negotiation with the community group will be necessary to ensure that the Stalled Spaces criteria is met before the application is granted.
- 4.2 Representatives from Engage Renfrewshire and Renfrewshire Council are currently in the process of discussing potential applications with community groups. We will continue to work with community groups to help them in the completion of their applications.

# LOCAL GREEN NETWORK PROJECTS UPDATE GREENER COMMUNITIES SUB-GROUP

## 1. Summary

1.1 This report provides a review of the Renfrewshire Council Local Green Network projects delivered in 2014/15.

## 2. Recommendations

## 3. Background

- 3.1 The improvement of Green Networks is a key element of the Renfrewshire Local Development Plan and in recent years a successful programme of projects has been delivered for the benefit of communities across Renfrewshire.
- 3.2 In 2014/15 seven projects were completed, the largest of which was the 'Grand Fountain: Interpretation and Restoration Project'. The remaining completed projects comprised:
  - Linwood Lade Phase 4,
  - Renfrew Riverside Walkway study,
  - Lighting the National Cycle Network through Saucelhill Park,
  - Improvements to the lighting and new benches in Fountain Gardens,
  - various small scale access projects concentrating on Core Paths, and
  - various small scale green network upgrades.



3.4 As with previous years, Local Green Network projects continue to focus on creating green links, improving access and interpretation, and environmental improvements.

## 4. Benefits

5.1 Local green network projects aim to create, improve and extend access routes for active travel, recreational walking and cycling. In addition, projects address community safety by improving lighting, cutting back vegetation and improving sight lines as well as improving biodiversity and preventing damage to property through woodland management. The restoration of the Grand Fountain has increased activity in the park as well as preventing the loss of the category A listed fountain.

## 5. Community Engagement

6.1 Community engagement is a key component of the delivery of green network projects, demonstrated by the involvement of community groups in the Grand Fountain project, the success of work carried out by the Conservation Volunteers on various sites throughout the area and the involvement of over 1000 school children in the delivery of the Activity Plan for the Semple Trail Heritage Project.

## 6. Resources

4.1 Funding for the delivery of projects in 2015/16 is secured within approved Council budgets and external funding opportunities will continue to be maximised.

#### 5. **ELECTRIC VEHICLES AND CHARGING POINTS IN RENFREWSHIRE**

D Burnie provided information on electric vehicles. He confirmed that Transport Scotland have paid the gap funding to enable electric vehicles to be purchased for Renfrewshire Council's fleet, which will have a total of 22 electric vehicles in this financial year. This gap funding has been reducing due to the cost of electric vehicles becoming more in line with traditional vehicles. C Roxburgh confirmed that the first electric vehicle for UWS is due for delivery and that they would be keen to take advantage of any further funding opportunities for electric vehicles through Transport Scotland.

D Burnie confirmed that Transport Scotland funding is only available to public sector organisations but the Energy Savings Trust could be approached for funding for other organisations.

D Burnie provided an update on electric vehicle charging points. He met with a representative from an organisation called Charge Your Car and confirmed that a map is available on their website showing the location and details of all charge points in Renfrewshire. Transport Scotland are currently funding all electricity used at publicly funded charging points but once this funding ceases, procedures will require to be put in place for recovering costs.

- To ensure there is a link with what's happening at ground level and the priorities of the Community Plan.
- Encouraging local groups and organisations to sign up to the Greener Pledge, receive the quarterly Green Newsletter and have the opportunity to participate in the annual Community Planning events.

#### 2 MINUTES OF PREVIOUS MEETING

There was submitted the Minute of the meeting of the Greener Communities sub-group held on 23rd April 2015.

**ISSUES**: An update was requested on the progress of the Green Newsletter. JB confirmed that Alan Bradford of Renfrewshire Council's communications team is presently working on the development of the Renfrewshire 2023 website. All community planning partners are asked to submit contributions for the website relating to events/initiatives being carried out in their organisations. Alan will then create a newsletter based on these contributions. JB also advised that training is available for website authors . It was also noted that the Green Newsletter should not conflict with the newsletter which is currently issued by Steve Edwards in relation to Growing Grounds.

JB also referred to the headline and supporting indicators relating to Greener Communities from the Greener Renfrewshire element of the Single Outcome Agreement and asked that all members of the group advise if they have any comments/ suggestions relating to the measures and targets being used.

#### 4. **MEMBER UPDATES**

## **Local Energy Action Plan (LEAP)**

SD provided an update on some of the work being carried out by LEAP. The organisation is funded through the Climate Challenge Fund, with guaranteed funding to March 2016. Some of the work carried out includes:

- Work in energy transport education. The LEAP car share club is an example of this. This is now a self sufficient project and is not reliant on any external funding but assistance is required to sustain the project through provision of locations and electric charging points for the cars.
- Energy advice is provided to rural communities including the installation of external wall insulation. LEAP can only provide assistance for domestic properties but they have been approached by community groups looking for advice and assistance relating to energy efficiencies for commercial properties or for taking on void council properties, so there is a need which requires to be met.
- The group is currently aiming to expand into adult education to offer workshops which would generate an income – e.g. boatbuilding.

## **Eadha Enterprises**

PL provided an update on the work of Eadha Enterprises. The social enterprise was founded in 2011 with initial funding from Oxfam but no core funding at present. It is a registered charity with one paid member of staff. Eadha Enterprises run a small aspen tree nursery in Lochwinnoch and works with local groups, such as Kibble, to provide Level 1 City & Guilds Horticulture qualifications. They have already delivered a number of woodland projects across Renfrewshire and beyond.

Eadha Enterprises are looking for opportunities to deliver projects relating to woodlands, on their own or in partnership with other organisations. Proposals have been submitted in respect of a community woodland at the Linwood Moss landfill site and for woodland at the former ROF site in Bishopton.

A key issue for the group at present is to obtain a key, designated site to base their operation, which must be at least ½ acre and have a water supply. It is hoped that the Council has a suitable vacant derelict site which could be used.



## **Forestry Commission**

DS confirmed that there is currently a Land Management Plan Consultation ongoing until September – once finalised, the results will be published on the Renfrewshire 2023 website. This was previously known as a Forest Design Plan but the name has been changed to better reflect the management of the sites, especially those within the central belt and communities. (There are currently 6 sites across Renfrewshire).

DS also confirmed he has contributed to the consultation relating to the new Renfrewshire Outdoor Access Strategy. This will replace the strategy which was approved in 2004 and will reflect the changes in policy both at a government and local level since its implementation in 2004. Further consultation on the strategy will take place in September prior to submission to Board for approval.

### DECIDED

- Information to be shared with the group relating to any assistance which could be offered to community groups to make their premises more energy efficient.
- SM to discuss availability of vacant derelict sites in Renfrewshire with PL.
- Opportunity to contribute to the Renfrewshire Outdoor Access Strategy or to find out more information: corepaths.pt@renfrewshire.gov.uk

## ENERGY EFFICIENCY AND WASTE MANAGEMENT IN RENFREWSHIRE HOUSE

## 1. Summary

- 1.1 Renfrewshire Council's Energy Asset Unit is continually striving to reduce costs, energy use and carbon emissions across the council, through its assets and staff.
- 1.2 To measure attitudes to energy usage, waste collection, recycling and travel-to-work, a survey was conducted in July 2015 with Renfrewshire House based Renfrewshire Council employees.
- 1.3 The survey was intended to provide baseline measurements of prevailing attitudes ahead of a promotional campaign to recruit Green Champions to help engage the wider staff group in energy efficient and other 'green' measures within the workplace.

## 2. Recommendations

2.1 It is recommended that the Greener Renfrewshire Thematic Board notes the work being carried out by Renfrewshire Council's Energy Asset Unit and Waste Services to raise awareness of energy efficiency and waste management in Renfrewshire House.

## 3. Background

3.1 All Renfrewshire Council employees in Renfrewshire House were invited to participate in a survey, in July 2015 to measure attitudes to energy usage, waste collection, recycling and travel-to-work.



- 3.2 As part of the survey, staff were invited to volunteer to be a Green Champion, with the purpose of promoting energy efficiency measures, improving waste management and encouraging recycling amongst their colleagues. 16 staff members from Renfrewshire House volunteered to take up this role.
- 3.3 The survey received a very healthy response rate with almost 300 employees participating which compares favourably with similar staff surveys. The high response rate suggests that these are issues of significant interest to employees – some feel positively about current efforts, while others are critical, but there are certainly high levels of engagement.
- 3.4 It was noted in the results of the survey that the processes in place to recycle paper, cardboard, glass, cans and plastic are broadly categorised as 'excellent' or 'good'. There is, however, a much lower awareness of how to recycle glass.
- 3.5 A significant percentage of respondents (29%) were unable to describe their levels of energy usage at work. This suggests it would be a useful engagement and educational exercise to highlight a typical individual's energy usage within the workplace.
- 3.6 Almost 60% of respondents confirmed they travel to work alone, by car. This underlines the requirement to encourage staff to switch to greener methods of transport. This issue has been identified through the work being carried out by the Greener Transport sub-group.
- 3.7 Almost 80% of all respondents consider the cost of energy usage to be equally as important as the environmental implications.

#### 4. Resources

- 4.1 The annual energy costs for Renfrewshire House in 2014/15 were £425,000 but more than half of the respondents assumed it would be less than this.
- 4.2 A total of 76 tonnes of waste were collected in Renfrewshire House in 2014 although more than half the respondents thought it would be less than this. 43% of this waste was recycled, although almost a quarter of respondents expected the recycling rate to be higher than this.



## 5. Prevention

- 5.1 A number of actions have been agreed following analysis of the survey results to address the issues raised and suggestions received.
- 5.2 Green Champions are to be recruited across Renfrewshire House for the purpose of increasing awareness of energy usage, waste management and recycling within the building. Examples of this are: identifying equipment which is left on unnecessarily (e.g. monitors); promoting the use of recycling bins; and providing a point of contact in every area of Renfrewshire House to provide advice and information on energy usage, waste management and recycling.
- 5.3 A Green Champions' Working Group is being established which will help share successes in increasing awareness of energy and waste issues within Renfrewshire House and help to reduce overall consumption and increase recycling.
- 5.4 A council-wide Carbon Awareness Campaign is being planned with strong visuals which will provide staff with instantly recognisable messages on how to reduce carbon emissions.
- 5.5 Options are being investigated to roll-out the Green Champion model and Carbon Awareness Campaign to other council venues, particularly schools.
- 5.6 The current Cycle to Work Scheme is being actively promoted to all Renfrewshire Council employees to encourage more employees to cycle to work, therefore, helping to reduce the high percentage of lone car journeys.

## 6. Community Involvement/Engagement

6.1 It is intended that the ongoing work in Renfrewshire House to raise awareness and change attitudes towards energy use and carbon emissions can be rolled out across all Renfrewshire Council employees and assets. Good practice will be shared with our Community Planning Partners with the aim of changing attitudes to energy usage, waste collection, recycling and travel-to-work throughout Renfrewshire.

## **Good Practice Examples**

## Strathclyde Partnership for Transport (SPT)

### \*FOR INFORMATION ONLY\*

Strathclyde Partnership Transport (SPT) has provided £10,000 funding towards the latest version of the Traveline Scotland app, which features an easy-to-use, dedicated 'Travel to Hospitals' section. This offers instant information on transport links available to hospitals across Scotland at the tap of a screen and is particularly relevant with the opening of the new Queen Elizabeth University Hospital in Glasgow. With space for 750,000 patients and more than 10,500 staff, it is vital that the large volume of people accessing Europe's largest hospital can easily access travel information.

SPT Director of Bus Operations Ronnie Park said: "SPT recognised the need to have the app updated and available on all relevant smartphone platforms well before NSGUH opened its doors. With several existing NHS facilities being merged into one campus, the number of new public transport users is likely to significantly increase, so having a simple and seamless source of information is absolutely essential."

Using the new feature, users can easily pick their NHS destination from a list of pre-defined locations, which will plan their journey right to the door of that facility. For the new Queen Elizabeth University Hospital in Glasgow, this will take staff and visitors directly to the new bus facility at Arrival Square on the campus.

## **Glasgow City Council**

Glasgow City Council hosted an event in July highlighting the various Affordable Warmth programmes available for homes and businesses in the city, that offer both reduced energy costs, tackle fuel poverty and a reduced impact on the environment.

The council's Affordable Warmth team outlined, to an audience of housing associations, the available programmes, such as the Home Energy Efficiency Programme for Scotland Area Based Schemes (HEEPS ABS) and the Energy Company Obligation (ECO) funding and initiatives using cutting edge technology and renewables such as district heating, biomass, Ecopod projects and innovative programmes for insulating Glasgow homes. The council's Energy Efficiency Loan Scheme (EELS) provides interest free loans to help owners participate.

This council team is unique in Scotland firstly because of its focus on all homes in the city, not just public sector stock, and secondly its assistance to housing associations through the drawing



together of complex funding packages for Affordable Warmth projects which could not be accessed otherwise.

### The Scottish Government

Construction work has started on a state-of-the-art biomass facility on the site of a former paper mill at Guardbridge in Fife. The site will be constructed using only wood from sustainable local sources and will pump hot water from the plant four miles underground to heat and cool laboratories and student residences in St Andrews.

The green energy centre which is being delivered by St Andrews University will help to regenerate north east Fife by creating more than 225 jobs in the construction phase.

The University has developed the Guardbridge Guarantee as part of the project. This ensures that the project supports apprenticeship and graduate training, creating and sustaining jobs while working with the local community to promote environment and energy projects and local business.

## The Scottish Government

Communities from inner city Glasgow to western Harris are set to benefit from £500,000 in funding for demonstrator projects designed to encourage the use and local ownership of renewable energy.

A third of the 23 projects are specifically focussed on town and city areas, building on the already established trend for community ownership of renewable energy sources in more rural areas.

Energy Minister Fergus Ewing announced in June that community and locally owned energy capacity in Scotland could generate enough electricity to power approximately 100,000 domestic households.

This is the second allocation made from the Scottish Government's Local Energy Challenge Fund, which confirms Scotland's position as a global leader in renewables and low carbon development. Each project has received funding of up to £25,000 for feasibility work and, if successful, may be able to compete for significant capital support.



## Keep Scotland Beautiful

Keep Scotland Beautiful has secured future funding from the Scottish Government to continue to develop and manage the Eco-Schools Scotland programme, which 98% of schools are engaged with.

Keep Scotland Beautiful will receive £440,000 of funding to manage the Eco-Schools Scotland programme and develop new activities to support educators, children and young people to engage with learning for sustainability and will reshape Eco-Schools Scotland around the needs of learners and schools.

Eco-Schools is the largest sustainable schools programme in the world and is operated internationally by the Foundation for Environmental Education (FEE).



## Research and Consultations

### **Scottish Government**

A consultation has been carried out by the Scottish Government in respect of Permitted Development Rights for Non-Domestic Solar Panels and Domestic Air Source Heat Pumps. This consultation paper sets out proposals that increase the number of situations in which solar panels on non-domestic buildings (those that are not homes) and air source heat pumps on domestic buildings (homes) can go ahead without first having to seek planning permission through making a planning application to the planning authority for the area.

Permitted development rights help provide certainty about what development can proceed. Permitted development rights can reduce costs for applicants and building owners by removing the fees and costs associated with the planning application process. The consultation closed on 27<sup>th</sup> August 2015.

## Scottish Environment Protection Agency (SEPA)

SEPA is carrying out a consultation to provide the opportunity for stakeholders to give their views on their revised enforcement policy and new guidance on enforcement. The Regulatory Reform (Scotland) Act 2014 (RR(S) Act) has enabled the Scottish Ministers to give SEPA the power to impose fixed and variable monetary penalties and accept enforcement undertakings (the enforcement measures). The enforcement measures form part of the new environmental enforcement framework for Scotland that will enable more proportionate and flexible enforcement and will help ensure that SEPA have the right tools to change the behaviour of those who continue to perform poorly or ignore their responsibilities, and will help to tackle non-compliance at an earlier stage before it becomes entrenched.

The consultation is open until 22 October 2015 and can be accessed on the SEPA website.
