Replacement cost is approx £7000 incl VAT. We have applied for funding from the Scottish Landfill Communities Fund and hope that some funding will be awarded, allowing us to maintain our programme of necessary maintenance and improvement projects. The SCLF requires a Contributing Third Party payment of £690, which cannot come from us. We hope that the LAC can assist with this sum. The Cornerstone has gas-fired central and water heating systems. Annual safety inspections have identified that the main is leaking, previously within acceptable limits, but now requires replacement before August 2018. The current rate of leakage (external to the building) does not present any safety hazard to Hall users, but failure to renew the pipe will result in disconnection of the supply, rendering the building largely unusable. Quotes for the necessary repair works have been obtained from 3 contractors to establish a budget cost for the works. The repairs will completely replace the leaking pipe, including increasing capacity for later possible improvements to the heating system. The works involve excavation and replacement of the existing pipe, necessitating lifting and relaying an area of the mono-blocked car park. Contractors with appropriate competencies will be employed. 1. Avoidance of enforced shut down of heating and hot water systems. 2. Provision of increased gas supply capacity

A condition of the Award is that the Club must connect the facilities to the utilities at its cost. With this initial support the Club will be able to re-establish and maintain Ardgriffe Football Park for the use of the Community and to provide a home ground for its 200 players over 11 age categories. The Football Park is not viable without changing facilities. There are currently no grass parks that developmental or competitive football can be played in the Houston or wider Gryffe area (villages of Bridge of Weir, Houston, Brookfield and Crosslee), and a significant current projected under provision in the wider area. Ardgriffe Park has been earmarked as surplus to Local Authority requirements.</p> <p>Houston United FC successfully applied to the Property Board on the 23rd August 2016 to return the park to its original and intended use for the benefit of the community and following public notices without objection, have agreed an initial 10 year lease. Public Notices have been placed mapping the location of the facilities and received no objection. On the 26.02.18 plans were submitted by Andrew Murray FRICS to the LA which outlines the location and construction of the Civil works related to the siting of the changing facilities. Scottish Power Energy Networks will install 230V cable and C Hanlon (Drainage) will connect water to the mains and waste to sewer connections by excavating / backfilling verge adjacent to the location. If achieved, volunteers will carry out the civil works and maintain the football pitch thereafter. In line with Scottish</p>

While Paisley Pirates were successful in finding alternative accommodation at Braehead Arena, the cost of hiring the ice has proved to be prohibitive at almost £200 per hour, causing such activities as junior ice hockey (which had 150 members playing every week) to fall due to insufficient funds, and other activities such as skating to move elsewhere. Pirates have on occasion gone further afield as far as Dumfries simply to find	

available ice; such is the paucity of alternative ice provision in central Scotland. By comparison, Kilmarnock ice rink charges are in the region of £125 per hour. Paisley Pirates have this year appointed a second volunteer coach who has allowed more intensive training to take place, and the Head Coach was appointed to the Scotland Under 17 squad, demonstrating the desire and ability of the coaching strategy to develop young players. The strategy in team matches has also ensured that all players are allocated regular ice time (known as "shifts") to afford them continuous on-ice development. It will enable:

1. The club continuing to provide a local focus for the sport, given that no other suitable venue is currently available.
2. The continued development of on ice skills.
3. The continued development of off-ice skills (eg adults with learning difficulties carry out tasks on match nights requiring numeracy/interpersonal/organisational skills. For example, supporters may arrange coaches to away matches which requires them to set prices, recruit fans to travel, arrange times/pickups, etc.
4. The club to publicise the existence of the Paisley Pirates, an ice hockey team playing within Renfrewshire, through the local media, and maintain a significant profile for the club, the town of Paisley, and the wider Renfrewshire community. For example, the club has been invited for a second time to participate in a project produced by a Canadian tourist company, entitled "42 Best Ice Hockey Towns in Europe", which will see the production of a tourist booklet with a 0.25million circulation, which will publicise both Paisley as a tourist location and the Pirates as an ice hockey club.
5. The club to continue attracting nominations for local volunteer awards. The club has won a number of such awards in past years, the most recent of these being in February 2018.
6. Assimilate new members from the community into its group. It has recently introduced a Mascot, specifically targeting school children in particular, which will visit local schools on request and involve pupils in historical discussions about Pirates, coming to see their local community club and enjoying a healthy lifestyle.

This year due to involvement with other outside agencies we discovered a gap for support for young people with cancer and their parents, and to this end we realised the importance of starting a group for them. It's amazing for us to see the overall wellbeing of the group, through the various degrees of support that is now available within the group. There is a more social contact and friendship with people who have been through a similar journey as they can discuss various aspects of their illness with confidentiality, including financial difficulties experienced through the loss of income whilst going through treatment. We have a walking group which meets once a month for a short walk and new knowledge of the surrounding area, we also have nutritionist and psychotherapist on board and this is proving very helpful with a positive health improvement.
