### <sup>3</sup> LOCAL PARTNERSHIPS REVIEW AND LAUNCH OF 2024 DEVELOPMENT PROGRAMME

There was submitted a report by the Chief Executive relative to the review of Local Partnerships and the launch of the 2024 Development Programme.

The report intimated that Local Partnerships had been established during 2019 and it had been anticipated that these would be reviewed after a period of 12 months, however due to COVID and wider resource pressures, the review had been postponed until September 2023. A consultation and engagement process to inform the next phase of the development of Local Partnerships commenced, with a key focus on building on existing strengths and identifying further opportunities for the Partnerships to grow.

The report advised that the consultation findings had been presented to the meeting of the Council's Leadership Board held on 6 December 2023 with a further report submitted to the meeting of the Leadership Board held on 21 February 2024 when it was agreed (a) that the launch of a new campaign to relaunch the Local Partnerships, which would be implemented from the end of February 2024, be noted; (b) that the refreshed Local Partnership Guidance for 2024 be approved and; (c) that it be noted that future updates on Local Partnerships would be provided as part of the six-monthly reports on community planning provided to the Leadership Board.

#### DECIDED:

(a) That the launch of the new campaign to relaunch the Local Partnerships from end February 2024 be noted; and

(b) That the refreshed Local Partnership Guidance for 2024 be noted.

The term of office for Community Representatives ended at this point in the meeting and the Chair thanked everyone for their participation in the Local Partnership and for the work done locally.

# 6 MEMBERSHIP OF ERSKINE, INCHINNAN, BISHOPTON AND LANGBANK LOCAL PARTNERSHIP

There was submitted an report by the Chief Executive inviting standing members of the Local Partnership to agree the appointment of community representatives to vacant positions within the Local Partnership.

The report intimated that Local Partnerships comprised of an equal number of elected members from Renfrewshire Council and community representatives. Following the review of Local Partnerships in autumn/winter 2023/24, the community representative positions now required to be refreshed and applications had been invited form current and new community representatives.

The report advised that this Local Partnership had seven standing members, being those elected members from Renfrewshire Council representing the Partnership area, as detailed in paragraph 3.3 of the report; that there were seven spaces for community representatives and that active community councils were automatically allocated one of these spaces and paragraph 3.4 of the report detailed the four active community councils in the Partnership area being allocated a space; and that there were three spaces remaining to be filled by community representatives and paragraph 3.7 of the report provided information in relation to the four applications received.

The report detailed the criteria developed to support members on the appointment of community representatives.

**DECIDED**: That Jacqueline Doherty, Langbank Swingpark Regeneration; Hayden Sutherland, Bishopton Community Development Trust; and Ali Whitty, Erskine Arts be be allocated a community representative space on the Erskine, Inchinnan, Bishopton & Langbank Local Partnership.

#### TITLE: Erskine, Inchinnan, Bishopton and Langbank Local Partnership Budget Monitoring Report

#### 1. Summary

- 1.1 Erskine, Inchinnan, Bishopton and Langbank provides funding to community groups to undertake projects. In 2023/24, the Local Partnership awarded £42,200.82 of funding to 14 organisations.
- 1.2 Community groups and organisations funded by the Local Partnerships are asked to provide feedback on their projects as part of their grant agreement. This report provides information on the feedback received from organisations funded by the Erskine, Inchinnan, Bishopton and Langbank Local Partnership in 2023/24.

## Feedback On Erskine, Inchinnan, Bishopton and Langbank Local Partnership Awards 2023/24

Community groups awarded funding from Erskine, Inchinnan, Bishopton and Langbank Local Partnership in 2023/24 were asked to provide feedback regarding the progress of their project and benefit to the local community.

#### FR1127 - Bishopton Week Group

#### Section 2: About the activity you delivered.

#### 2.1 What activities did you provide as part of the Local Partnerships?

We started the week with music from 2 bands in the Community Centre.

The following day we had a mini fun run for under 5-year-olds, a fun run for children and adults and a school pupils chess tournament at the Community Centre.

During the week we held 3 magic shows for children and a children's treasure hunt around the village.

On Bishopton Day there was a parade with 4 large floats with children from each of the Primary Schools and a local team. A pipe band led the parade and children from dance schools walked with it. There was entertainment all day on the stage and in the arena and a large number of stalls with crafts, food, drink, tombolas and children's games. The monthly farmer's market also attended. We had a display from the fire service and from the Royal Marines. The library's Skoobmobile bus also attended, we had a circus skills area and a large area with inflatables.

#### 2.2 What do you think worked well about your activities?

All the events during the week were very well attended. The magic shows sell out quickly.

The parade attracts all ages to watch it go around the village and a lot of preparation is put into it by those involved.

Bishopton Day ran very well with persons in charge of the running order on the stage and in the arena. The stalls were all very busy. It was very well attended.

The move to wristbands with QR codes was very successful resulting in low queues to enter the ground.

#### 2.3 Is there anything that you would change?

We decided not to hold the concert with a band on the first night of Bishopton week this year as although popular, it was not cost effective.

We found that a couple of the children's games and rides were very overpriced so we have decided to change the suppliers this year.

#### Section 3 – Impact

#### 3.1 How many people benefitted from/accessed your project?

(If you have received funding from more than one Local Partnership, please tell us how many your reached in each Local Partnership area)

The concert sold around 80 tickets to over 18-year-olds. The fun run attracted about 250 adults and children. The chess competition involved pupils from 8 schools. 180 children attended across the 3 Magic Shows. Around 50 children and adults participated in the Treasure Hunt.

We estimated that around 7500 attended on Bishopton Day based on the sale of wristbands which is for those aged 16 and over which was about 4000 and the number of children present.

## 3.2 What impact has the Local Partnership programme had on members of your community?

Most of the stalls and nearly all the entertainment were people from the local community including: the primary schools, the Scouts, Girl Guiding, Bishopton Parish Church, the Library, the rugby, football and tennis clubs, Erskine Home, the Rotary club, dance schools and a variety of local small businesses. This enhanced the feeling of community togetherness and it also promoted access to local facilities and support networks.

69 different stall holders attended on Bishopton Day, many with more than one pitch, that doesn't include the library bus, the fire service, the navy and the circus skills. Most have said already that they will return this year.

It was so well organised and the use of field meant it felt like there was plenty of space and stalls without it feeling crowded or empty. Really just a lovely day out- and that's what I've heard from everyone; even my husband (who doesn't really enjoy these things) said it was just a lovely, really nice day.'

'Hi thanks again for organising a brilliant day! Loved it! Can I register my interest for next year please?'

'Thank you so much for yesterday! KA Dance Community had a BLAST! We are emailing to put forward out interest to be included in the parade, have a stall and preform next year for 2024.'

'A+ Dance Academy would like to say a MASSIVE thank you for letting us take part in Bishopton day. We all had the most amazing and fun-filled day!!! Thank you so much for all your efforts and organisation, you put on a great day for everyone! Well done!!!'

## 3.5 Is there anything else that you would like to tell us about the Local Partnerships programme?

We really appreciate the support from the Local Partnerships programme and the fund helped us to deliver a very successful project to the community.

#### FR1099 – Bonnie Bishopton

#### 2.1 What activities did you provide as part of the Local Partnerships?

We purchased six additional street planters for our village. They augmented our existing planters allowing us to complete planters right along the Main Road. We also placed three of them in a row at the border of the Community Centre/Health Centre Road which improved and brightened this area. We bought compost, organic fertiliser pellets, and a variety of plants, shrubs and bulbs.

#### 2.2 What do you think worked well about your activities?

Completing the Main Road with end to end planters (lot of space between them) Improving a neglected horrible area between the Community Centre and the Health Centre Road now villagers walk to the Health Centre past three bright and cheerful planters placed on nice bark. A huge improvement.

#### 2.3 Is there anything that you would change?

Not really. As always we could do with more street planters to have a bigger impact as at the moment they are fairly well spread out. However they are a good choice for us as they contain a water reservoir with capillaries and this makes watering in the heat of summer slightly easier, thus for us the higher cost is worth it as we are not a big group.

We have approximately twenty members who all enjoy our outdoor physical activity and indeed the social aspect of meeting new people and being part of something appreciated by our community.

The local Brownie group assist us each year with planting in some of the planters thereby involving different generations together in a community project.

All of the village benefit as they walk or sit at traffic lights in their car. When we are out working they always peep and give thumbs up to us.

As above really.

The group slowly attracts new members who all bring different things. Many enjoy the physical gardening, others try to help raise funds and many good gardeners grow or split their own plants to add to ours.

Also there is a learning process from listening to the highly experienced and

knowledgable gardeners to the simply keen gardeners. The public often stop and ask us questions about our plants so knowledge is shared with the community.

#### Section 2: About the activity you delivered.

#### 2.1 What activities did you provide as part of the Local Partnerships?

We started art classes, drop-in sessions and an inclusive choir all free and fully staffed by Erskine Arts and sessional workers. These classes have been running every week since receiving the funding and we have continued these classes as part of our growing programme. Some of them we have continued for free and some we have introduced a small fee to keep them sustainable.

#### 2.2 What do you think worked well about your activities?

The new programme has been very well attended and it has helped widen our social reach across our community. We have had some very nice feedback and testimonials from those attending that it has become a life line, especially to those who have been more isolated and found it difficult to engage in culture and to meet new people. With it being group activity, people have developed new relationships and have come to rely on these activities as their new weekly ritual. We have had feedback that the classes are fun and are helping individuals to be encouraged to take up new hobbies later in life. This new activity has also provided a great opportunity to involve new volunteers who have helped to assist with delivery and building community cohesion.

#### 2.3 Is there anything that you would change?

Nothing that comes immediately to mind. The whole programme has been a very encouraging development for Erskine Arts. It has given us the encouragement to reach out to the wider public and it has had a very positive knock on effect to other parts of our programme and live event activity. We only received some of the grant award that we asked for, however we managed to deliver much more than expected even with a reduced amount for a shorter time period (21 weeks instead of 38). It has also led to some intergenerational work starting new mixed aged group classes and bringing young volunteers into help assist with adult classes. It's been brilliant.

Over the 21 week funded period we have had 1534 attendances relating to the funded activity. This has supported an average of around 73 people every week.

## 3.2 What impact has the Local Partnership programme had on members of your community?

It has led to an increase to our overall membership and attendance. This has also had a knock on effect, increasing attendance to our live events, community programming and local consultation projects. In the 21 week period our full attendance stats were 8258. The following 13 weeks following the funded period we have seen 6606 attendances which is already around 1000 attendance up when broken down into average weekly attendance.

#### Section 2: About the activity you delivered.

#### 2.1 What activities did you provide as part of the Local Partnerships?

We purchased brand new mobility equipment with the help of this fund in order to maintain

and grow our current levels of stock to meet Health and Safety regulations, customer demands and further promote our services across Renfrewshire.

3 x Sterling Sapphire 2 Mobility Scooters (These are sturdy and can withstand pavements and heavy usage – with a suite of these scooters we are able to save costs with parts and repairs. We are also using these scooters to conduct surveys of pavements, dropped kerbs and feeding our findings into Renfrewshire Council's Town Centre and Villages Accessibility Forum and our feedback and recommendations are welcomed and actioned)

1 x Lightweight Scooter (for travelling – easy to lift and put in the boot of a car, train, taxi, plane)

2 x Excel G-Logic Lightweight Self-Propelled Wheelchairs 16" (these wheelchairs are proving very popular with Renfrewshire communities)

6 x Sets of Replacement Batteries (The majority of people who need our help when they break down is due to battery problems and in some cases reported, people are unable to afford to pay electricity to charge their batteries. This can place an already vulnerable person in a potentially dangerous situation. Another item we properly consider from a Health and Safety point of view is giving users advice on purchasing safe batteries)

We said we would, and we did:

1. Change our name to Shopmobility Renfrewshire to better reflect reality in the fact that we support the whole of Renfrewshire. We held an event in Johnstone to celebrate and promote our name change with RenSEN. We were acutely aware that assumptions were being made we were only delivering a service in Paisley – hence the call for action.

2. Recruited, and retained, more volunteers and staff. Recruited from Linwood, Johnstone, Bishopton, Inchinnan, Barrhead, Paisley. Often targeting those with barriers.

3. Developed more robust surveys to ensure we ask the needs of those whom we support and change our model of delivery as required.

4. Managed to access free Accelerate Community Enterprise support which will help us will build our small repairs and maintenance service to develop our social enterprise with a view of continuing to provide a low-cost service. Our 5 year plan is to develop the social enterprise of our charity to be less dependent upon grant funding in the future.

5. Accessed, researched and joined more relevant networks who understand mobility disabilities and how working in partnership impacts on lives.

6. We are now delivering 4 pillars of strength (Hires, Repairs, Social Inclusion Events, Advocacy). Our service has increased as well as us having a much more ambitious strategy to meet demands.

7. Going digital to improve our internal / external processes.

We wanted you to understand the bigger picture in terms of what your investment has helped us achieve for the betterment of those with mobility disabilities.

We constantly need to be able to embrace change and adapt, therefore our philosophy has been to plateau income wise, then concentrate on growing the charity with Health and Safety, Human Rights and Equity in mind at all times.

Stability is essential for growth and we have learned this – especially over the last year. Surveys indicate to us more recently that people are looking for lightweight equipment to take with them on holiday, require a delivery and pick up service, plus host more social inclusion events.

We believe we have had the right approach and continuing to develop in a strategic and constructive way – always trying to meet needs and demands – networking and partnership working with the right people and networks.

## 3.5 Is there anything else that you would like to tell us about the Local Partnerships programme?

We are actively pursuing other investors to help us fund many other projects to support our new 4 pillars of strength, in order to be less dependent on Renfrewshire Council funds. This, we are hoping, will enhance our ability to access many more funding streams. We have already reduced our dependence on Renfrewshire Council funders since 2019 from over 90% to 25%. Our long-term aspirations are to further enhance and solidify our social enterprise which takes years to accomplish. Creating stability and growth is an area that Local Partnership funding has helped us with tremendously and this is very much appreciated. We previously purchased a van which is really helping our development and using your investments wisely – always looking at the longer-term picture. Many people tell us that they don't know what they would do without our service and your fund is helping us retain and further develop quite a unique and much needed service in Renfrewshire. With an ageing population, we believe there will be a need to retain such a service.

#### 2.1 What activities did you provide as part of the Local Partnerships?

We delivered a successful Christmas 2023 campaign supporting 3,035 local children with gift packages and distributed £10,420 worth of gift cards to teenagers: 521 gift cards in total.

This Easter we distributed 4,705 eggs to local schools, nurseries, community groups as well as charities that tackle food insecurity.

In 2023 we distributed Halloween costumes too. This provided great feedback as more and more schools are having Halloween discos again or dressing up for the day. We know this helped more children to feel included, helping to reduce financial strain for many. Birthday gifts constantly go out with some organisations having "birthday boxes" that we top up when needed.

## 2.2 What do you think worked well about your activities?

Partnership working is key for the toy bank. This ensures the referral process is transparent, fair and secure. Working together to build connections not only helps us, it allows us to network and know where to signpost community members for other support that we cannot offer.

Having support from libraries, organiations and businesses is a vital part of how we operate, and we cannot thank them enough for making donating as easy as possible for the public.

The toy bank simply could not run without our incredible volunteers. The local people that help us go above and beyond.

## 2.3 Is there anything that you would change?

This year we need to focus on recruiting more volunteers. We will remain volunteer led and do not plan on having staff. We want to ensure our core costs are kept to a minimum, putting everything we can back out to support local families.

71 organisations referred to us – multiple social work departments, local charities, NHS divisions such as health visitors and doctor practices, schools, nurseries and many more.

Renfrew schools and social work - over 400 children.

Johnstone and Linwood social work and schools - over 500 children.

Erskine, Bishopton and Inchinnan health visitors, charities schools -over 300 children

Paisley NWC, East and Glennifer schools and social work been combined due to a high crossover in post codes from social workers from the north and south team – over 1000 children.

The Villages – over 300 children.

# 3.2 What impact has the Local Partnership programme had on members of your community?

The cost-of-living crisis has affected so many and most local charities have reported seeing a change in people accessing their services. The toy bank is no different and we have received feedback from referring partners about the financial strain, embarrassment, and stigma the toy bank helps to relieve. The toy bank is open to all, and we hope our referral system is as simple and fair as possible to continue to support our local community. It has allowed parents and carers the knowledge that their child is receiving high quality safe toys the same as their peers. Sparking joy for our young people while helping them to learn and develop through play.

As well as distributing toys we also provide clothing items such as pyjamas and blankets, something that is being asked for more and more.

# Applications for Local Partnership Funding To Erskine, Inchinnan, Bishopton and Langbank Local Partnership 2024/25

# 1. Summary

- 1.1 Applications for grant funding from the seven Local Partnership areas were invited to be submitted during March and April 2024, to be considered at the Local Partnership meetings due to be held in May and June 2024.
- 1.2 The available allocation for Erskine, Inchinnan, Bishopton and Langbank Local Partnership for 2024/25 is £43,989.00
- 1.3 The Local Partnership has an underspend of £2,519.56 from the 2023/24 financial year, which was unable to spent due to changes in the Local Partnership timetable. It has been agreed that, in the circumstances, this balance can be carried forward to the financial year 2024/25.
- 1.4 From this total budget, a sum of £50 per community representative requires to be ringfenced for potential claim of expenses. These expenses are deducted from the available allocation for the Local Partnership. Erskine, Inchinnan, Bishopton and Langbank has space for seven community members, so the total ringfenced for expenses is £350. The total budget available for allocation by Erskine, Inchinnan, Bishopton and Langbank Local Partnership is therefore £46,158.56.
- 1.5 The total value of applications made to Erskine, Inchinnan, Bishopton and Langbank Local Partnership for funding is £94,613.52.
- 1.6 The Youth Challenge Fund component of Erskine, Inchinnan, Bishopton and Langbank Local Partnership Funding is £20,288.00. This funding will be

allocated by young people through a Participatory Budgeting exercise called Celebrating Renfrewshire that will take place during May 2024, with decisions to be announced in Summer 2024.

## 2. **Recommendations**

2.1 It is recommended that members of Erskine, Inchinnan, Bishopton and Langbank Local Partnership consider the applications for Local Partnership grant funding, as set out below in Appendix 1 and 2.

# 3. Background

- 3.1 Applicants for funding in 2024/25 have been provided with guidance, as well as a description of the Local Priorities identified by the Erskine, Inchinnan, Bishopton and Langbank Local Partnership.
- 3.2 Local Partnership members are asked to consider the applications for funding summarised at Appendix 1 and 2 of this report, and to assess these against the Local Priorities agreed by the Erskine, Inchinnan, Bishopton and Langbank local priorities.
- 3.3 An initial assessment has been carried out by officers to support Local Partnership members in their decision-making. Where applications have made clear reference to the Local Priorities identified by the Local Partnership, this is identified in the first table at Appendix 1. Applications that make a partial or no reference to Erskine, Inchinnan, Bishopton and Langbank Local Priorities are summarised in the second table for example, the project may work with young people (and therefore meet the Local Priority around young people) but not deliver this directly in the Local Partnership area or refer to how many young people from the area would be engaged in the project.
- 3.4 The priorities of the Erskine, Inchinnan, Bishopton and Langbank Local Partnership are:

# Key theme: Intergenerational work

The Local Partnership are particularly interested in building relationships between younger and older communities across the area and exploring how intergenerational work might support their Local Priorities.

## Health and wellbeing

The Local Partnership want to make sure people are aware of and can access health services, to support both physical and mental health. This includes community-led health services too. The Partnership also think tackling social isolation is key to improving health across the area.

# Connectivity

The Local Partnership want to see places across Erskine, Inchinnan, Bishopton and Langbank better connected to each other, and to the wider area. They want to see provision of good quality public transport, but also safe, clean and green routes for walking and cycling.

# **Community identity**

The Local Partnership want to support the individual identity and history of each town and village. A key part of this should be local events which celebrate this identity, and better communication of what's on across the area to support this.

# Planning and environment

The Local Partnership want to be involved in, and influence, planning decisions, and are particularly interested in land ownership and use. The Partnership see this as key to supporting a clean and green area, which includes street cleanliness issues at a local level, but also wider green issues such as low carbon.

# **Community empowerment**

The Local Partnership want communities to be involved in, and influencing, decision making about the area. This includes making sure communities are well informed about local issues and looking at ways to get people involved such as participatory budgeting.
