Building And Strengthening The Local Action Group For The Former LEADER Rural Areas

1. Summary

- 1.1 This note concerns a collaborative programme between Renfrewshire, East Renfrewshire and Inverclyde to recruit new members to a strengthened Local Action Group (LAG) for the Greater Renfrewshire and Inverclyde (GRI) rural areas.
- 1.2 The approach currently being taken regards strengthening the LAG was approved by the Economy and Regeneration Policy Board on 23 August 2022.
- 1.3 The former European funded LEADER programme stopped in 2020, with the UK withdrawal from the European Community. Between 2014 and 2020 it invested some £1.7m, leveraging £2.8m match funding and generated some £4.5m for the area.
- 1.4 With the cessation of LEADER, Scottish Government has been interested in how the approach to rural support and intervention might be enhanced and has invited submissions from former LEADER areas (through the Local Action Groups, on which Councils have sat), for projects to test new approaches to delivering community-led local development and now, in 2022/23, to identify how Local Action Groups might be strengthened with more diverse representation. While funds across Scotland for these projects in 2022/23 have been modest (£11m+), they do lend credence to future funding being made available by Scottish Government to substitute for LEADER once the 2023/24 Scottish Budget is published in December 2022.

- 1.5 The strengthening of Local Action Groups by inviting applications to join has been interpreted to include people and organisations from the geography of the rural areas (e.g. community development trusts, village associations etc.) and from those whose activities are considered to meet equality, diversity and inclusion criteria. Thus, people and organisations in the urban areas who represent e.g. gender, youth, ethnic and other diverse interests, who might want to extend their activities, or want stronger representation in the rural areas, would be appropriate to encourage to apply.
- 1.6 The role of the strengthened Local Action Group and of the new members recruited for their capacity, interest, commitment and skills, are being defined at the present, with each Council, plus e.g. Engage Renfrewshire, participating in a widespread social media recruitment campaign in November. Potentially, the role will include managing funds made available through the Agriculture and Rural Economy Directorate, help strengthen local communities by advocating solutions/ projects/ investment to meet their needs, support and strengthen Councils' funding bids for the area, as well as address emerging local and national level priorities and translate what action should be taken on the ground (i.e. climate emergency and achieving net zero carbon emissions, inclusive growth/wealth building, local capacity building/community support interventions and placed-based delivery).
- 1.7 We anticipate a strengthened Local Action Group of between 10 and 15 people. The Partnerships are asked to help publicise the recruitment opportunity.

1. Summary

- 1.1 Erskine, Inchinnan, Bishopton and Langbank Local Partnership provides funding to community groups to undertake projects. This funding is allocated from the General Grant Fund and, through a Participating Budgeting exercise known as Celebrating Renfrewshire.
- 1.2 A table setting out the funds allocated by Erskine, Inchinnan, Bishopton and Langbank Local Partnership in 2022/23 and current budget position is attached as an appendix to this report.
- 1.3 Projects referred to the Villages Investment Fund at the June 2022 meeting (FR 1118 Bonnie Bishopton and FR1149 Inchinnan Community Council) were awarded this funding.
- 1.4 At the June 2022 meeting, three projects (FR1075 Inchinnan Development Trust, FR1126 Right2Dance and FR1083 Erskine Arts) were awarded funding that was ringfenced subject to additional information. This information has now been received as follows:

Maggie Morrison, Inchinnan Community Development Trust - £10,000 award for FR1075 India Tyres Playing Fields Drainage Solution

Question: Will EIBL Local Partnership receive future applications for the drainage works beyond the £10,000 award?

The drainage project that Inchinnan CDT was awarded £10, 000 for has now been costed as requiring a much larger spend (possibly into the millions), so it's now a much larger programme of work looking at the whole site. Given the scale of the project, Inchinnan CDT would be seeking this funding elsewhere, and don't intend coming back to the Local Partnership for money for drainage.

Maggie asked if the £10,000 resource could be put towards sorting out the utilities for the site. Maggie advised that permission for this would depend on whether the Local Partnership views this as sufficiently close to the purpose of the original spend, otherwise it would have to go out for approval from all members. The other thing that Maggie mentioned was that the utilities couldn't be sorted until the drainage issues are completed, so it seems unlikely that the spend could be completed in 2022/23.

Question: Which groups will get the use of the pitches – will access be available to groups across the EIBL Local Partnership area?

Currently the pitches are used by St Mirren Youth FC and also by dog walkers. In the future, access will be on a paying basis, so any football teams can pay to use the pitches.

Craig Brownlie, Erskine Arts – £6,980 award for FR1083 Music Workshop For Older Adults

Question: How many people will benefit?

“We currently have 14 adult students from the weekly pilot lessons and, with interest expressed and current waiting lists, I expect that we will double this number almost immediately. As we encourage greater participation I would expect to have closer to 40 adults participating across each week.”

Question: Is attendance open to people Local Partnership-wide, i.e. beyond Erskine?

“As for participation, this is open to all residents in all surrounding towns - no restriction at all. We want as many people to benefit as possible.”

Aileen Palumbo, Right To Dance - £5,670 award for FR1126 Right2Dance: Our Story

Question: Should we be paying for the co-ordination?

“The project co-ordination budget line is a contribution towards staff time for the associated co-ordination and administration of the project, such as meetings with the school and other project partners, organising the performance - costumes, tickets etc, and co-ordinating music creation and filming.”

Question: Clarification sought that people won't be charged to watch the show

"We were not planning to charge for tickets for the performance to ensure it is open to all within the community."

2. Recommendation

2.1 It is recommended that:

- (a) the budget monitoring report 2022/23 be noted.
- (b) funding awards previously ringfenced for FR1075, FR1126 and FR1083 be considered for approval on the basis of the additional information provided at paragraph 1.4

Feedback On 2021/22 Projects

The following feedback was received from organisations that were awarded funding from Erskine, Inchinnan, Bishopton and Langbank Local Partnership.

FR1150 - Erskine Youth Council

Project: Youth Space redesign and mural project

Amount Received: £3963.14

We wanted the funding to buy furniture for our youth space and create a LGBT/wellbeing inspired mural on a local underpass to spread awareness and positivity within our community. We wanted to deliver a creative outdoor session at the new interactive playpark such as chalk drawing and outdoor painting. We also wanted to buy a bin for the playpark.

We spent the funding on a new modular seating area for our youth room and on a coffee table and stool to match the seating. We commissioned the artist 'bmore sketchy' to design a youth and community mural with us and create the artwork on our local underpass at Alison Avenue near the Bargarran shops and community centre. We weren't able to do the chalk drawings sessions due to the materials not being suitable for the paths but did lead a lot of outdoor sessions during the Get into summer programme which benefited young people. We were not able to buy a bin as Renfrewshire Council put two bins in place, instead we purchased we purchased two multi coloured large rugs to brighten up our youth space.

All of Erskine community can benefit from the underpass mural artwork

The mural helps brighten up peoples' days walking through the underpass and raise LGBTQ awareness in a community friendly way.

The furniture and rugs we purchased has made the space look brighter and more youth friendly as well as providing comfortable seating in our youth space.

This includes schools across Renfrewshire, meetings, competitions, street stalls, stalls at the University and the podcast among others.</p> <p>Our previous Education officer resigned last year and we appointed a new Officer during 21/22. She has been learning the role and has been very active. This was done in the face of the pandemic and this has temporarily altered the nature of the role.</p> <p>The role of the Education Officer used to involve a lot of work with schools across Renfrewshire and that has been severely limited in 21/22 due to Covid. However, despite the restrictions, many connections have been made and many re-established.</p> <p>During COP26 we ran a well-attended meeting about Fair Trade and the Climate Crisis. We had 3 speakers including a coffee grower from Uganda. Over 50 people attended. https://www.rainbowturtle.org.uk/2021/11/04/climate-change-fair-trade-behind-the-scenes/ https://www.rainbowturtle.org.uk/news/page/2/</p> <p>We also represented Renfrewshire Fair Trade at two COP26 events as well as promoting COP26 in the shop. https://www.rainbowturtle.org.uk/2021/11/04/climate-change-fair-trade-behind-the-scenes/</p> <p>We ran several interviews on our podcast https://www.rainbowturtle.org.uk/our-podcasts/</p> <p>We involved schools in a very popular 'Design a T-shirt' competition which reached over half of Renfrewshire schools. This was part of Fair Trade Fortnight and we also ran a food tasting stall outside the shop in Gauze St https://www.rainbowturtle.org.uk/category/fair-trade-fortnight/</p> <p>We have held stalls and educational events at the University. These have gone down well and increased our reach into the student population.</p> <p>Work within the charity and linked to the Rainbow Turtle shop involved the volunteers and getting them out the house and linking with other volunteers, old and young, and members of the public.</p>

If you have received funding from more than one Local Partnership, please tell us how many you reached in each Local Partnership area)</p> <p>Almost 2,700 children received Christmas gifts, over 750 Halloween costumes were given out, 3,800 easter eggs and over 1000 birthday gifts – a total of 8,250 gifts out in a year to children in Renfrewshire.</p> <p>Providing parents and guardians with new toys and gifts helps to reduce stigma as there are no links to the toy bank as all gifts are of a high quality and quantity, the same as children’s peers. This also helps reduce the risk of families getting into debt at Christmas, knowing that their children will get to enjoy the magic of Christmas.</p> <p>With the rising cost of living providing Halloween costumes has been a vital service this year and feedback from groups and parents highlights this. With school Halloween discos, the toy bank can help reduce financial pressure from families while tackling stigma by providing new high-quality costumes in a range of accessible locations throughout Renfrewshire. The same applies to Easter. Birthday gifts are always given out, as much as I have said above that 1000 children have had gifts we know this number is higher. Organisations that work with have “birthday boxes” with toys and gifts suitable for children that they work with. This model came about due to covid. This means gifts are already with organisations and we provide top ups when needed. We had unexpected repair and maintenance costs, fitting out the back of the van breakdown and pick up costs as well as insurance increases. However; we are very grateful for this money which has enabled us to further develop our social enterprise and ultimately enhance service to members.</p>

The outcome is that we are now able to pick up and deliver mobility equipment locally as well as enhancing our repairs and maintenance service following on and off-site repairs. This can save an individual trying to deal with mentally getting out of their house to navigate public transportation to Shopmobility as we can now deliver to them if that's what they need. We also pick up food from RAMH pantry and deliver to our members and we pay the £1 for a lifetime membership with RAMH – all they do is pay the £2.50 for their shopping. We also deliver and pick up shopping to those in the RAH, pick up prescriptions. We know 73% of our ordinary members are still suffering from social isolation and loneliness (post pandemic), and, live in poverty – they tell us this. Following surveys, the impact is very positive indeed and we deliver a service which our membership tell us they need and receive great benefit from.</p>

If so, please explain).	<p> We wanted to support as many mums as possible within Renfrewshire with breastfeeding during a very difficult period when there were still restrictions in place due to the pandemic. We trained new peer supporters to help sustain our project. Peer supporters are mums who have breastfed and completed our free accredited training in order to support breastfeeding families achieve their breastfeeding goals. Our volunteers provide independent evidence based information which can be shared with their health care provider in a relaxed non judgemental environment. We ran weekly face to face groups, walks and zoom groups. </p> <p> We spent the money on the training and the ongoing supervision in order that they can remain registered and insured. We provided travel expenses to the volunteers when they attend our groups and events, resources required for the groups such as tea and coffee, room hire costs, books, a BfN tshirt as a uniform, equipment for the walks eg first aid kits </p> <p> We attended local community activities at Liliash Day in Kilbarchan and Barshaw Gala Day, Scottish and World Breastfeeding Week and local UWS Midwifery conferences to inform midwives about our services and refer them to good breastfeeding resources. We also hope to be able to return to the postnatal wards in the RAH Maternity Unit to support new mums who have given birth and antenatal sessions in collaboration with local midwives too. </p> <p> Everyone is welcome at any of our events whether pregnant and wanting to find out more, exclusively breastfeeding, mixed feeding or expressing. Mums come along for many reasons, social support, difficulties with getting breastfeeding off to </p>

	a good start, returning to work and breastfeeding, needing help with weaning and a multitude of other subjects.

Please describe the impact your project had on its participants If you have received funding from more than one Local Partnership, please tell us how many you reached in each Local Partnership area)</p> <p>As you will see from the separate feedback comments, mums were extremely appreciative of the breastfeeding and social support provided by our volunteers. Getting out and about is good for everyone’s mental health so having the opportunity to meet up with other new mums at our weekly walk is ideal. A walk in the park helps with some exercise, fresh air and a chat with other mums alleviates loneliness and isolation and can help to boost low mood. Breastfeeding support is vital for new mums who need to connect with another mum who has experienced the highs and lows of having a baby. Our volunteers are all highly trained in evidence based information and to support all mums with feeding their infant.</p> <p>Having the chance to talk to families at events like Gala days is a great way to inform and give support to the wider community eg partners, grandparents and the the mums’ closest support network. We provide a quiet space to sit and rest, feed and change baby or toddler and have a chat with our lovely volunteers about how it’s all going, shelter from the elements and of course a nice cuppa and cake!</p> <p>Walks – 90 mums attended on 42 occasions between 1/6/21 and 31/3/22 (figures available at the moment data collector colleague is on holiday) Bishopton group – 26 attendances on 12 occasions between 28/8/22 and 27/10/22 (figures available at the moment) Station 7 Johnstone group – 46 attendances on 8 occasions between 5/9/22 and (figures available at the moment)</p> <p>Our volunteers have all benefitted from ongoing supervision, ongoing learning and training and the social support they have received from each other. This has helped raise their self-esteem, they have made new friends, it has reduced their own isolation and boosted their mental health by being involved with different activities and families. Being involved in a project by helping others is very motivating boosting both mental and physical wellbeing.</p>

If so, please explain).</p> <p>We employed a Child Play Therapist to assist children between the ages of 5-12 with therapy to improve their wellbeing and worked alongside their school to ensure they were receiving the required treatment. These classes are held weekly and last about 1 hour. These are completely free of charge and they use equipment such as games and toys to assist with their therapy. Another party of the money has been used to send our Child Play Therapist on further training to increase her knowledge of the field which would benefit the children that attend.</p>

Please describe the impact your project had on its participants If you have received funding from more than one Local Partnership, please tell us how many you reached in each Local Partnership area)</p> <p>We have had eight children attend the therapy in the last 18 months since we reopened after lockdown. All of these children have had one-to-one sessions over a period of 4-5 months and if they need to be extended then we do so. We are striving for the number to be higher but there is a long process which we have to go through before the child can begin their therapy and that includes liaising with their schools. The children have come from all over Paisley and the surrounding areas including central Paisley, Glenburn, Foxbar, Seedhill and Shortroods. The progress that has been made with the children has been very encouraging and we are looking to grow the service along with introducing an Adolescent counseling service for those aged 13-18 which would also be free of charge.</p>
