1 MINUTE OF PREVIOUS MEETING

3 9 STREET PILOT AND NEW GROWTH FRAMEWORK

R Cooper, Economic Development Manager, Renfrewshire Council gave a presentation relative to inclusive growth and developing a framework and action plan for Renfrewshire.

The presentation gave a brief overview of the 9 Street Project based in Ferguslie and the programme of action planned; highlighted SIMD facts and figures; outlined the key messages and outcomes to date. R Cooper advised on a proposal to expand the 9 Street Model as a future model for inclusive growth, increasing outcomes for the most disengaged and posed several questions to members for discussion.

Discussion focused on how to achieve an Inclusive Growth Framework based on the expansion of the 9 Street Model to target wider priority areas and a range of disadvantaged target groups who were resident across Renfrewshire. It was noted that the model required a full partnership approach; the outcomes should be linked to each other to improve the overall circumstances and wellbeing of the communities; and targeting income, employment, health, education, housing, crime, access to services to improve people's life chances and opportunities. It was suggested that the Inclusive Growth agenda should feed into, and have oversight by the Improving Life Chances Group.

A copy of the Scottish Government's Index of Multiple Deprivation (SIMD) 2016, which outlined the methods used to identify deprivation in Scotland and to calculate SIMD, was tabled at the meeting.

It was proposed that further information in relation to target areas, population, size of areas and working group details be brought back to a future meeting of the Group. This was agreed.

DECIDED:

- (a) That it be agreed that further information in relation to how to achieve the expansion of the 9 Street Model to target wider priority areas and a range of disadvantaged target groups who were resident across Renfrewshire be brought back to a future meeting of the Group; and
- (e) That the presentation be noted.

4 RENFREWSHIRE LEISURE - PUPIL ACTIVITY SURVEY 2018/2019

F Watson, the Sport and Health Services Manager, Renfrewshire Leisure, gave a presentation on the Pupil Activity Survey 2018/19.

The presentation outlined the purpose of the survey; the method that was used to obtained the information; how the survey was applied; highlighted the analysis; and detailed the next steps and the importance of the survey.

Discussion took place on the survey and it was proposed that further information on how partners could input into the process be brought back to the next meeting. This was agreed.
