1. Introduction and Background

The current framework for frozen foods will expire on 31 March 2022 after an additional extension period. This was put in place to provide supplier relief and to ensure continuity of service to member councils during the first impacts of the coronavirus (COVID-19) pandemic in line with applicable law and guidance. This recommendation is for the award of a renewal framework which is intended to operate from 1 April 2022 to 31st March 2026.

This framework will provide councils with a mechanism to procure a range of frozen goods including but not limited to, poultry, seafood, meat, pizza, potato products, ice cream and desserts. Users of the framework are likely to include schools, nurseries, leisure centres, community centres, social work, council buildings and civic centres.

As with the current framework, manufacturers were able to bid directly on this tender – creating greater brand flexibility, locally sourced produce and an increase in sustainable products.

The report summarises the outcome of the procurement process for this national framework arrangement.

2. Scope, Participation and Spend

As part of the strategy development, the User Intelligence Group (UIG) endorsed the inclusion of three lots as summarised in Table 1.

Lot 1 (Supply Only) sought offers from Tenderers for individual product items. There was no limitation on the number of product items for which a tenderer could offer. Each product item and each offer was evaluated on its own merits as discrete and independent tenders, as outlined in the published tender documents

Lot 2 (Distribution) and Lot 3 (Supply and Distribution) were sub-divided into geographical sub-lots. Tenders for Lot 2 (Distribution) and Lot 3 (Supply and Distribution) were to be linked and could be considered non-compliant if no offer was submitted for the corresponding geographical sub-lot in the other Lot. A minimum pricing requirement was also set for Lot 3. Offers received for Lot 2 and Lot 3 were evaluated in accordance with the published tender documents.

This lotting structure recognises the current landscape of the marketplace, and is designed to align with council requirements more closely. The lotting strategy continued to maximise opportunities for Small or Medium sized enterprises (SMEs).

As detailed in the published tender documents, Tenderers are recommended for appointment to the Framework by reference to the individual product items for which Tenderers are successful (Lot 1), or to the lots and council areas (the geographical sub-lots) for which they are successful (Lots 2 and 3).

The framework was advertised to enable access by all 32 councils in Scotland and, Tayside Contracts and all associate members. As detailed in Appendix 1, 31 councils and Tayside Contracts have confirmed their intention to participate in this framework. Orkney Islands Council has confirmed that they will not participate as they currently have their own arrangement in place.

Historical spend data would suggest a forecast framework spend of c. £21.2 million per annum. However, the framework was advertised with a potential value of £25 million per annum to allow increased participation from councils and associate members. It will also take into consideration:

- The Scottish Government's pledge to increase the annual provision of free early learning and childcare provision to 1140 hours by 2022
- The roll out of universal free school meals for Primary 4 to 7 by August 2022
- Any additional costs incurred due to the changes to the Nutritional Requirements which were introduced by the Nutritional Requirements for Food & Drink in Schools (Scotland) Regulations 2020 in April 2021.

3. Procurement Process

Two Prior Information Notices (PIN) were published in relation to this framework, on 3 September 2020 and 3 June 2021. These resulted in expressions of interest from 16 suppliers, which led to 7 engagement meetings which supported key elements of the development strategy. These included - ability to service, market trends, community benefits, sustainability, product range/specification

The UIG consisting of procurement and technical representatives from participating councils, endorsed the procurement strategy on 21st and 22nd September 2020. A working group of technical representatives from the councils reviewed the specifications and the technical criteria to be adopted during the tender process.

Scotland Excel has taken cognisance of the current situation relative to the Coronavirus pandemic. Balancing the current situation with the need to provide a route to market for Councils to obtain frozen foods, Scotland Excel has determined to proceed with the tender exercise to establish the framework for the Supply Only and Supply and Distribution of Frozen Foods. Scotland Excel has carefully monitored the situation throughout the period of the tender exercise and has taken cognisance of all relevant circumstances in coming to this decision to recommend the award of Framework placings to successful Tenderers.

The procurement exercise followed an open tender procedure to encourage maximum competition and participation. All bidders were evaluated against the advertised selection criteria using the Single Procurement Document (SPD), and the stated award criteria of:

o Technical 25%

o Commercial 75%

Within the technical section, bidders were required to evidence their knowledge and experience by responding to a series of technical areas which are detailed in Table 2.

The commercial section of the tender was worth 75 points.

4. Report on Offers Received

Offers were received from 14 tenderers, a summary of which is provided in Appendix 2 (List of Tenderers).

Based on the criteria and scoring methodology set out in the tender documents, a full evaluation of the offers received was carried out. Appendix 3 outlines the scoring achieved by each bidder.

5. Recommendations

Based on the evaluation undertaken, and in line with the advertised criteria and weightings summarised above, it is recommended that a multi-supplier framework arrangement is awarded to 14 suppliers across the three lots, as outlined in Appendix 3.

The 14 recommended suppliers provide the choice, scope and range of frozen foods required by councils as well as representing best value and providing geographical coverage. These 14 suppliers also represent a mix of small, medium and large organisations, with 10 of the recommended suppliers classified as SMEs.

As shown in Appendix 3, Scotland Excel did not receive any bids for Orkney Islands Council despite full engagement with organisations such as the Soil Association and Scotland Food and Drink to encourage participation from local suppliers. Continued engagement with appropriate council officers will follow to explore further opportunities.

For the recommended suppliers, Renfrewshire Council's Environmental Services team has assessed self-audit documentation, as well as the latest audit reports from relevant Food Enforcement Authorities to ensure compliance with the relevant legislation, and that they have robust processes in place to manage a contract of this nature. All relevant reports were considered satisfactory and compliant with defined requirements.

6. Benefits

Savings

Scotland Excel conducted a benchmarking exercise for each council based on the available historic spend information. The results of this benchmarking are detailed in Appendix 1.

The projected average saving across all councils is 1.8%, which equates to an estimated total saving of approximately £374K per annum based on current forecast spend levels. The projected savings per council ranges from a cost increase of 2.53% to a saving of 6.94%. These costs / savings are largely dependent on the menus adopted by each council, the sustainability of the products they are using and the suppliers tendering for each council. Scotland Excel will continue to work with councils to derive further savings by identifying opportunities to reduce costs by considering brand swaps or alternative pack sizes.

However, it should be noted that future buying patterns in councils may change in light of changes to catering services and menu options that schools may adopt.

Price Stability

Price Stability was not scored for this tender due to market uncertainty at the time of tendering. However, a price stability clause was included, and of the recommended suppliers, 3 suppliers have offered 12 months fixed pricing and 11 have offered 6 months fixed pricing across both core and non-core product offerings.

Subsequent pricing will then be held for 6 monthly periods with any price variance request within these windows being considered in accordance with the defined Scotland Excel process. All requests will be evaluated against market indices which monitor the consumer price index and agricultural price index.

Rebate

A retrospective rebate of 0.5% payable to Scotland Excel will be applied to framework spend above £500,000 (excluding the initial £500,000) and will be calculated based upon all framework spend with the supplier reported through management information returns.

Sustainable Procurement Benefits

Within the technical section of the tender, Scotland Excel included method statements to cover sustainability and supply chain traceability.

All manufacturers bidding on Lot 1 Supply Only of Frozen Foods provided input on their drive to improve packaging as manufacturers have more influence over the packaging used for their products. One supplier committed to improve the environmental and social impact of all its brands throughout the value chain and have set an ambition to achieve Net Zero emissions from all products by 2039. Another supplier detailed three key commitments in relation to reducing C02 emissions:

- 50% absolute reduction in CO2 emissions and 100% renewable electricity by 2030.
- 30% reduction in CO2 emissions intensity by 2030.
- Reducing CO2 per tonne from potato farming, storage, and freight by 25% by 2030.

Definitions of "country of origin of Scotland" and "manufactured in Scotland" were included within the tender to allow both elements to be monitored and recorded correctly. The origin of all products was captured through the tender process and this will be tracked during the life of the framework through quarterly management information returns.

Community Benefits

Suppliers were asked to commit to the delivery of community benefit initiatives, against pre-agreed spend thresholds outlined within the community benefits method statement. These aim to be reflective of the National Indicators outlined within the Scottish Government's National Performance framework, and their underlying vision and goals. Councils will accrue 'community benefit points' based on their level of spend with a supplier. These 'points' correlate to a negotiable benefit that the council can elect to receive at any given point throughout the lifetime of the framework. Of the recommended suppliers, 13 have committed to delivering these benefits. In addition to the above, one supplier has offered that 0.7% from each local authority spend will be awarded as a grant for current or required community benefits in each council region. Scotland Excel will continue to engage with all appointed suppliers to drive maximum adoption and delivery of community benefits where appropriate.

Within the published tender documents, suppliers were given a list of indicative community benefits that could be agreed with councils. Examples of these are:

- Fundraising event for external charities / initiatives within the council
- Work placements to school students from councils
- Support local food banks and community pantry initiatives
- Support holiday hunger programmes
- Sponsorship of sports team or community event within the council to the value of £500
- Recruit a modern (or other approved) apprentice from within the council
- Recruit one person from with the council area

Scotland Excel will monitor delivery of these commitments during the lifetime of the framework and this will also be reported through ongoing contract management returns. Results reported on community benefits will be disseminated to councils on a 6 monthly basis.

Fair work Practice including Real Living Wage

Scotland Excel recognises the importance of fair work practices in the delivery of effective public services. Within the technical section of the tender, one of the method statements assessed bidders on areas such as how they will commit to fair work practices. These include payment of the Real Living Wage, a fair pay

policy, improving wider diversity of staff and avoiding exploitative employment practices, such as no inappropriate use of zero hours contracts.

Of the 14 suppliers to be awarded, four suppliers are fully accredited, one supplier is currently progressing with the accreditation process, another four suppliers pay the real living wage but are not accredited and two suppliers who do not currently pay the real living wage have made the commitment to within he first two years of the framework. There are three suppliers who do not currently pay the real living wage. It should be noted that Brakes, who are one of the suppliers who do not pay the real living wage do in fact pay circa. 97% of their staff the real living wage or higher.

Appendix 4 shows a breakdown of responses received from Tenderers on their approach to fair work practices and their position on the payment of the Real Living Wage.

Scotland Excel will monitor status with all awarded suppliers during the lifetime of the framework and engage with the Living Wage Foundation on this particular market.

7. Contract Mobilisation and Management

As part of the mobilisation process, all suppliers will be invited to a contract mobilisation meeting to outline the operation of the framework. This will include roles and responsibilities, management information requirements and community benefits reporting. Suppliers and participating councils will be issued with a mobilisation pack containing all required details which will enable them to utilise the framework.

In accordance with Scotland Excel's established contract and supplier management programme, this framework will be identified as a classification B framework. As such, Scotland Excel will conduct quarterly review meetings with suppliers and annual user group reviews, whilst monitoring management information and community benefits associated with this framework. Key performance indicators will also be monitored monthly. A summary of contract and supplier management classifications can be found in Appendix 5.

Supplier performance will be monitored by the contract supplier management process where surveys will be issued to councils for feedback on elements of the framework such as quality and service. This feedback will form the basis of contract management meetings with suppliers, who will be able to review the feedback and if required initiate an improvement programme.

Meetings and engagement undertaken with suppliers will adhere to all applicable health and safety guidelines.

8. Summary

This is the fourth-generation framework for the Supply Only and Supply and Distribution of Frozen and aims to maximise collaboration, consolidate demand and deliver best value.

The Executive Sub Committee is requested to approve the recommendation detailed in Section 5 (Recommendations) of the report, to award this framework to the suppliers detailed within Appendix 3 (Scoring and Recommendations).

Appendix 5 - Segmentation classifications

1120 Supply Only & Supply and Distribution of Frozen Foods is classified as class B.

There are five segmentation classifications, and these classifications are rated from Class A to Class E. Each classification has contract and supplier management activities associated with it based on pre-determined weighted criteria.

Class A

Due to the unique and bespoke nature of the frameworks that fall within this class, a contract management plan to be developed and agreed with CSG.

Class B

Quarterly supplier contact, six monthly surveys, annual UIG, frequent support to councils, suppliers and external stakeholders requiring high level of procurement expertise, extensive contract monitoring.

Class C

Six monthly supplier contact, six monthly to annual surveys, annual UIG, regular support to councils, suppliers and external stakeholders requiring procurement expertise, high contract monitoring.

Class D

Annual supplier contact, annual surveys, optional annual UIG, ad-hoc support to councils, suppliers and external stakeholders potentially requiring procurement expertise, regular contract monitoring.

Class E

Annual supplier contact (if required), optional annual surveys, no requirement for annual UIG, straightforward ad-hoc support to councils, suppliers and potentially requiring procurement assistance, basic contract monitoring.
