- 3.2 The procurement exercises referenced in table 3.1 were conducted in accordance with the Councils Standing Orders Relating to Contracts and the procurement exercises subject to the full requirements of the EU Procurement Regulations were tendered in accordance with those Regulations.
- 3.3 Those procurement exercises which were conducted as mini competitions under existing framework agreements were conducted in accordance with the applicable framework agreement terms and conditions.
- 3.4 Procurement exercises referenced in table 3.1 were evaluated on the basis of the most economically advantageous tender received, this included an assessment of both price and quality.
- 3.5 The contracts referenced in table 3.1 are subject to various funding streams including:

Boiler and Hot Water Plant Replacement at St Catherine's, St Fillan's and Wallace Primary Schools	Financial costs will be met through the department's lifecycle capital budget.

Provision of Community Day Services	Jointly funded by Renfrewshire Council and the Health and Social Care Partnership.
Improvement Works to Inchinnan Junction	Grant fund given to Council by SPT.
Provision a Carers Centre	Jointly funded by Renfrewshire Council and the Health and Social Care Partnership.
Gallowhill External Wall Insulation Cladding, Phases 4+	Will be fully funded by the Scottish Governments Home Energy Efficiency Programme or HEEPS with contributions from E.ON's Energy Company Obligation (ECO) fund.
Rosemary Tile Replacement and Associated Common Block Works Programme	Financial costs will be met through the departments Capital HRA Budget.
Strategic Review of Street Lighting LED Lantern Replacement 2016/2017 - Phase 2	Financial costs will be met from approved capital investment programme.
