Declarations of Interest

There were no declarations of interest intimated prior to the commencement of the meeting.

1 Minute of Previous Meeting

There was submitted and approved the Minute of the previous meeting held on 25 June 2019.

Under reference to Item 4 – Applications for Local Partnership Grant Funding - it was highlighted (i) that the decision in respect of application FR1082 required to be amended to reflect that the award of £700 had been subject to further discussion with ROAR in respect of a 'falls approach'; and (ii) that the Minute required to be amended to indicate that E Loch, having declared an interest in respect of application FR1264, did not vote.

DECIDED: That the Minute be approved, subject to the amendments highlighted.

2(a) Budget Monitoring Report

There was submitted a report by the Director of Finance & Resources relative to the Paisley East Local Partnership budget for 2019/20.

The report advised that the Local Partnership provided funding through a range of grants in terms of the General Grant Fund, Paisley Common Good Fund and the Celebrating Renfrewshire Youth Fund following a participatory budgeting exercise. An Appendix to the report detailed the funding allocated at the Paisley East Local Partnership meeting held on 25 June 2019.

DECIDED: That the report be noted.

2(b) Grant Funding Update

There was submitted a report by the Chief Executive relative to grant funding applications considered at the meeting of Paisley East Local Partnership held on 25 June 2019.

The report indicated that at the meeting grant funding awards had been made to 33 community projects. Reference was made to the application submitted by Paisley and District University of the Third Age (U3A) seeking £1,225.08 in respect of IT equipment to enhance continuous learning for older people. The Local Partnership had continued consideration of the application pending further information on the extent to which the applicants were working with other partners active in the field. Confirmation had subsequently been received from U3A that they were currently working with DigiRen, who had strategic responsibility to increase the uptake and usage of digital technology in Renfrewshire that and were willing to discuss

opportunities to work together with ROAR Connections.

Following discussion it was proposed and agreed, in view of the proposed timescale for the next meeting of the Local Partnership and the need for further information from the applicant regarding the proposed purpose of the grant, that authority be delegated to the Convener to determine application FR1140 and that details of the decision be submitted to the next meeting for homologation.

DECIDED: That authority be delegated to the Convener to determine application FR1140 and that details of the decision be submitted to the next meeting for homologation.

3 Celebrating Renfrewshire Youth Participatory Budgeting Exercise

There was submitted a report by the Chief Executive relative to the Celebrating Renfrewshire Youth Participatory Budgeting Exercise.

The report indicated that the Youth Challenge Fund component of the Paisley East Local Partnership Budget had been renamed “Celebrating Renfrewshire: By young people for young people”. A McKechnie of the Youth Steering Group provided a presentation in connection with the pilot participatory budgeting exercise undertaken which had resulted in 370 young people aged between 12-25 voting to allocate the available budget for Paisley East Local Partnership in respect of the Celebrating Renfrewshire Fund, £24,095, between ten projects. Details of the process were provided. It was highlighted that the project had been co-produced by young people and supported by Renfrewshire Council, Renfrewshire Youth Voice, Active Schools and Young Scot to distribute Youth Challenge Funding and would inform the development of future participatory budgeting within Renfrewshire. A document summarising the results of the Celebrating Renfrewshire Budgeting process was appended to the report.

DECIDED: That the outcome of the youth participatory budgeting exercise for the Paisley East Local Partnership and the information provided in the presentation be noted.

4 Local Partnership Priorities

There was submitted a report by the Chief Executive relative to the draft priority areas for focus agreed at the meeting of Paisley East Local Partnership held on 27 March 2019.

The report advised that three draft priorities, (i) exploring the impact of new housing developments; (ii) supporting social connections; and (iii) community pride and safety had been identified by the Local Partnership for the Paisley East area and subsequently developed into priority statements detailed within the report. It was noted that these draft local priorities and statements would help develop the future agenda and workplan of the Local Partnership. Potential discussion points were provided for consideration to facilitate discussion in relation to how the priorities could shape the workplan and determine future agenda items and potential partner invitees to meetings of the Local Partnership.

During discussion in connection with the priority of exploring the impact of new housing developments reference was made to the local Development Plan, the process by which the Plan was developed, constraints, the potential incorporation of

community benefits through the planning process, local arrangements for the maintenance of greenspace and footpaths, housing developments in neighbouring planning authorities which impacted on the infrastructure in Renfrewshire. It was proposed and agreed that the Head of Housing & Planning Services Renfrewshire Council be invited to a future meeting of the Local Partnership.

In relation to the supporting social connections priority, mention was made during discussion to the need to define social isolation and identify relevant groupings affected, the role of community connectors, the associated Health & Social Care Short-life Working Group report, the desirability of ingathering information and best practice in relation to loneliness, ALICE and the need to gauge the extent and factors influencing younger people's mental health. It was proposed and agreed that the Director of Children's Services Renfrewshire Council and the appropriate representatives of the Health & Social Care Partnership be invited to a future meeting of the Local Partnership.

DECIDED: That arrangements be made to invite the Head of Housing & Planning Services and the Director of Children's Services, Renfrewshire Council and the appropriate representative of the Health & Social Care Partnership to future meetings of the Local Partnership to discuss, as appropriate, the issues raised.

5 Local Partnership Review

There was submitted a report by the Chief Executive relative to the review of Local Partnerships.

The report indicated that when the Local Partnerships had been established in September 2018 it had been agreed that there would be a review of arrangements following a year of operation. The inaugural meetings of the Local Partnerships had taken place during January 2019 and it was proposed that the review begin in January 2020. A summary of the tasks completed to date by the Local Partnerships was provided. The report sought views on the proposed scope and approach of the review.

There then followed a general discussion in relation to the benefits of reviewing the Local Partnership grant funding process prior to consideration by members of the Local Partnership of future applications for funding. It was the consensus that specifically consideration be given to how applications for funding met the priorities agreed by the Local Partnership, the adoption of a scoring/evaluation process prior to consideration by members of the Partnership, potential 'asks' of applications to meet the priorities should funding be allocated for projects, avoiding duplication (on a Paisley-wide basis) of funding awards, proposed monitoring and evaluation arrangements and the methods to be used to obtain feedback from applicants. It was proposed and agreed that a copy of the monitoring documentation used be circulated to members of the Local Partnership.

It was also proposed that consideration be given to establishing a mechanism to facilitate communication among members of the Local Partnership in the periods between meetings.

Members of the Local Partnership were invited to provide their views on the scope and approach for the Local Partnership review prior to the next meeting of the Partnership.

DECIDED:

(a) That a review of the Local Partnership grant funding process, prior to consideration by members of the Local Partnership of future applications for funding, be included within the scope of the Local Partnership Review and that Members of the Local Partnership provide their views on the scope and approach for the Local Partnership review prior to the next meeting of the Partnership;

(b) That arrangements be made to circulate a copy of the monitoring documentation used to members of the Local Partnership;

(c) That consideration be given to establishing a mechanism to facilitate communication among members of the Local Partnership in the periods between meetings; and

(d) That Members of the Local Partnership submit their views on the scope and approach for the Local Partnership review prior to the next meeting of the Partnership.

6 Future Meeting Dates

There was submitted a report by the Chief Executive relative to arrangements for meetings of Paisley East Local Partnership during 2020.

The report referred to the previous decision taken that Local Partnerships meet at least three times a year and proposed that meetings be held in April, August and November 2020. It was further proposed that grant funding allocations be made at the April meeting. Potential meeting date options in April, August and November were detailed in the report.

It was highlighted that the wider engagement event, to provide the opportunity for wider local engagement with the work of the Local Partnerships, help build networks and connections and provide a chance to engage around the local priorities, which had originally been scheduled to be held during Autumn 2019 had been delayed due to the focus on delivering the Youth Participatory Budgeting approach and would now be carried out in early 2020.

The Convener invited members of the Local Partnership to advise of their preferred dates in 2020, from those detailed in the report, for meetings of the Paisley East Local Partnership.

DECIDED:

(a) That members of the Local Partnership submit their views on their preferred dates in 2020, from those detailed in the report, for meetings of the Paisley East Local Partnership; and

(b) That members of the Local Partnership submit feedback on the proposed approach for the engagement events and, where appropriate, express an interest in the development of these events.

1. Summary

- 1.1 Applications for grant funding from the seven Local Partnership areas were invited in February 2020, to be considered at the Local Partnership meetings due to be held in April.
- 1.2 The Paisley East Local Partnership meeting in April was cancelled due to the Coronavirus pandemic, to reflect both the 'lockdown' restrictions and the emergency planning arrangements in place put in place by Renfrewshire Council.
- 1.3 Renfrewshire Council resumed its policy board arrangements in August, and it was agreed by Renfrewshire Council's Emergencies Board that Local Partnerships would be resumed in September to allow for the allocation of Local Partnership funding for 2020/21.
- 1.4 The budget allocation for Paisley East Local Partnership is £63,347. This is made up of £52,247 from the General Fund and £11,100 from the Paisley Common Good Fund.
- 1.5 In addition, a sum of £50 per community representative requires to be ringfenced for potential claim of expenses. These expenses are deducted from the budget allocation for the Local Partnership. As Paisley East Local Partnership has 11 community members, £550 is ringfenced for expenses. **The amount available to allocated by Paisley East Local Partnership is £62,797.**

- 1.6 The Youth Challenge Fund component of Paisley East Local Partnership Funding is £24,095. This funding will be allocated by young people through a Participatory Budgeting process currently underway.

2. **Recommendations**

- 2.1 It is recommended that members of Paisley East Local Partnership consider the applications for Local Partnership grant funding, as set out below in Appendix 1 and 2.

3. **Background**

- 3.1 Applications for grant funding from the seven Local Partnership areas were invited in February 2020, to be considered at the Local Partnership meetings due to be held in June.
- 3.2 Applicants were also provided with refreshed guidance, as well as a description of the Local Priorities identified by the Paisley East Local Partnership. A copy of this guidance has been provided at Appendix 3.
- 3.3 Following agreement by Renfrewshire Council's Emergencies Board that Local Partnerships would resume in September 2020, all applicants were contacted and provided the opportunity to amend their application or reflect any changes in circumstances that may have occurred since original applications were submitted.
- 3.4 Local Partnership members are asked to consider the applications for funding summarised at Appendix 1 and 2 of this report, and to assess these against the Local Priorities agreed by the Paisley East local priorities.
- 3.5 Following feedback received by Local Partnership members in previous funding rounds, an initial assessment has been carried out by officers to support Local Partnership members in their decision-making. Where applications have made clear reference to the Local Priorities identified by the Local Partnership, this is identified in the first table at Appendix 1. Applications that make a partial or no reference to Paisley East Local Priorities are summarised in the second table – for example, the project may work with young people (and therefore meet the Local Priority around young people) but not deliver this directly in the Local Partnership area or make reference to how many young people from the area would be engaged in the project.

3.6 The priorities of the Paisley East Local Partnership are:

Exploring the impact of new housing developments

The Local Partnership want to explore how they influence planning decisions around new developments, and make sure that the infrastructure is in place to support these developments, for example, roads, schools and nurseries. They want to explore how community benefits might be used to support this.

Supporting social connections

The Local Partnership want to support social connections to tackle isolation and promote mental health and wellbeing. They want to see groups in the local area working together, swapping skills and sharing resources.

Community pride and safety

The Local Partnership want to see the care and maintenance of their spaces across their area, so they are clean, safe and attractive spaces. They want to see these spaces used to promote good wellbeing across the area.

5. Description Of Project	<p>To regenerate a piping and drumming band to bring together all veterans from different regiments and the local community. To provide musical support at appropriate events to enter into pipe band competitions. To provide open and inclusive musical community group to promote wellbeing.</p> <p>It was recognised that there were insufficient numbers to make a pipe band available to service the local British Legion and veteran community event, eg Remembrance Sunday. Members decided to establish a local pipe band that would allow veterans, their families and the wider community members an opportunity to learn piping and drumming.</p> <p>The project will provide musical tuition twice weekly in the local RBL club who have provided the venue for the practise for a nominal fee. The musical tutors are experienced pipe and drum majors and have the expertise and knowledge to teach beginners and develop intermediate musicians.</p> <p>The project will provide regular music tuition, creating a community group which will in turn be beneficial to the members. Musical group work is known to help improve physical and mental health as well as promote and widen social bonding and networks. It is anticipated that a fully functioning marching pipe band will be formed and available to support the local branch from 2020 onwards.</p>									
6. Who Benefits From The Project?	The project benefits those involved in the band through, including young people and people who have experienced PTSD. It also benefits the wider community through the provision of music at community events.

Led by a qualified cricket coach, our cricket sessions will increase the activity levels in all participants and help to promote an active and healthy lifestyle throughout the local communities where our project will work.</p> <p>The need for this project was identified by liaising with local groups and local people. We have become aware of the declining number of people of all ages participating regularly in sport, especially cricket. Football teams cater for a high number of people however our project seeks to cater for those who do not play football and indeed cater for people regardless of ability. We seek to promote participation in sport, through cricket for people of all ages and abilities.</p> <p>Our project will provide cricket sessions for people of all ages and will focus on the following:</p> <ul style="list-style-type: none"> - in or after school cricket coaching sessions (primary schools) - in or after school cricket coaching sessions (secondary schools) - university and college cricket coaching sessions - weekly, open cricket coaching sessions for all aged under 18 - weekly, open cricket coaching sessions for all aged 18 and above - winter cricket coaching sessions for people all ages and abilities <p>Our project will not only help to enhance fitness levels and improve the health and well-being of each individual but it will also promote key transferrable skills which people of all ages can use in their educational or employment lives. Communication and teamwork skills will be promoted by our project while self-confidence, self-belief and self-esteem of each individual will be enhanced.</p> <p>We will monitor participation numbers at each of our activity sessions and use these figures to monitor and evaluate our projects success. BACKGROUND We recently took over The Bungalow an iconic and historic music venue in the heart of the town and changed it from private ownership to a community venue. In general the building is in a good state of repair but heating and insulation is in a poor state. The boiler is 20 years old and only services 4 radiators. 2 radiators have not even got pipes running to them. To heat the building 5 electric heaters are being used and are proving to be inefficient and costly. The loft is partially insulated and the entry doors lose energy. The need has been identified by comments and feedback from user groups and customers who find seated events such as singer song writers, spoken word and jazz etc uncomfortable. Older users especially suffer from the low temperature. We have had a survey by two heating engineers advising us on the state of the heating system and insulation. Both have told us the boiler is totally inadequate for a building of its size and improvements to building insulation is needed. We attended a recent event at Paisley Arts Centre at which we received help and advice from Creative Carbon Scotland. Having a venue fit for purpose and having a more eclectic music programme the beneficiaries would be: A wide range of organisations and users of all ages with a wide interest in various types of music and entertainment. In addition we would be: 'Playing Our Part in the Community Energy Challenge'

The play-programme will allow for more children of Paisley East to benefit from the findings from the Playbus pilot which was carried out Nov/Dec 2019. More schools will engage with their own funding once more children are shown to have benefited from the experience. Playbus is focussed on working within Renfrewshire. Renfrewshire is one of the nine 'Challenge Authorities' identified by the First Minister in the Scottish Attainment Challenge and has one of the highest concentrations of deprivation.</p> <p>The need has been identified by schools, nurseries and clubs. Head Teachers, teachers, parents and children have provided evidence to show improvement in their children's mental wellbeing with the use of the Playbus and consequently a positive impact in class afterword's. The pilot found that 100% of parents attending with their children at after school clubs stated that they enjoyed the sessions and agreed that the Playbus was good for their children's mental and physical wellbeing. The pilot reported that 100% of parents who attended the out-reach toddler session said they would access this service again within the community. The toddler group helped parents build relationships with each other and offer each other support as well as building a relationship between families and school.</p> <p>Parents have reported to schools about their child's change in behaviour at home. Examples of this are playing with siblings and an improved bedtime routine due to the increase in their child's physical exertion.</p> <p>Paisley East Project - Supporting social connections.</p> <p>Using the places where children congregate e.g. schools, nurseries, after-school clubs; Playbus will use these locations as Play-Hubs for the Playbus Play-Programme. Using hubs will allow the Playbus to reach as many children as possible. A six-week arrangement will be made with the hosts of the play programmes. The centres will be given a topic to work with and report back on. The centre will also be asked to work with additional support need groups in their surrounding areas, their parent and toddler community as well as the children and their parents within the</p>

centre.

The pilot topics that are still to be reported on are:

1. Measuring the impact on health and wellbeing in the community.
2. Measuring the impact on communication in young people.
3. Measuring the impact on social skills of young people and their families.
4. Measuring the impact of community play in young people.
5. Measuring the impact on pre-school groups when connected with the community in early years.
6. Measuring the impact on social isolation with community play.

These studies will be shared across Renfrew and Paisley East. The centres Playbus will be working with for this project in Paisley East are - Ralston Primary School, St John Ogilvie Primary and Lochfield Primary School.

Each centre will be asked to collect evidence through observation, discussion and questionnaires. Each centre will be asked to use the Leuven Scale with the children and there will be six case studies carried out with individual children to focus on their specific improvements in the subject area. If the centre is not familiar with reporting outcomes or the Leuven Scale, training can be provided.

The results from the schools participation will give reason for schools to engage in the future with their own funding. This allows the work to be sustainable in the community.

Following our Paisley East project, Playbus will offer the Playbus into the community as a Community Play-Day with Playbus. This could be a Gala or a local event. When the Playbus was open to the community through Todholm, the community were sharing messages on social media that there was something to do in the community and parents have been asking for the bus to return. The Community Play day will be marketed in school newsletters, across various social media outlets. Attendance will be high at these events. Playbus will happily engage with other community groups and work together bringing them into the Play-Day with Playbus. These groups will be advertised as additions to the Play-Day.

9. About The Organisation

Paisley & District U3A is an unincorporated club which was established in 2018.

The U3A motto is “Learn, Laugh, Live”. The aim is to help anyone Retired or Semi-Retired living in Paisley and District to learn for the fun of it, and so get more out of life.

Local Partnership Grant Funding

A guide to the grant funding available from Local Partnerships and how to apply

Local Partnerships are a way for communities, elected members and public organisations to work together at a local level.

There are seven Local Partnerships in Renfrewshire, and they replaced Local Area Committees in 2018.

Each Local Partnership has agreed a set of Local Priorities, and each Partnership has grant funding they can allocate to support these priorities.

The aims of Local Partnerships are to:

- Make connections and networks between community groups and the wider community
- Identify, set and share local community priorities
- Listen to, consult and represent local communities
- Distribute grants to support local priorities

Grants available from Local Partnerships

The Local Partnerships consider applications and award grant funding that reflects their local priorities. The Local Partnerships look after grant funding streams that were previously overseen by Local Area Committees:

- the General Grant Fund;
- two Common Good Funds (Paisley Common Good and Renfrew Common Good); and
- the Youth Challenge Fund

It is strongly advised that organisations read this guidance before writing and submitting their applications.

You will find further information about each of these three funding streams and how to apply for them over the next few pages.

The most important thing to remember when applying for grant funding is to make sure you can contribute to at least one of the local priorities for the area you are applying to. It will be important to take time to find out about these priorities before applying. They are available [here](#).

The Application Process


Read the Local Partnership Grant Funding Guidance and the Priorities for the Local Partnership area you are applying to.



Attend a drop in session if you would like to discuss the priorities, application process or alternative funding opportunities.



Fill in application, ensuring you address the relevant local priorities and submit to rcgrantapplications@renfrewshire.gov.uk, together with the relevant bank statement, accounts and constitution. The deadline for applications is 9th March 2020



Your application will be considered by the Local Partnership in April or May. Local Partnership meetings are public, so you are welcome to come along to the April or May meetings. You will not be required to attend, or expected to speak at the meeting.



Following the meeting, you will be informed whether your application was successful or not. If you are successful, you will be asked to agree the conditions of grant and payment arrangements will be made.

The Application Form

The standard Voluntary and Community Organisations Grant Application Form is used to apply for Local Partnership funding. The form is available [here](#) (under related documents) or please contact the Community Planning team on 0141 6184168 if you would like a paper copy sent to you.

The form has guidance notes in the right-hand column to help you with what information to put in each box. The notes below provide further information about how to make the best use of the application.

Section 1

This section is for you to tell us about your organisation and what you do. In section 1.13 you are asked about which Local Partnership area you are applying to and where your project will be operating. In section 1.13a you should tick the Local Partnership area you are applying for funding in. In 1.13b you should write which Local Partnership area(s) the project you are applying for will operate in. All applications will be treated as an individual application by each Local Partnership. In this way, your activity needs to be viable as a project in each Local Partnership area it is applying to. If you are applying for funding from more than one Local Partnership area, you will either need to make sure your one application covers at least one priority from each of the Local Partnership areas applied to, or submit separate applications tailored to the priorities of each Local Partnership area applied to. If you are submitting one application to cover more than one Local Partnership area, you will need to make it clear how much funding is being asked for from each Local Partnership. This is covered in section 2.

Section 2

This section is an opportunity to tell us about the project you would like funding for. It is very important that you use this section to explain how you will address the priorities identified by your Local Partnership. These sections will be made public through the summary reports at the Local Partnership meetings. You should provide a good description of your project in this section highlighting clearly which priorities it will address. This is information that the Local Partnership Meeting will use to decide on your application. If you are using one application to apply to more than one Local Partnership, you need to write the name of the Local Partnership applied to next to the amount requested from that Local Partnership in section 2.10.

Section 3

This section is to make sure that you have included all the necessary supporting paperwork. Your application cannot be considered until you submit all of the correct paperwork.

Section 4

If you are filling in a paper copy of the form to post, you can sign this section of the form. If you are doing the form online, a signature can be taken at a later date.

General Grant Fund

The General Grant Fund provides grants of up to £10,000. The grants are open to constituted local community, voluntary organisations and Community Planning Partners. The fund is intended to develop local activities and projects within Local Partnership areas. The total amount of General Grant funding available is slightly different in each of the seven Local Partnership areas, because funding is allocated to Local Partnerships based on their population. Activities are expected to reflect the different priorities and needs in each of the seven areas.

Eligibility Criteria

Who can and cannot apply?

- Any community or voluntary organisation with a constitution and a bank account can apply. Any organisation applying should be accountable to its members.
- Community Planning Partners can submit applications for funding, but Council services cannot. Community Planning partners should not submit applications for projects that are regarded as core functions.
- If your application is for an individual, it will not be considered.
- Your application should contribute towards at least one of the Local Partnership's key priorities. These were established by Partnerships at their March 2019 meetings and have been developed further since. Projects should be able to demonstrate real benefit to the local area by improving or complementing existing service provision.
- Organisations that work across Renfrewshire, or in a number of Local Partnership areas, can apply, but only for projects or activities which support an area's priorities, and are delivered in that area specifically.
- You cannot apply for costs of activities that have already happened.
- You cannot apply for your total running costs. You can apply to part fund running costs though.
- The General Grant Fund will very occasionally support applications to fund activities such as day trips and lunches, but only when they provide an additional community benefit (for example tackling loneliness and isolation).
- The General Grant Fund will not support projects that exist mainly to further religious or political beliefs.

- Your application must encourage equality of opportunity.
- You cannot apply to fund either a trip abroad or hospitality to other organisations.
- If you receive a grant from the General Grant Fund, it must usually be spent within this financial year.
- General Grant Fund awards are one-off and are not intended to provide ongoing funding for the same or similar activities on an annual basis.
- If you are successful in your application, you must accept and comply with the grant conditions. It is also expected that you report back on the impact the project has had once the funds are spent.
- You should plan how you will sustain your organisation, once funding from the General Grant Fund has been used.
- You cannot use the funding for events to raise funds for other charities
- You cannot use the funding to cover your Community Councils' running costs above those funded by its administration grant from the Council.
- You should provide evidence of partnership working, where applicable.

What types of activities or projects can and cannot be funded?

Activities or projects must contribute to at least one of the key priorities identified by the Local Partnership. The fund can support a variety of projects and activities. This can include supporting people back into employment; supporting young people; supporting community safety activity; supporting healthier lifestyles; tackling poverty in disadvantaged areas; and promoting equality within local areas.

These types of activities can cover an array of different projects. Examples include:

- Refurbishment of community facilities such as decorating or improving the layout of a room for community use.
- Enhancing or creating community gardens for recreational areas.
- Community events such as gala days.
- Projects that raise awareness of healthy eating and help people change eating habits.
- Projects that promote positive mental health issues.
- After school clubs that encourage development e.g. homework clubs,
- Leadership and team working skills for group members.

Common Good Funds

Common Good is funding generated from an investment portfolio where the annual income is used to support local projects. There are Common Good funds in both Renfrew and Paisley, which are distributed through the Local Partnership. In Paisley, the fund is split across the three Local Partnerships, based on the population of each area.

The general eligibility criteria for the common good funds are the same as for the General Grant Fund, although there is no specific maximum award. The main difference is that the Common Good Funds are charities and so any projects funded through the common good funds must meet their charitable objectives (the advancement of civic responsibility or community development) to benefit people in Renfrew or Paisley.

Former Youth Challenge Fund

The Youth Challenge Fund was allocated using participatory budgeting for the first time in 2019/20 and became known as “Celebrating Renfrewshire – By Young People, For Young People.” This was the first year that young people decided directly which youth projects should be funded. It is expected that this fund will be allocated in the same way this year. This funding round will be launched separately.

Further Information

Drop in sessions will be held across the Local Partnership areas. These are not specifically to address any funding concerns, but may be useful if you would like to find out more about local priorities and give your input on Local Partnerships more generally.

Frequently Asked Questions

How will funding award decisions be made?

The members of the Local Partnership in each area will make a decision on each funding application, guided by an assessment of whether the application has met the local priorities. Remember to base your application on the local priorities of the Partnership area you are applying to. Priorities are linked [here](#)

How do I apply?

Fill in a standard grant application form on the Renfrewshire Council web site. You can do this electronically and email it in or send in a completed paper copy. You should make sure you have understood what the local priorities are for the area you are applying to before completing your application.

When is the deadline for applications?

The deadline will be 9th March 2020 for consideration at the April/ May meetings.

What happens to my application after it is submitted?

Your application and documents will be checked and then stored on the Council system. A summary of your application will be prepared to include in the papers for the relevant Local Partnership meeting. If there are any queries or clarifications needed about your application, you will be contacted before the Local Partnership papers are prepared.

When will I hear back?

You will hear back after the meeting of the Local Partnership has made a decision. The decisions will be made during the April/ May 2020 cycle of meetings. Local Partnership meetings are public, so you are welcome to come along to the meetings. You will not be required to attend or expected to speak at the meeting.

How much money can I apply for?

You can apply for a maximum of £10,000 from the General Grant Fund. If you are applying for Common Good funding, there is not specific maximum limit – but remember Common Good funding is only available in Paisley and Renfrew.

Who can apply?

Any community or voluntary organisation with a constitution and a bank account can apply. Any organisation applying should be accountable to its members. Council services will not be able to apply for funding. The wider community planning partners will be able to apply, if their project aligns with local priorities.

Can I apply to fund Christmas lights?

Unfortunately, Renfrewshire Council has very limited capacity for any further installation, storage and maintenance of Christmas lighting. If you wish to submit an application which would require

additional Council resources, you should discuss this with Council officers prior to submitting your application.

[We work across Renfrewshire, can we apply?](#)

You can apply to one or more Local Partnership. The project you are applying for, must be for the benefit of people who live in that area and the project must align with the local priorities for that area. You should focus on the areas where your project aligns most with the local priorities. You could also think about where your project is based or where most of the people using or otherwise involved in the project will be based. It might align with more than one Local Partnership area. If you do want to apply to more than one Local Partnership area, you will need to either submit separate applications or make it very clear which information applies to which Local Partnership.

[What is happening to 'multi LAC' applications?](#)

All applications will be treated as an individual application by each Local Partnership. In this way, your activity needs to be viable as a project in each Local Partnership area it is applying to. If you are applying for funding from more than one Local Partnership area, you will either need to make sure your one application covers at least one priority from each of the Local Partnership areas applied to, or submit separate applications tailored to the priorities of each Local Partnership area applied to. If you are submitting one application to cover more than one Local Partnership area, you will need to make it clear:

- How your project will specifically benefit people in each Local Partnership area applied to, and
- how much funding is being asked for from each Local Partnership.

[Is it the same process as the old LAC funding applications?](#)

There are some differences. Local Partnership grant applications must be based on the priorities for that Local Partnership area. The Youth Challenge fund decisions will be made by local young people and so follow a different process to take place later in the year.

[Is the total amount of funding the same as the old LAC funding?](#)

Yes, the total amount of funding is the same. It is still based on the population of each area, but now split between the seven Local Partnerships, rather than the five former LACs.

[What happens if money is not allocated by the end of the financial year?](#)

Where all available grant funding within a financial year is not fully committed, the balance can be carried forward only where a specific project for the forthcoming financial year has been identified and approved by the Local Partnership. This gives the Local Partnership the flexibility to set aside a proportion of its current year grant for use on a specific project the following year.

It is not intended that this year-end flexibility would be applied to carry forward a general underspend of available grant for which no specific purpose has been identified or approved.

[What happens if organisations that are members of Local Partnerships apply for funding?](#)

Organisations that are members of a Local Partnership can still apply to that Local Partnership, but they will not be allowed to speak to the application at the decision meeting and will not be allowed to vote on their own application.

If I am unsuccessful, where can I find other sources of funding?
